Subject: Complaint regarding Matthew Haney, PDC Case 46655

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its review of the complaint you filed on February 2, 2019. Your complaint alleged that Matthew Haney may have violated RCW 42.17A.605 by failing to submit a recent photograph for his lobbyist registration.

PDC staff reviewed your allegations, and as a result of staff's review, we found the following:

- Matthew Haney (the "Respondent") is a registered lobbyist, employed by Service Employees Int'l Union Local 6, who failed to submit a recent photograph to the PDC as required per RCW 42.17A.605.
- The Respondent took corrective action within a week of being notified by the PDC and emailed the PDC the missing photograph on February 14, 2019.
- The Respondent erroneously believed his photograph was already on file with the PDC. Once notified, the Respondent took steps to remedy the oversight.

Based on these findings, staff has determined that in this instance, failure to submit a photograph for a lobbyist registration does not amount to an actual violation warranting further investigation.

PDC staff is reminding Matthew Haney about the importance of submitting a recent photograph when registering as a lobbyist, and the timely filing of all future required lobbyist registration information.

The PDC has dismissed the matter and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
