

Her late C4 covering 7/27/2010 to 10/12//2010 is now signed by a Dennis Huston who is employed by the County also but never declared her Treasurer????? Her accounts should be audited. This is the Franklin County Auditor- Treasurer name- T Booth. T Booth signed July filed C-3's and C-4 dated July 10, 201. Signature of T Boothe and Tracie Boothe. No filings of C-4 for August, September or October until a call and e-mail to the PDC was made October 27th 10:30 AM. A response was sent from Jennifer 12:20 PM.

Primary Report

On July 10, 2010, the campaign filed a C-4 report. No starting date was recorded; the ending date was July 9, 2010. This C-4 report showed \$5,730.00 in contributions and \$1,813 in expenses. This report was filed early. The Schedule A shows 3 deposits:

On July 27, 2010, the campaign files a C-4 report. No starting date was recorded; the ending date was July 27, 2010, one day longer than the required period. C-4 report showed \$6,330 in contributions and \$6 301 in expenses. This report was filed timely. The schedule A shows four deposits:

C-3 reports for the same period are:

On October 25, 2010, the campaign filed a report for the period of July 27, 2010 through October 12, 2010. (No 7-day pre-primary was filed for August 10, 2010 deadline). This C-4 report showed \$1,405 in contributions and \$1,229.17 in expenses. This may be the campaigns attempt to file a 21-day pre-general report. No post-primary C-4 was filed. This report appears to correct in the figures.

On October 28, 2010, the campaign filed a C-4 for the period of October 12, 2010 through October 19, 2010. This report showed an additional \$685.00 in contributions.

No other C-4 reports have been filed.

A c-3 was filed Ocber 27, 2010 showing \$975 in contributions

An additional C-3 was filed October 28, 2010. It showed \$9,000 loan from Bart Gallant.



To Whom It May Concern

My name is Zona Lenhart. I had worked in public service for 36 years. Twenty of which I served as Franklin County Auditor. During 2010 I engaged in my first contested election as Franklin County Auditor. It was an entirely new experience for me. I had experience with the Public Disclosure Commission over the years but never as candidate.

During the approximate 30 years I have come to see that things have changed significantly regarding the rules of the PDC. I discovered in late August that July forms had not been filed and at that point I was late or at least close to being late with the filing of August forms. I found I needed to replace the treasurer and I took this corrective action. Should I engage in any future campaigns, I will hire an accounting firm and not rely on volunteers. Lesson learned.

This year was challenging for me at many levels. Besides working a job and running a campaign and all that that involves I had many significant issues that competed for my time. My husband was ill during most of this time and even though he passed a stress test in April, he had a heart attack in November and subsequent open heart quadruple bypass surgery on November 30, 2010. Twenty four hours after surgery his kidneys failed. Also during this time I was caring for my 82 year old ageing and ailing father who suffers from dementia and requires daily care of feeding and administration of medication. Another matter that took a significant amount of time was and is an immediate family member with a significant drug problem who was in treatment and continues to work a twelve step program. I wish I could say that all of the above had been resolved but unfortunately all of these above mentioned issues continue today to take a significant toll on our family.

I offer the above explanation only to show that I did not blatantly or with intent ignore the rules of the PDC. There were mistakes made and lessons learned. I accept full responsibility for the consequences.
