a cash contribution of \$250. plus a loan of \$938.98 totaling \$1188.98 from Ty Haberling to  
each candidate. These candidates filed for mini reporting on Candidate Registration forms  
C1. The requirement that a single contributor donate no more than \$500. in the aggregate  
to a candidate has been violated by each school board candidate.

Dear Mr. Stutzman:


Being new to local politics, I made a huge effort to abide by the rules of running for office. When a mistake was pointed out to me, it was corrected right away.

In response to a complaint made by Tom Staley Jr. I would like to state that the funds questioned in the complaint were returned to the contributor. Because it was returned, I did not think there was a need to change my reporting requirement to the long form.

In an e-mail dated December 5, 2011, Mr. Staley questioned why I returned a \$500.00 contribution. I replied that I did not want to exceed the contribution limit. This is evidence that I did not purposely exceed the mini reporting option.

As stated in the certification, the information I submitted is true and correct to the best of my knowledge. If an error was made, it was completely unintentional. I am willing to make any corrections that are required.
