COMPLAINT

This is a complaint against Justin Kover, aka harbormasterlief, "Matthew Green" and "Matthew DGreen." The complainant is Thaddeus B. Curtz, Jr.

Justin Kover is a resident of Thurston County. His voter registration address is: 522 Lilly Rd NE Apt 752, Olympia WA 98506.

Count 1: Justin Kover violated RCW 42.17.510(1) when he distributed, mailed, and published political advertising that did not contain a sponsor's name and address.

Count 2: Justin Kover violated RCW 42.17.510(1) when he used an assumed name for the sponsor of political advertising.

Count 1 is supported by the Declaration of Thaddeus B. Curtz, Jr. and the facts provided therein. Justin Kover distributed, mailed, and published an anonymous political advertisement in the form of a flyer beginning October 5, 2011 and continuing for two weeks or more thereafter. The anonymous political advertisement did not contain a sponsor's name and address.

Count 2 is supported by the Declaration of Thaddeus B. Curtz, Jr. and the facts provided therein. Justin Kover sponsored political advertising on October 9, 2011under the assumed name "Matthew Green."

Complainant has provided the Declaration of Thaddeus B. Curtz, Jr. and attachments to support the complaint. Complainant has also provided the Declaration of Stephen Buxbaum to support the complaint.
