To whom it may concern,

Pursuant to chapter 42.17 RCW, I would like to lodge a formal complaint relating to Lieutenant Governor Brad Owen.

His filings have been routinely late, but in the last six months, he has fallen sharply out of compliance. When I discussed this with PDC staff in February 2011, they said they would look into it, but the problem has not been corrected.

The worst offense is that Owen apparently received \$28,470 in contributions during November or December with no disclosure of the source of the money.

It is exactly this circumstance that drove the voters to create the Public Disclosure Commission in the first place and to require full and timely disclosure. An important legislative session has come and gone, but the special interest contributions given to Owen are still hidden from public view.

After decades in Olympia, the Lt. Governor surely knows the law.

In reviewing the PDC forms he submitted, there are several discrepancies:

- He failed to file a C3 for a 9/21 deposit of \$975
- He failed to file a C4 for the months of November and December of 2011
- The first C4 filed for 2012 showed a discrepancy of \$28,470 in contributions and \$18,851 in expenditures

There were a few other issues with his reports. He filed three amended C4's for October 2011, the last of which was filed on December 10, 2011. This third amended October 2011 C4 showed a previous total of expenditures of \$4,892.51 – a difference of \$1,453.80 from the previous C4 period. Nowhere is this additional expenditure itemized or explained.

In addition, Mr. Owen was late on seven of the nine C4's he actually turned in for his 2012 campaign.

This news is troubling given that we are issuing this complaint over 4 months after the November C4 was due.

To whom it may concern,

Pursuant to chapter 42.17 RCW, I would like to lodge a formal complaint relating to Lieutenant Governor Brad Owen and his potential misuse of surplus campaign funds.

As detailed below, Owen reported in 2009 that he had transferred \$23,713 to an "office fund." Since that time he has not reported the balance nor any expenditures from this fund. His office recently said that such a fund does not exist and then clarified that this "office fund" was another name for his surplus funds account. I would like to know what became of these campaign contributions and how they have been spent.

In a January 5, 2009 Schedule A to C-4 form submitted by Bradley Owen to the PDC for December 2008, there shows a December 19, 2008 expenditure of \$23,713.02 to the "Lieutenant Governor's Office Fund". The corresponding description says "gifts and entertainment for visiting dignitaries or gifts while visiting other countries".

The Washington State Republican Party submitted an information request for, among other things, an itemization of expenditures from this "office fund." The preliminary response from Brent Pendleton of the Lt. Governor's office said that no such fund exists or had ever existed during the period requested.

The WSRP re-submitted this request, citing the expenditure in the January 5, 2009 Schedule A. In an email dated May 2, 2012, Mr. Pendleton said this "office fund" is another name for the surplus funds account of the Lt. Governor. As such, he could not provide an accounting of expenditures from this fund.

According to RCW 42.17A.430(7) candidates are authorized to transfer surplus campaign funds to a separate account for use in paying nonreimbursed public office-related expenses. The law requires candidates who establish such a separate account, either for nonreimbursed public office-related expenses or for the other surplus funds expenses permitted under RCW 42.17A.430, to report the disposition of the funds in accordance with RCW 42.17A.240.

RCW 42.17A.240 specifies the information required to appear on the regular C-4 summary report of contributions and expenditures filed by candidates and political committees.

After a thorough review of Mr. Owen's PDC filings, there has been no disclosure of expenditures from this "office fund," nor from any surplus funds account.


As such, I would request that the PDC investigate Mr. Owen's surplus funds account to determine if expenditures from this fund are of proper use and within the confines of the law. Further, I would request that any and all expenditures from this fund be publicly disclosed.

As there is an ongoing investigation into Mr. Owen's PDC filings, this complaint may be added to that investigation.

I have attached all documents referenced in this letter for your information.

This is to acknowledge your public records request received by our office on March 27, 2012 regarding employee records, including their salaries; and costs and reimbursements associated with travel and our state agency budget.

Additionally, you asked if the lieutenant governor maintains an "office" fund and, if so, an itemization of expenses within that fund. Since this agency does not maintain an office fund, nor has it during the period requested, no record can be supplied.

Please be assured that our office intends to fully comply with your request in a timely manner pursuant to Washington state law and administrative code. We estimate that we will need a period of up to three weeks to research these records and provide them to you. Should we need longer than three weeks we will provide you with a new estimate, along with an explanation.

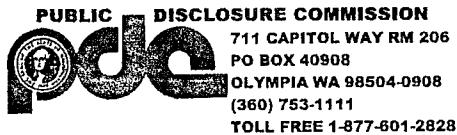

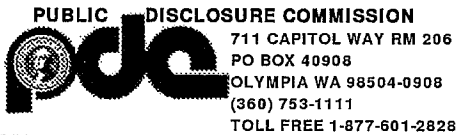

The Committee is in receipt of your letter(s) regarding complaint #12-167 and offers the following response:

A. Citizens to Re-Elect Brad Owen Lt. Governor

1. November/December 2011 receipts not disclosed

Contributors and their contributions are disclosed to the PDC via the filing of C3 reports. The Committee timely filed all seven C3 reports for November 2011. There were no contributions received in December of 2011, therefore no C3 disclosures were filed.

2 Missing reports

The Committee contacted the PDC about the problems with filing the C3 for the 9/21/11-\$975 deposit as well as the November and December C4's. The Committee's software reflected sending the file at the time, but no confirmation was received. The Committee did, however, re-submit these reports to ensure the PDC received complete disclosure information.

3. January 2012 C4 discrepant carry forward balances

The C4 for January reflects the correct carry forward balances from the prior month's C4. There is no discrepancy in the receipts or expenditures.

4. October 2011 C4 multiple amendments and unknown increase in expenditure carry forward total

The two C4 reports dated 11/21/11 were submitted in error and should be deleted from the system since no information was added, deleted, or changed. The only amendment filed was the C4 submitted on 12/10/11 to include two expenditures that had not been included on the original C4. The Committee also filed an amended September 2011 C4 to correct the expenditure carry forward total.

5. C4 reports filed late


Several of these reports were filed timely, but the Treasurer received no confirmation. Upon contacting the PDC and explaining the problem, the Treasurer received the missing confirmations. Please note that the Committee and I take our reporting obligations very seriously and have taken steps to remedy this issue, including, but not limited to, hiring a professional compliance firm.

B. Lt. Governor Brad Owen Surplus Account

In 2003 the surplus bank account was closed and information was received from the PDC that disclosure reports were no longer required. In December of 2008, the remaining surplus funds from the 2008 campaign account of Citizens For Lieutenant Governor Brad Owen were transferred from the campaign and used to open a new surplus bank account. Based on the information received in 2003, no disclosure reports were filed for the activity. However, after discussion with the PDC, the Committee has been asked to provide disclosure reports for the activity. The information was filed to the PDC in conjunction with this response.

Per your instructions, I have attached the supplemental information you have requested.

Kurt, we touched on the change in compliance procedures for the campaign - but I was unsure if it was to be included in the response since we had addressed it in the original submission. However, to cover all bases - and hopefully not be redundant, here is a small outline of our process.

Compliance communicates daily/weekly with the campaign to ensure receipt of all transaction information, receipts (monetary and in-kind), expenditures, obligations, etc.

The information is checked to ensure compliance with PDC rules - limits, permissibility, etc.

The data is loaded into Quick Books and reconciled to the bank on a daily/weekly basis depending on volume.

The data is loaded into ORCA and reconciled back to Quick Books, verifying correct receipt, expenditure, and Cash on Hand totals.

The reports are reviewed and any missing information - address, employer, occupation, etc is obtained and added.

Draft reports are distributed to compliance, candidate and staff for review prior to filing.

In response to your request for additional information, the Committee offers the following response:

Late filed reports: C3 - 11/08/11, C4 - Nov 2011, C4- Dec 2011

The Treasurer, Laurel Willis, stated that she filed the reports timely using the ORCA software. She did add that the files did not reflect the normal color code that usually appends to the filed reports. However, the PDC was having software problems at the time, so the incorrect color code that appeared upon filing did not alarm her since she received confirmation numbers.

When the reports failed to appear on the PDC website, the Treasurer was contacted by the Jennifer at the PDC. The Treasurer gave the above explanation, but was told that neither the numbers nor reports appeared in the PDC's system and was asked to re-submit the reports. There was no indication from the PDC at the time that there would be any fines or penalties associated with the re-submission, but rather the re-filing of reports was to ensure the PDC had the complete reports on the website.

Surplus Account:

The surplus office account was closed shortly after the 2004 election and remained that way until the account was opened in 2008. There are no records available for this account prior to 2008.

Candidates' Surplus Funds – Frequently Asked Questions

What are surplus funds? Any monetary contribution that was received for an election, not spent on the election, still in your possession and control *after* the election is held, and not needed to pay campaign debt from the election.

What can I do with my surplus funds? You have seven options:

1. Refund the contribution(s). Don't return more money to a contributor than you received from that source!;
2. Reimburse yourself for earnings lost as a result of your campaign activities. Lost earnings must be verifiable as unpaid salary, or if you are not salaried, the amount reimbursed should not exceed income received by you for services rendered during an appropriate, corresponding time period;
3. Transfer the surplus without limit to a political party or to a caucus political committee;
4. Make a charitable donation;
5. Give it to the state treasurer for the state's general fund, the oral history, state library, and archives account, or the legislative international trade account;
6. Spend it on nonreimbursed public office-related expenses if you are elected. You must register a surplus funds account with the Public Disclosure Commission and file surplus funds account expenditure reports if you choose this option; and/or
7. You may leave the surplus funds in the campaign account for possible use in a future election campaign for the same office that you were campaigning for when the contributions were received. In order to use the contribution for a campaign for a different office, you'll first have to receive the contributor's written approval.

Can I give my surplus funds to another candidate? No.

Do I have to open a separate bank account for surplus funds? Only if you are spending your surplus funds on nonreimbursed public-office related expenses. A surplus funds bank account is a perpetual account – each time you run for office and are left with surplus funds, they may be deposited into the surplus funds bank account regardless of which office you sought. (e.g., Surplus funds from a city council campaign can be deposited into an account that contains surplus funds from a state legislative campaign.) Only surplus funds can be deposited into the surplus funds bank account!

Do I have to report how I spend my surplus funds? Yes.

If you do not open a surplus funds bank account because you are not going to make nonreimbursed office-office related expenditures, continue to file monthly campaign reports after the election showing your

expenditures. At the end of each month, if you have not spent \$200 since the last C-4 report was filed, you may wait until you do and then file a report for multiple months.

If you plan to make nonreimbursed office-related expenditures, open a surplus funds bank account and file a Candidate Registration (PDC Form C-1) for the account. File monthly surplus funds account C-4 reports showing your expenditures. At the end of each month, if you have not spent \$200 since the last surplus funds account C-4 report was filed, you may wait until you do and then file a report for multiple months.

If I open a surplus funds bank account, when can I close the account? The account can be closed when the balance is \$0.

What do I do if I want to keep the surplus funds to use in my next campaign? File a final C-4 report for the current campaign and show the balance of your surplus funds on Line 20. When you become a candidate in the future and file your initial C-4 report, report the balance of the surplus funds again on Line 1. Any bank charges paid or interest earned during the period between the campaigns will be reported on the initial reports of the future campaign.

Can I invest my surplus funds? Yes. Campaign funds or surplus funds may be invested in bonds, certificates, tax-exempt securities, savings accounts or other similar instruments in financial institutions or in mutual funds. Financial institutions other than banks, savings and loan associations, and credit unions may NOT be used as the campaign depository into which contributions are deposited and out of which campaign expenditures are made. However, brokerage houses and other financial institutions may be used for investing campaign funds so long as the investment by the brokerage house or other institution is in the form of bonds, certificates, tax-exempt securities, and mutual funds.

If you invest campaign funds, take the following steps:

- Notify PDC by letter of the date, amount and the name of the financial institution where the surplus is invested. Do not report the investment as an expenditure on Schedule A or on the C-4 report.
- Deposit all interest, dividends or income earned by the investment into the investment account. Report this income as miscellaneous receipts on line 1d of the C-3 report.
- When the investment is terminated, re-deposit the principal plus the accrued earnings into the original campaign account. Notify PDC by letter that this re-deposit has been made. Do not report this transfer as a contribution on the C-3.
- Check with the IRS or your personal tax consultant about any tax liability that the investment may create.

You have asked for clarification of what constitutes a "public office fund" as referenced in RCW 42.17.710.

RCW 42.17.710, known as the session freeze period, prohibits a state official from soliciting or accepting contributions to a public office fund, to a candidate, or to retire a campaign debt during a regular legislative session, thirty days before and after session, and during any special session.

The Public Disclosure Commission had the same questions you have raised, and in 1996 sought an Attorney General opinion for clarification. I am enclosing a copy of the opinion, but I can briefly summarize the conclusions of the Attorney General's office as follows:

- RCW 42.17.095, as amended in 1995, authorizes a public official to establish an account with surplus campaign funds from which nonreimbursed public office related expenses may be paid, but did not eliminate the ability of public officials to establish public office funds or solicit donations for them.
- There are no reporting requirements for the receipt of donations to a public office fund.

The only limitation under RCW Chapter 42.17 on soliciting donations to a public office fund appears to be the freeze period of section .710. (PDC staff has advised state officials that they may not, during the freeze period, solicit funds to pay for office related expenses, regardless of whether a public office fund has been formally established.) You may wish to contact the Executive Ethics Board

for guidance on any restrictions under the ethics law against receiving or soliciting donations to a public office fund.

As noted above, RCW 42.17.095 does provide for the establishment of a surplus funds account, into which surplus campaign funds may be deposited. The moneys in a surplus funds account may be used for several, specified purposes, including nonreimbursed public office related expenses. I am enclosing a copy of section .095, and instructions from the State Executive and Legislative Candidates manual which explain in more detail how to establish a surplus funds account and the purposes for which it may be used. Please note that only surplus campaign funds may be deposited into this account, and that officials may not use active campaign moneys for office related expenses nor accept donations to the surplus funds account.

I hope the foregoing answers your concerns. Please do not hesitate to contact me if I may be of further assistance.

Recently per a verbal inquiry to our office attorney general we were told there was no such fund.

Please respond to the following questions:

1. What is the aforementioned "public office fund?"
2. Can we solicit funds for it and to what purpose?
3. If we can solicit funds for it, what are the limitations?
4. If this fund does not exist except in language and not in reality then is there a method to raise funds for expenses of the office not payable with public funds?

If you invest campaign funds, take the following steps:

- Notify PDC by letter of the date, amount and the name of the financial institution where the surplus is invested. Do not report the investment as an expenditure on Schedule A or on the C-4 report.
- Deposit all interest, dividends or income earned by the investment into the investment account. Report this income as miscellaneous receipts on line 1d of the C-3 report.
- When the investment is terminated, re-deposit the principal plus the accrued earnings into the original campaign account. Notify PDC by letter that this re-deposit has been made. Do not report this transfer as a contribution on the C-3.
- Check with the IRS or your personal tax consultant about any tax liability that the investment may create.

Surplus Funds Accounts

Who Needs to Set Up a Surplus Funds Account.

Any elected official who wants to spend surplus campaign funds for non-reimbursed public office related expenses must set up a Surplus Funds Account in order to make these types of expenditures.

The other six legally permissible options for disposing of surplus campaign funds found in RCW 42.17.095 and listed below in "Using the Account" may be engaged in either with a Surplus Funds Account or directly out of the old campaign account. However, the dangers of not setting up a separate Surplus Funds Account and simply disposing of surplus funds out of the now inactive campaign account are:

- 1) the funds can't be used for non-reimbursed public office related expenses; and
- 2) once new campaign monies are co-mingled with any existing surplus balance, or the surplus is carried forward to a new campaign, or expenditures triggering candidacy for a new campaign are made out of the account, none of the funds in the account is considered surplus and the money now may only be used for expenditures that are directly related to the new campaign.

Opening the Account. Take all or a portion of truly surplus funds and open a separate Surplus Funds Account (or transfer latest surplus into an already existing Surplus Funds Account).

"Surplus funds" are the balance of contributions given for a specific election that remain after the election and are not needed to pay off that election's campaign debts. Funds remaining after an election are NO LONGER SURPLUS FUNDS if they have been carried forward to a new campaign, mingled with new contributions for a future election, or used to make expenditures for a future election campaign.

Using the Account. According to RCW 42.17.095(7), you may only use monies in a Surplus Funds Account for one or more of the following purposes.

- Non-reimbursed public office related expenses.*
- Refunds to contributors. Refunds of contributions made by the candidate to his or her own campaign are subject to restriction. See page 8.
- Payments to the candidate for verifiable earnings lost because of campaigning.
- Unlimited contributions to a bona fide political party or caucus political committee.
- Donations to a charity registered with the Secretary of State in accordance with RCW 19.09.
- Deposits into the state's general fund.
- Transfers to your campaign account for use in a future election (if a different office is sought than the one for which the surplus funds were initially raised, written permission will have to be obtained from the contributors of the remaining surplus before the surplus may be used to seek the different office).

*A "non-reimbursed public office-related expense" is an expenditure incurred by an elected or appointed official, or a member of his or her immediate family, solely because of being an official. [WAC 390-24-032]

Reporting a Surplus Funds Account. When the account is established by opening a separate bank account:

- file a C-1 giving the Candidate's Name plus the words "Surplus Funds Account;"

- transfer all or a portion of the eligible surplus funds into the new or existing Surplus Funds Account (which should be a checking account -- rather than a savings account-- if there will be more than infrequent expenditures out of it); and
- file C-4 reports along with Schedule A's showing any transfers into the account at the top of the Schedule A and also itemizing all expenditures out of the account on the form. File a C-4 for the Surplus Funds Account monthly by the 10th of the month, covering the preceding calendar month, for any month in which you transferred in or spent over \$200. If over \$200 in activity does not occur in a month, the next report is triggered when over \$200 has been transferred into the account or spent out of it since the last report was filed. Then, file the C-4 by the 10th of the following month.
- File future C-3 and C-4 reports for the new campaign according to the reporting schedule for that campaign.

Note: ONLY SURPLUS FUNDS FROM A CAMPAIGN MAY BE DEPOSITED INTO A SURPLUS FUNDS ACCOUNT. RCW 42.17.095(7).

Start-up of New Campaign

A candidate's committee does not "net out" annually, but aggregates contributions and expenditures throughout the existence of the candidacy or campaign. For example, a candidate might begin seeking contributions and making expenditures two or three years before an election. The aggregate of all contributions and expenditures is shown on C-4 reports until the election is over.

Here are the steps to follow to start a new campaign:

- File a final C-4 report with the appropriate schedules for the earlier campaign. Include all transactions since the last C-4 was filed. Indicate in the space provided that this is the final report.
- File a C-1 registration statement for the new campaign.
- File a C-4 report for the new campaign. The surplus carried forward from the old campaign is reported on line 1 of the C-4 as shown in the example on page 55. If you are carrying forward any debts from your previous campaign, identify them in Part 3 of Schedule B and include the amount on line 19 of the C-4. Appropriate schedules are attached showing new contributions and expenditures.
