Dear Sir:

I am formally filing a complaint against City of SeaTac Councilmember Mia Gregerson and the Firefighters Union IAFF for violating RCW 42.17 or Title 390 WAC.

Mia Gregerson and Ms. Brandt-Schluter organized and scheduled meetings at non-profit agency facilities and Angle Lake residents' homes, thus including other city staff and their spouses to ensure the defeat of Proposition #1 and obtain endorsements from the firefighters for their chosen candidates running for SeaTac City Council.

IAFF Union President John Gallup and Adam Renn (IAFF SeaTac City Political Action Committee) also used city email and resources, actively strategizing, not only about endorsements, but also to the opposition of Proposition #1.

The city firefighters used numerous city vehicles to go to the Bow Lake Mobile Home Park to a Firefighters Breakfast and then openly distributed flyers, soliciting opposition to the Change of Government (COG).

The city has attempted multiple cover-ups to avoid addressing these illegalities. They delayed release of emails for over a year, jeopardizing availability of evidence because of records retention limits. They even hired a consultant to create a sham investigation report to whitewash the violations.

Enclosed are copies of pertinent emails of the literally thousands of emails I have obtained between Mia Gregerson and Colleen Brandt-Schluter, including emails from SeaTac City Firefighters that clearly depict these serious violations.

The last email will show the same tendency started in February of 2010, using city email by Pat Patterson (Facilities Manager) to strategize for the 2011 election of which they were not only successful in stopping the COG, but electing two of their team members (Dave Bush and Barry Ladenburg) to the City Council, allegedly violating RCW.42.A.335 in the process. *This is to be determined at a later date by the Attorney General's Office.*

Dear Honorable Public Disclosure Commissioners,

I appreciate the allowance to have more time to respond to these allegations pertaining to RCW 42.17.130.

It has been nearly three years since I have had access to these emails. I cannot honestly state that I know the intent of each email or that they are in chronological order. What I can state is that I have never used any public facilities or suggested that anyone use a public facility to promote or oppose either a ballot measure or a candidate. I never formed or worked on a steering committee to support or oppose a ballot measure or candidate. This is in response to the allegation about using public facilities such as my email account to support or oppose a ballot measure and or candidates.

The majority of these emails are dated in June and July 2009. Whenever there is a reference to the Proposition One (COG) or a candidate, I remember it being more in the context of questioning the subject matter. The community that I serve is very diverse. We are diverse in culture, language, economic status and fragmented in where we live. We do not have established neighborhoods or a city center where people gather. My emails are focused around the desire to figure out how to connect this diverse community.

I must admit that although I held the title of an elected official, I was new at this role and I ran unopposed. Running unopposed stunted me in many ways. One was building the community infrastructure to outreach to the community and Colleen's role as the human services manager was a natural connection to learn about the community members who represented certain ethnic, cultural or religious leaders. Second, I did not know how to run a campaign or what to do when information was important to me and how to get that information out to the community I serve. Neither Colleen or I knew very much about how a ballot proposition was run and especially how to run a campaign. What we wanted was to continue to outreach to the community about; schools, safety, animal control, code enforcement, programs, ect. Please note that these emails represent many different topics and subjects.

Two emails to note is one on July 6<sup>th</sup> and one on July 7<sup>th</sup>. The email on July 6<sup>th</sup> discusses the newspaper that had information on the ballot measure on its front page. We questioned its integrity to show all sides of the issue and we discussed who knew about the article but we never tried to do


anything about it. The second email was dated July 7th. Although I mention a "steering committee is being formed." I did not form a steering committee nor did I work on it. I never outreached to the African American or Somali community about Proposition One or a candidate. Colleen and I are personal friends. What you see is a lot of fast paced chatter back and forth about lots of different topics. The comment about "forming a steering committee" was really irrelevant. I do not know why that was even written or discussed in these emails.

My intent was never to do harm or cheat. I did personally oppose the Proposition one and support candidate Jonathan Standridge but I never intentionally used my councilmember title or city resources to support or oppose these ballot issues. My husband (Scott) was on the steering committee to oppose Proposition 1 but I did not have anything to do with it. I did attend a meeting or two on my own time but I never did anything to force or coerce Colleen Brandt -Schluter, the SeaTac firefighters or any SeaTac staff or constituents while using my city email account to push my personal viewpoints.

I would happily entertain any questions or concerns you have from any of the emails that were submitted and any of the notations that were noted by Mrs. Aileen Fisher. The intent was to keep this statement centered towards the PDC's written and formal concern.

If the commission does find me to be guilty then I apologize for the inappropriate behavior and will make every attempt to never reoffend. I will continue to educate myself on the laws and restrictions related to use of public facilities and property. I appreciate the work of the Public Disclosure Commission and staff. Lastly, I will work diligently with the PDC to fulfill whatever fine and or penalties that result from this case. Thank you for your consideration.

Dear Public Disclosure Commissioners,

Thank you for allowing the extension of time for me to respond to the complaint filed by Aileen Fisher, PDC Case No. 12-165. The following provides an explanation of my work and my response to the allegation of my emails seeming to indicate that I may have engaged in campaign activity using my city of SeaTac email account.

My job requires me to manage the planning, organization, and coordination of a comprehensive Human Services program to meet the needs of the community. I work within the community to identify and address critical and emergent Human Service needs as well as assess and prioritize the needs to facilitate collaborative partnerships and programs that address those needs. I advise City Management and Council of relevant issues and concerns and often obtain Council direction and approval when necessary. Lastly, I work hard to maintain effective relationships and advise and assist all departments as requested to assess the needs of the community, provide recommendations regarding outreach to our residents, how to work with our multicultural population, and collaborate with service providers.

When I was hired I was unfamiliar with Public Records Requests, the Public Disclosure Commission and the acceptable/unacceptable work practice within the PDC laws/requirements. My first week I was told by the City Manager that I work for him and seven council members and I should provide whatever they needed. I am a hard worker with an intention to meet and exceed expectations, so in anything I have been asked for and provided to a council member it has been under that assumption and work ethic.

I'd like to share that I had never met Councilmember Gregerson prior to her becoming a councilmember. We became acquainted in her desire to understand the community. Anytime I talked with, met with, emailed Councilmember Gregerson, numerous topics were discussed, and so often our discussions bounced from one topic to another. When others decide to "contextualize" our discussions they truly lose their meaning! We became friends over time and worked hard in an effort to build a sense of community for SeaTac. Lastly, it is important to note that I am not a resident of SeaTac and do not vote in their elections.

Within the documents you sent me are numerous duplications of emails so with brevity in mind I am responding to those emails that question whether I supported/opposed a candidate or proposition.

***Emails having to do with contacts in the community*** had nothing to do with a proposition or a candidate. Many people come to me asking for contacts . . .it's my job to build relationships and connect people with natural leaders, providers, partnerships, and try to build capacity for better understanding. Building school relationships had to do with the failure rates of kids of color in our school district, not to engage them in politics.

***Emails suggesting I was supporting a candidate*** – I did not support or oppose any candidate. I was concerned that Candidate Rick Forschler, the chair of the Human Services Advisory Committee, was

asking for the committee's support of his candidacy both personally and within the community and how uncomfortable the committee members were with his request.

*Emails regarding firefighter endorsement* are strictly a question, not a recommendation. I work for this councilmember and was asking how that process worked.

*Email regarding COG* – I did not support/oppose this proposition. I acknowledge I was aware of a front page article in the local newspaper and acknowledge Councilmember Gregerson's effort to encourage the community to understand the issues in front of them and to register to vote.

*Emails regarding distribution of materials on National Night Out* – I visited scheduled events and distributed my human services brochures and business cards only.

To summarize:

- I did not use any public facilities or suggest public facilities be used to promote or oppose a ballot measure or candidate, nor did I suggest anyone use any public facility or organization to support or oppose a ballot measure or candidate.
- I never organized, scheduled, or attended any meetings having to do with a ballot measure or candidate. I do not live or vote in the SeaTac community.
- I did not engage in campaign activity or assist a candidate or support/oppose a ballot measure. My questions were genuine to the person I work for without an intent to use influence or suggest anything other than the community be encouraged to understand the issues that affect them.
- I would never want to jeopardize the city I work for nor my job as I value both very much! I understand the importance of the RCW laws and if I have been inappropriate I sincerely apologize. Because of these allegations I have made a concerted effort to educate myself on the PDC laws.

Thank you very much for your consideration of my perspective! I am more than willing to cooperate in your investigation by answering any questions or elaborating on my response.

Technically it appears the minimum legal requirements were met, however, for those SeaTac Citizens such as myself, who attend Council meetings on a regular basis and have signed up to routinely receive council meeting agendas electronically (not received in this case), this was highly unusual. None of the other routine/normal and logical places had the meeting announcement. I actually thought it was a calendar misprint or executive session (since it was being held in the executive conference room versus Council chambers) until I emailed the City on Monday.

The process for publishing meeting announcements should be written down/followed and alternate personnel trained regardless of staff absences. In such rare cases, especially on such short notice, considering carrying the announcement on the City's website home page.

I hope you see the irony that the meeting subject matter was a City Vision and from attending it, the main topic/s of the agenda/discussion was civic engagement in determining that vision. The civic engagement part seems hard to do if the Council calls a Public Special Meeting on the subject and the Citizens don't know about it.

I am no PR person but I think the Visioning Process (should the Council approve additional expenditures) is not off to a good start.
