Findings of Fact,
Conclusions of Law, and
Order Imposing Fine

A brief enforcement hearing (brief adjudicative proceeding) was held July 8, 2014, in Room 206, Evergreen Plaza Building, 711 Capitol Way, Olympia, Washington to consider whether the Respondent violated RCW 42.17A.700 by failing to file a Personal Financial Affairs Statement (F-1 report) due April 15, 2014, disclosing financial information for calendar year 2013.

The hearing was held in accordance with Chapters 34.05 and 42.17A RCW and Chapter 390-37 WAC. A brief enforcement hearing notice was sent to Glen Morgan on June 10, 2014. Commission Member Amit Ranade was the Presiding Officer. The Commission staff was represented by Jacob Berkey, Compliance Coordinator. The Respondent participated at the hearing.

Having considered the evidence, the Presiding Officer finds as follows:

FINDINGS OF FACT

1. The Respondent was an incumbent School Director for Rochester School District 401 in 2013.
2. As a School director, the Respondent was required to file F-1 reports no later than April 15, 2013 and April 15, 2014.
3. The Respondent did not file the missing F-1 reports by the date of the hearing.

4. The Respondent brought an incomplete F-1 report to the hearing covering calendar year 2013, which was due April 15, 2014. It did not have a valid signature.
5. The Respondent has no prior violations.

CONCLUSIONS OF LAW

Based on the above facts, as a matter of law, the Presiding Officer concludes as follows:

1. This matter was duly and properly convened and all jurisdictional, substantive and procedural requirements have been satisfied.
2. The Respondent violated RCW 42.17A.700 by failing to file the F-1 reports by than April 15, 2013 and April 15, 2014.

ORDER

ON the basis of the foregoing Findings of Fact and Conclusions of Law,

IT IS HEREBY ORDERED that the Respondent is assessed a civil penalty of \$300 in accordance with the penalty schedule set forth in WAC 390-37-160. Of the penalty, \$150 is suspended on the following conditions:


- 1. Respondent Files the missing F1 reports for 2012 and 2013 within 30 days from the date of this order;**
- 2. The \$150 non-suspended portion of the penalty is paid within thirty days of the date of this order; and**
- 3. Respondent commits no further violations of RCW 42.17A within the next two years from the date of this Order.**

If the Respondent fails to comply with any of these conditions, the suspended portion of the penalty will become immediately due and payable without further action by the Commission.

This is an **Initial Order** of the Public Disclosure Commission.
