

Professional Services Contract

This contract entered into this day between "Citizen Solutions L.L.C.", a Washington State Company, and hereafter "CS" and Voters Wants More Choices, hereafter "PROPONENT", shall remain in full force and effect until fulfillment on or before July 6, 2012, or upon PROPONENT'S cancellation at any time.

- 1) "CS" agrees to circulate PROPONENT'S 2011 Initiative to the People of Washington (such petition referred to hereinafter as the "Petition"), thereby obtaining up to 300,000 signatures at a cost to PROPONENT of, \$1,050,000.00. (one million fifty thousand dollars)
- 2) "CS" will perform a statistical random check of the validity of signatories obtained against the voting rolls as available on disc and certify the validity rate of each turn-in batch is within industry standards of 75%. *Validity rate is defined as the number of signatories, which are confirmed as registered to vote as determined by a random check, in Washington State according to said disc, expressed as a percentage of total signers.*
- 3) "CS" will turn full and partially full signature sheets over to PROPONENT. Each original petition sheet shall be delivered, on a regular basis at a time and location mutually agreed upon.
- 4) PROPONENT agrees to pay consideration to "CS". in the amount of \$3.50 per each signature contained in each turn in batch, with completed address, collected in accordance with this contract at time of delivery.
- 5) Proponent agrees to pay "CS". a \$30,000 deposit, upon execution of this contract. Deposit held against proponent's final payment.
- 6) "CS". may sub-contract any part of this contract.
- 7) PROPONENT agrees "CS" shall be PROPONENT'S exclusive contractor for paid signatures and proponent shall not pay any other person or entity for signatures.
- 8) PROPONENT will provide "CS". blank petition sheets in quantities as requested by "CS".
- 9) If PROPONENT decides to cease collecting paid signatures on said initiative PROPONENT must notify "CS" and provide written notice via email to signatureman@aol.com, "CS". will then have seven full business days from receiving the shutdown notice to turn the final signatures over to PROPONENT. Subject to the terms described herein, PROPONENT agrees all payments are due upon final delivery.
- 10) PROPONENT shall have the right to terminate this Contract at any time with a seven day shutdown notice as described in number 10 above.



Harwig & Harwig Enterprises, a petitioning firm from California that has been suspended and not registered to do business in this state, began paying petitioners for signatures on or about April 15, 2012 on I-517. Payment for signatures is occurring daily to **Rob Harwig (907-332-9198)** in a motel room at Americas Best Value Inn, Edmonds (22127 Hwy 99, Edmonds, WA 98026 (425) 776-0200).

The C1 PC form for I-517 was filed on June 11, 2012, however the campaign had been actively collecting signatures since April. The PDC reports also show that on July 16, 2012, Jack Fagan sent a letter to the PDC requesting a change in reporting status. That letter is disingenuous because the I-517 campaign had been running a paid petition drive for about three months as of the date of that letter. The letter in part states, "A C-4 report was filed on July 1, 2012 with appropriate schedules disclosing all monetary activity to date." That statement is false because the contributors and expenditures for a paid petition drive going on since last April have not been disclosed. The sponsors of I-517, Mr. Eyman, Mr. Fagan and Mr. Fagan all have many years of experience filing PDC forms and they are all well informed about the PDC rules regarding initiative campaigns. Their failure to disclose their contributors and expenditures as required since last April is a violation of RCW 42.17. I urge the PDC to investigate and to use their enforcement authority to fine this campaign for knowingly producing fraudulent PDC reports.



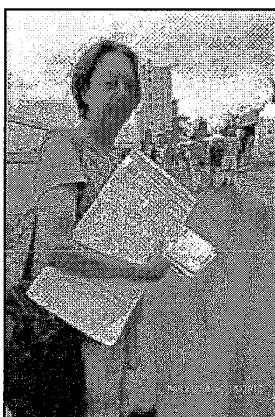

My name Miles Stanley, with Washington Petitioners Limited Liability Co.

I have been collecting signatures in the State of Washington since 2001 and this year agreed to work for Citizen Solutions, LLC as a contractor for Initiative 1185.

The agreement was to pay one dollar to the petitioner for every I-1185 collected. We agreed on a graduated pay scale for production bonuses (see email next page).

Two weeks into the I-1185 petition drive, Eddie Agazarm provided blank I- 517 petition sheets to all of the contractors for I-1185 and we were told that we needed to bring in equal amounts of signatures on both I-1185 and I-517 initiatives or "I would be fired," Eddie said (see second email on page 3).

On May 5, 2012, I was fired for not bringing in any of the I-517 signatures. Then, Eddie told me, if I wanted to continue working, that I would have to turn into Rob Harwig (Peoples Petition LLC), because he agreed to reduce the pay to 75¢ a signature for I-1185 so there would be 25¢ left to pay for the I-517 signature.

I refused to do that and so did my crew, so we decided not to work for Rob Harwig.





My name is Rick Walther, I am owner of Petition Management Services.

Around March 5th, 2012 I received a call from Eddy Agazarm about the upcoming I-1185 campaign, and we discussed the contract details for payment on I-1185.

I recruited workers through the month of March for the upcoming I-1185 petition drive.

On April 4th 2012, we had a meeting at the Hawks Prairie restaurant in Lacey. At the meeting Eddy handed me my contract agreement, plus blank I-1185 petition sheets.

My contract was signed by Roy Ruffino. The contract stated that I would be paid \$1.40 per signature on I-1185, in which \$1.00 went to the workers and 40¢ was my pay for managing.

My first turn-in on April 11th, 2012 exceeded my expectations, and I turned in 3,158 signatures on I-1185, which was the highest turn in for the week out of all the other contractors.

The second turn-in on April 18th, 2012, I was again the top producer, turning in 4,330 signatures on I-1185. At that same turn-in, on 4-18-12, we were told by Eddy, to take the blank I-517 volunteer petition sheets and we were expected to turn in equal numbers on I-1185 and I-517. If our petitioners did not want to work the I-517 volunteer issue, Eddy said they could "Go home, at anytime" meaning go for



good, and he laughed.

I turned signatures for I-517 for the first two weeks in which I received no pay for the petitioners work. They collected signatures for I-517, not as volunteers, but as a way to keep receiving pay for signatures collected on I-1185.

On my third turn-in 4-25-12, my numbers on I-1185 dropped by over 1,000 signatures as a direct result of carrying I-517. Also, on 4-25-12, Eddy was now threatening people to get equal numbers on I-1185 and I-517 or we were to fire our petitioners and risk termination ourselves.

None of the other contractors for I-1185 were able to get equal numbers with I-517, and all were very upset about Eddy's threats and harassment.

I asked Eddy "If you need equal numbers, why didn't you just start both petitions at 50¢ each?" His response was "If we keep I-517 in volunteer status, then we don't have to report income to the PDC, and we can stay under the radar."

A few days later I received a call from Eddy trying to coerce me into lowering the price to the petitioners on I-1185 from \$1.00 per signature down to 75¢ per signature, and then the extra 25¢ was to pay for every I-517 signature that came in.

Other I-1185 contractors including Leonard Ruthford, Eric Stanley, Rob Harwig, Miles Stanley (no relation to Eric Stanley) and myself were all upset about the price reduction on I-1185 to pay for I-517. Leonard Ruthford, Miles Stanley, and myself refused to take the \$1.00 per signature that the petitioners were contracted for on I-1185, and lower it to 75¢ to pay the 25¢ on the I-517 petition.

A day later I received a phone call from Rob Harwig stating that he agreed to take part in the price changes. Rob Harwig, Wendy, and Eric Stanley all agreed to reduce the petitioner's pay on I-1185 from \$1.00 down to 75¢, and pay the extra 25¢ on the I-517 petition signature.

The money being paid on the I-517 was being paid from the I-1185 contract agreement that I signed with Roy Ruffino.

On May 5th, 2012, Leonard Ruthford, Miles Stanley and myself were all released from our contracts for not participating in the price changes, although we were all told different excuses of why we were let go.

Wendy, Eric Stanley, and Rob Harwig, who all agreed to the lowering the price on I-1185 to pay on I-517, remained working for Citizens Solutions LLC until the end of the I-1185 campaign which ended in the beginning of July.

Rob Harwig (from Santa Cruz, California), owner of People's Petition, is currently collecting signatures on I-517 paying 75¢ per signature while carrying the I-514 (legalize marijuana issue) and I-522 (GMO) petitions as bait to get a signature on the I-517 petition.

I-517 campaign filed an amended report on Aug. 22 declaring a previous unreported donation for I-517 Petitioning by Citizens In Charge (571-327-0441), 2050 Old Bridge Road, Lakeridge, VA 22192 dated 7/25/12 - Paul Jacob is the contact person there. That amended report does not cure the problem because it does not cover the months of April, May and June when petitioners were being paid for I-517 signatures. I cannot find a C5 or C4 report for Citizens in Charge.

Below is an affidavit from a professional petitioner residing in Seattle who worked the I-517 petition drive in May for pay.

My name is Steve Burdick. I am a professional signature collector. I was paid for collecting signatures on I-517 in May, 2012.

My agreement with Rob Harwig was 75¢/signature on I- 1185 and 25¢/signature on I-517. If I collected 400 signatures on both petitions within one week, I would be paid 75¢ for each signature turned in.

I received the I-517 petition sheets on or about April 23, 2012 and began collecting signatures the same day I received them.

I worked both initiatives for a couple of weeks and collected 400 signatures on each.

I met Rob Harwig at his motel room in Americas Best Value Inn and received \$1200.00 in payment for the work - which worked out to 75¢/signature for each I-517 signature I turned in.

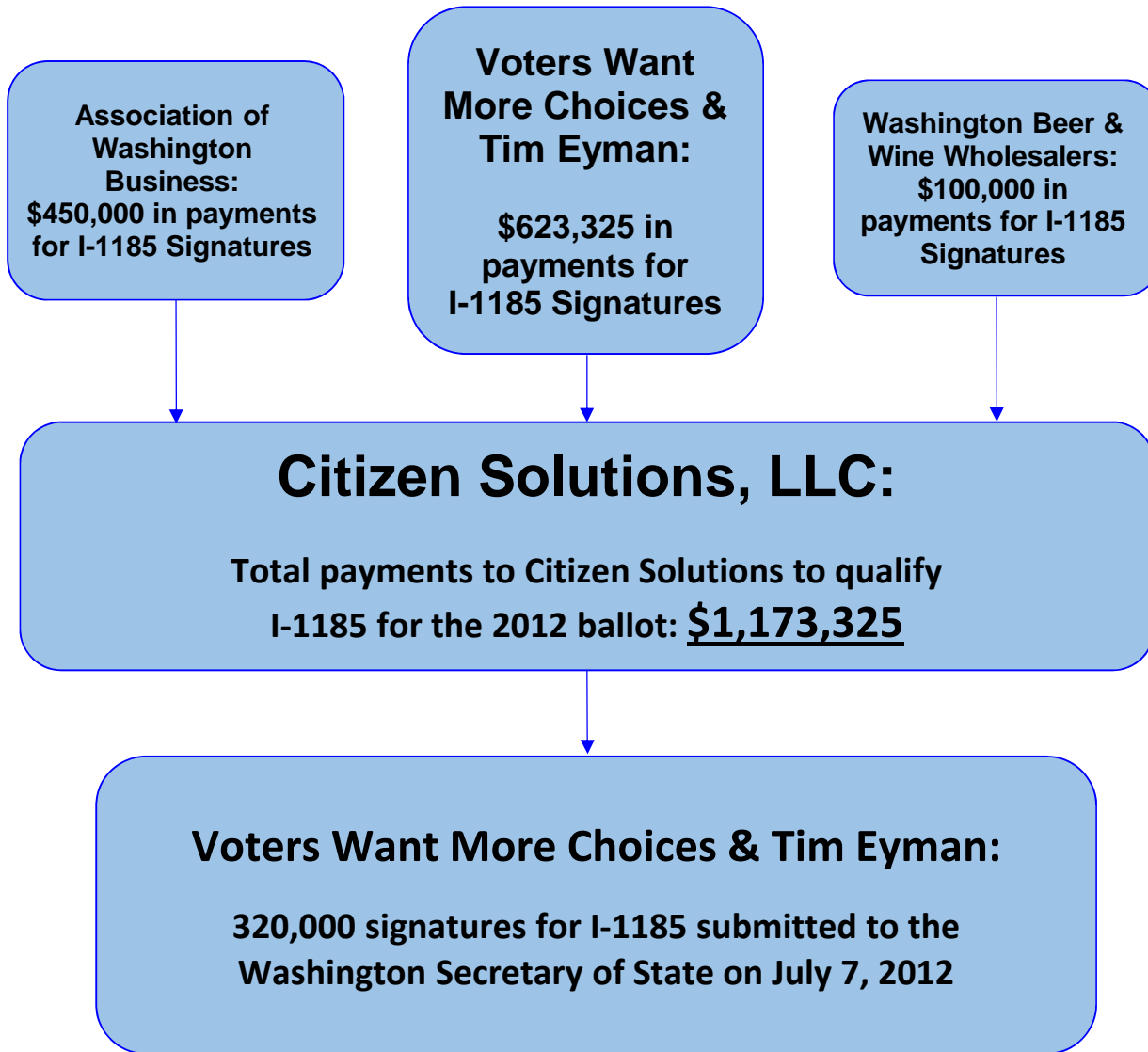

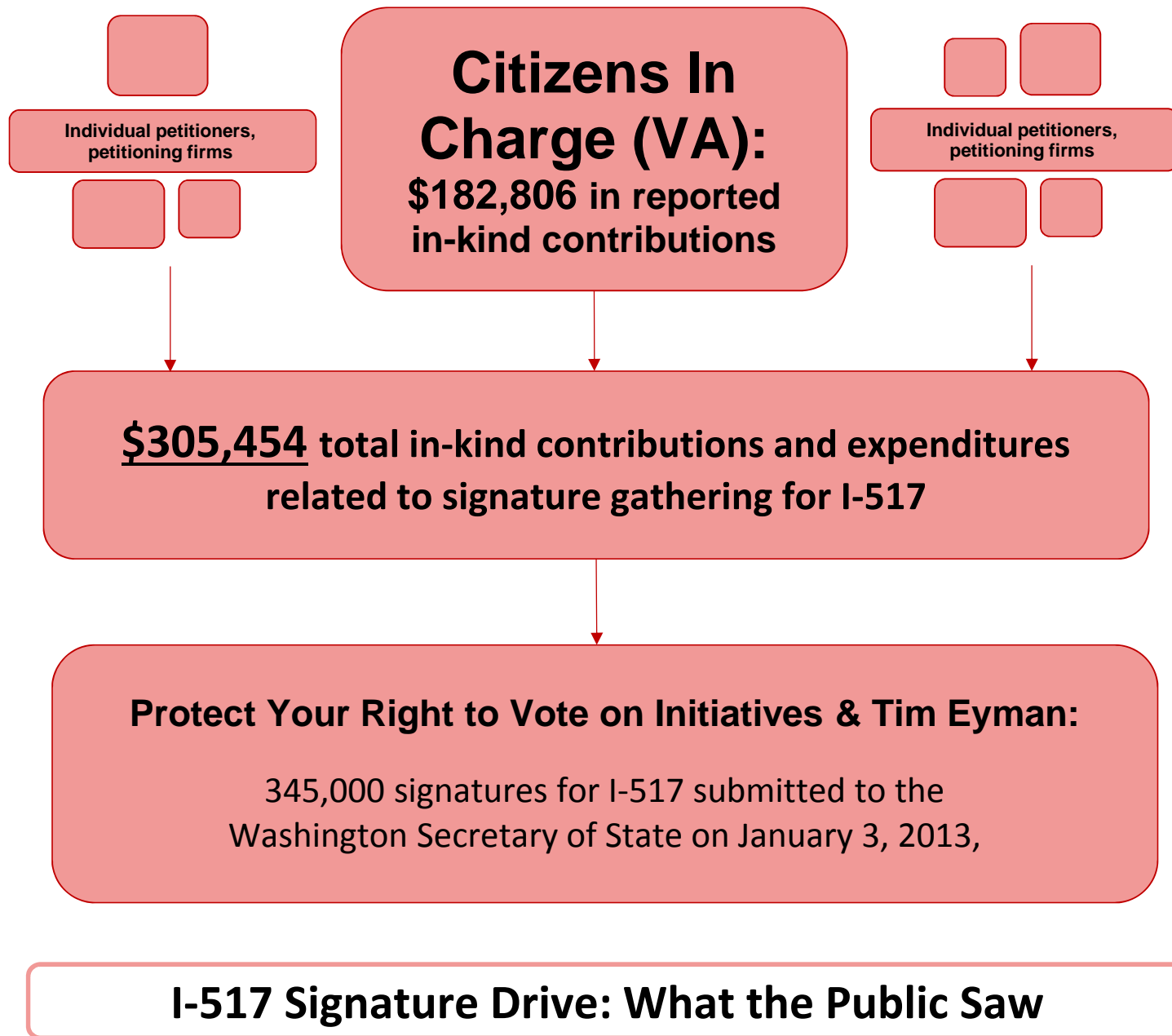

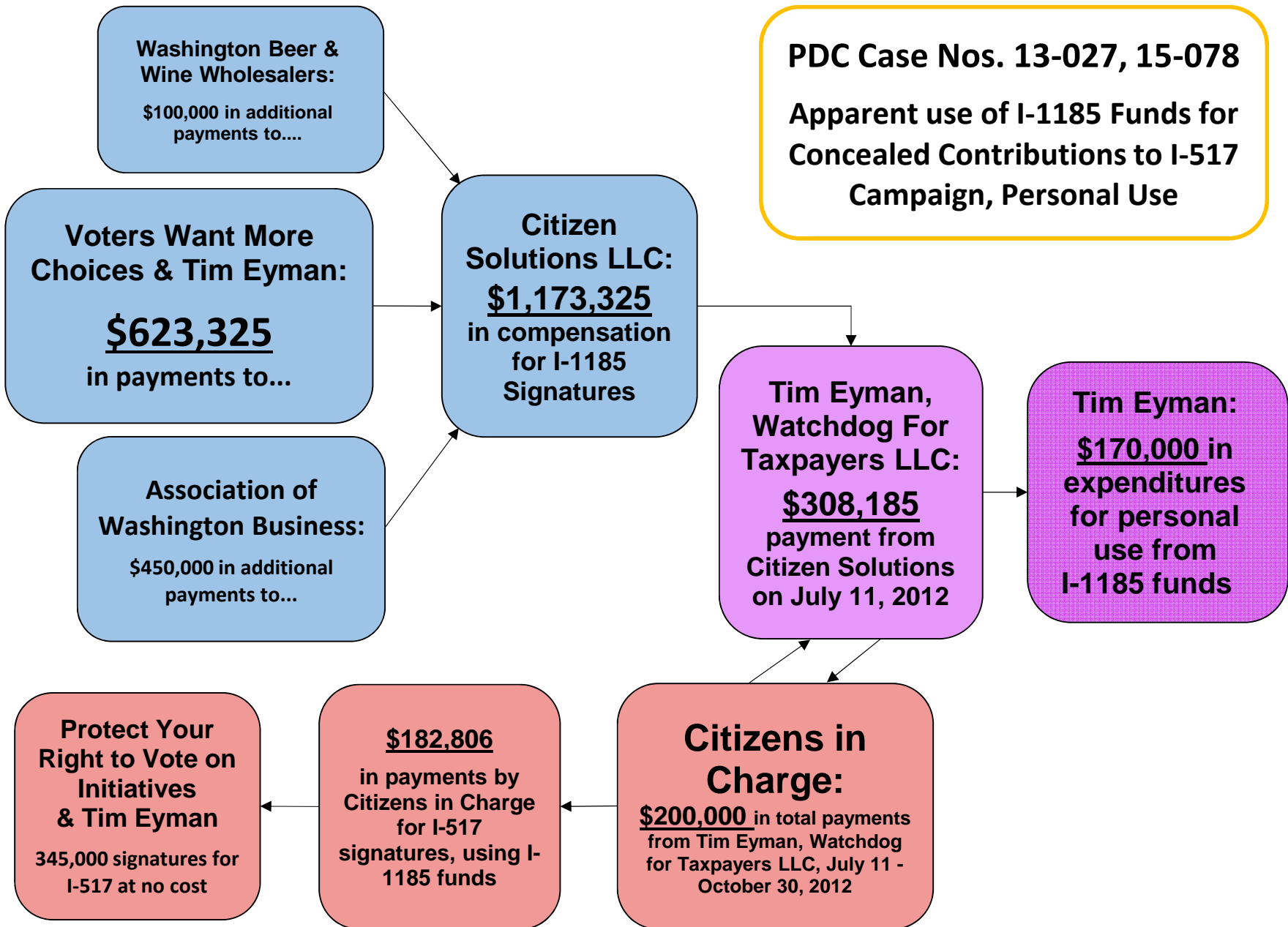

**NEW SECTION. Sec. 2.** A new section is added to chapter 29A.72 RCW to read as follows:

This section establishes protections for signature gathering for any state or local initiative or referendum. Interfering with signature gathering shall be illegal. Any person who is gathering signatures for an officially filed and processed initiative or referendum shall not have his or her right to petition deterred or infringed upon. Any person who is trying to sign a petition for an officially filed and processed initiative or referendum shall not have his or her right to sign a petition deterred or infringed upon. Any person who interferes with any person gathering signatures or interferes with any person trying to sign a petition or retaliates against or stalks any person who signed a petition or retaliates against or stalks any person who gathered signatures for a petition shall be subject to the anti-harassment procedures in chapter 10.14 RCW and civil penalties and shall be guilty of disorderly conduct under RCW 9A.840.030. For purposes of this section, "interfering with" includes, but is not limited to, pushing, shoving, touching, spitting, throwing objects, yelling, screaming, or being verbally abusive, or other tumultuous conduct, blocking or intimidating, or maintaining an intimidating presence within twenty-five feet of any person gathering signatures and any person trying to sign a petition. As the courts have consistently ruled, the signing of a petition and the collection of voter signatures is core political speech, which is deserving of the highest levels of protection. Signature gathering and petition signing for an officially filed and processed initiative or referendum shall be a legally protected activity on public sidewalks and walkways and all sidewalks and walkways that carry pedestrian traffic, including those in front the entrances and exits of any store, and inside or outside public buildings such as public sports stadiums, convention/exhibition centers, and public fairs. Law enforcement must vigorously protect the rights of the people who want to sign initiative and referendum petitions, and the people who collect voter signatures on initiative and referendum petitions, to ensure they are not inhibited or restricted in any way.

Your letter concerning the I-517 complaint was forwarded to me. I believe my August 27th email (reprinted below) responds, explains, and addresses most everything in the complaint.

But on page 2, you wrote: "*... please note the April 9, 2012 emails by Edward Agazarm, in which he stated that petitioners who did not 'get free signatures' or 'bring in equal numbers' would be fired.*"

As I wrote in my August 27th email to you: "*Up until having a severe stroke in May of last year, I was one of the officers of the paid signature gathering firm Citizen Solutions Inc. I retired in 2011 due to my diminished health and resulting disabilities.*" At the end of 2011, Citizen Solutions Inc. was dissolved. In January, 2012, Citizen Solutions LLC was formed and I am not an officer, principle, or employee of it. I have no authority to write checks or sign contracts or to hire or fire vendors. I receive no income from it. I have no authority whatsoever in the organization.

I took on the challenge of doing I-517 exactly because I had nothing else to work on, nothing else to do.

From almost 20 years in the industry, both in Washington and other states, I know most all the veteran coordinators and petitioners who come here each season to collect signatures. And they know me. I used my own money to print up petitions for I-517 because I firmly believe it's going to make the initiative process better for everyone. I saw no reason why anyone in the industry wouldn't want to carry I-517 petitions and ask every voter who signed R-74, I-1185, and I-1240 petitions to sign I-517 too. I strongly urged as many of them as possible to do so after explaining the merits of I-517 and providing them with the paper I'd paid for. Some did, some didn't. There was never any negative repercussions to any of them if they didn't because I didn't have the authority to do anything if they didn't. My spontaneous and often bombastic, over-the-top pleas were made with raw unadulterated enthusiasm, which for people who know me is expected. Saying things like "*petitioners who didn't get on board should be stoned to death in public squares ... or I would run them over with my walker*" was simply my way of conveying my deep personal passion I feel for this issue. I take it not only as a personal betrayal, but as an unpatriotic act, when a person who takes money from the system gives me the finger when asked to do the tiniest little thing to help make the system better for everyone. Whether it's my personality flaw or personality strength, it's the same as it's been for over 15 years. Everybody knows me as a cantankerous son of a B.

My email exchange with Steve Burdick is two people who've known each other for 10 years busting each other's balls -- as they have for years -- nothing more. Steve wasn't contracted by me, didn't work for me, and couldn't be fired or let go by me. In fact, he didn't work for Citizen Solutions and wasn't even a subcontractor for Citizen Solutions. He knew at the time I was simply ranting and raving. Steve got signatures intermittingly

on 517, of his own free will and as late as July 2012 was asking me to get him more paper to continue to work on 517. Exactly because I couldn't actually fire Steve is what allowed me to say it with a clear conscience.

The email by Rick Walther is pure fantasy. Rick works for himself as owner of a signature management firm. Rick had a signed contract with Citizen Solutions LLC for collecting signatures for I-1185. It was made crystal clear, both in the written contract itself and in subsequent communications, that it was for only I-1185:

I witnessed Rick throw a fit and quit when the work he had done on I-1185 was rejected as below standard. When he and his petitioners' validity rate for signatures on I-1185 fell below the minimum threshold in early May, he complained about it and left a voicemail at Citizen Solutions saying he quit. The firm sent him a termination notice immediately. When his attempt to un-quit himself was unsuccessful - he threatened to somehow get unemployment or make some sort of claim with Labor and Industries to get his revenge. I don't believe his attempts to do so have been successful. He now has a new avenue to spread his hatred.

As my August 27th email to Tim explains: *"Let me close by saying unequivocally that payments to Citizen Solutions LLC for I-1185 only went to pay for I-1185 signatures; payments made to Progressive Consultants Inc for I-1240 only went to pay for I-1240 signatures; and payments to Fourth Branch LLC for R-74 only went to pay for R-74 signatures. These signature firms only paid subcontracted vendors to fulfill their respective contracts for signatures. Some of those subcontracted vendors used their own money to provide an extra incentive for the collection of I-517 signatures. Any claim that any PACs' money was used for I-517 signatures is complete nonsense."*

As for not reporting the in-kind assistance that the I-517 signature drive has received from the I-514 people (marijuana), I have yet to receive any I-517 signatures from them so there's nothing to report. The deadline for filing the signatures is not until January, 2013. When and if they turn in any signatures, either to me or to Paul Jacob's group, they can be reported.

My name is Eddie Agazarm and I'm responding to a request from Tim Eyman to contact you concerning the I-517 signature drive.

I've been petitioning for decades in Washington and in other states. Up until having a severe stroke in May of last year, I was one of the officers of the paid signature gathering firm Citizen Solutions Inc. I retired in 2011 due to my diminished health and resulting disabilities.

Nonetheless, I am doing all I can to get enough voter signatures to qualify Initiative 517.

As you can see in my email exchange with Tim earlier this year (reprinted below), I pushed hard to have him file it because I believe in it and want it to succeed. It's my last hurrah, my final effort. I think it'll make Washington's initiative process a lot better, a lot safer, a lot cheaper. And I might leave the initiative process better off than I found it. Since it is an initiative to the legislature, I have until the end of December to collect the required number of signatures.

After getting the PDF of the petition, I have used my own money to pay for the printing of I-517 petitions and recently paid for travel expenses for some petitioners. For the past several months, I've contacted petitioners and coordinators for other initiatives and asked them to carry I-517 petitions. There have been several initiative campaigns going on at the state and local level this year and so I've had some success even though I've not had money to pay them.

In mid-July, I contacted a longtime friend, Paul Jacob, a fellow initiative activist, and told him about I-517 and

asked for his help. He later agreed. His group, Citizens In Charge, recently joined the effort and began paying petitioners for collecting voter signatures for I-517.

Last week, Tim emailed me and asked me how many I-517 signatures I had. I counted them over the weekend and earlier today sent him an email with the quantity and the fair market value for the signatures.

Why am I working so hard on this? Because I-517 makes it safer to collect signatures by deterring petitioner harassment. Because extending the time for signature collection gives grassroots initiative campaigns a better chance to qualify. Because guaranteeing the people's right to vote on initiatives that qualify for the ballot stops frivolous pre-election lawsuits. Over the years, I've fought hard against the Legislature's non-stop efforts to inhibit the process with anti-initiative bills. For a change, I want the chance to push policies that will truly improve and reform the initiative process in a positive way. A way that levels the playing field and makes it easy for citizens to participate in our citizens' initiative process.

I frankly don't know if I'll succeed with I-517's signature drive. Some professional petitioners and their allies have been trying to sabotage my efforts because they see I-517 - specifically its' extension of time to collect signatures -- as a threat to their jobs. Their rational being that easier signatures means less money for them. I believe they are being shortsighted and selfish. I-517 makes the process better for everyone.

Again, I don't know if I'll make it but I am trying my best, pulling out all the stops because I want the voters to get the chance to vote on it.

Kindly forgive my delayed response to your request for confirmation of contributions dated Oct 14. I have been working out of town for two months, and did not retrieve my mail until Nov 30<sup>th</sup>.

As I was not compensated for work on I-517, I did not preserve a record of the signatures submitted. If memory serves, the totals submitted were, while somewhat lower, consistently comparable to its companion measure I-1085.

My records indicate that I submitted roughly 5700 signatures on I-1085. When I use that total as a metric; a good faith estimate would fall somewhere between 4,000 to 5,000 signatures.

My memory regarding this is, at best, vague. I would have greater confidence in the totals you have been provided by the proponent.

**TP:** What does Tim invoice Citizen Solutions for, and what does Citizen Solutions pay Tim for?

**EA:** In the past, I can't tell you for sure on this one because it was 2012, but in the past, 2011 and sooner (sic) we have gotten an invoice or two from Tim for consulting. For his consulting business.

**TP:** And what services does Tim provide Citizen Solutions?

**EA:** Consulting.

**TP:** And what does that entail, in this case?

**EA:** Everything you can imagine from the petition business. The drafting of petitions, helping get the clients hooked up, when things can start, when things can't start. That kind of thing.

**TP:** During your time when you were an officer and a co-owner of Citizen Solutions, how long did you have that sort of arrangement with Tim?

**EA:** It wasn't really an arrangement. It depends on if he did a lot of work, and felt he was due some money for all the work he did for us. All the way from the beginning, we could have gotten an invoice from him. But it wasn't every year, it wasn't every thing, it wasn't every drive.

**TP:** How much is he typically paid, when he is paid?

**EA:** Anywhere from \$5,000 to \$100,000.

*(EA states that Tim has a business that the payments go to: "Tim Eyman Consulting," or something similar.)*

**EA:** Tim's asking for his initiative pay, or probably his pay on his initiative, and I'm telling him, or them guys, you know, 'Calm down.' Probably that's what it is.

*(EA states he does not have copy of any invoice from Tim, meaning we would have to get them from Citizen Solutions, or from Tim.)*

**EA:** [Tim] was angling to get paid earlier, right there in that letter.

*(Discussing nature of "partnership" described in July 8, 2012 email exchange)*

**EA:** Tim and I and William and Roy and I had discussed at one time, Tim becoming a partner in Citizen Solutions. But that's been, probably for that reason, never discussed again.

**PS:** What do you think [Paul Jacob was expecting a payment from Tim] for?

**EA:** Maybe for consulting.

*(Discussing the "something" Tim was working on with Paul Jacob that could result in some national recognition.)*

**EA:** I would think it would be 517, but I cannot say that on firsthand knowledge. So I'm speculating that it was 517, but it could also be other things.

**TP:** What would they be working on together that Tim would be reluctant to explain to Roy Ruffino?

**EA:** 517.

**TP:** Why would he be reluctant to explain that?

**EA:** Roy doesn't have anything to do with 517. Roy didn't like 517. If Tim wanted to get paid to hurry up and help 517, or anything to do with 517, Roy wouldn't...Roy was like, "no on 517" the whole time.

**TP:** In his email, Tim connects Paul Jacob's expected payment with payments to petitioners...

**EA:** Here's what I think. Some of the petitioners wanted...because 1185 was done. Some of the petitioners left. Some of the petitioners were waiting to get paid, they'd wait around. Normally, if you're finished with a drive, you've got to wait for your last paycheck. And there's nothing to do. So they're waiting to get paid on 1185, saying that they could go to work on 517, if you guys are going to start to pay. In the meantime I could work it on speculation. Speculation means that they go to work and get signatures, hoping—speculating—that they would get paid later.

**TP:** Was Tim promising to pay Paul Jacob so that Paul could use those funds to sponsor signature gathering?

**EA:** No, Tim was paying Paul to be a consultant on the 517 drive. That's what I think.

**TP:** So Paul Jacob was being compensated for something in connection with the 517 drive.

**EA:** I think so. ... It makes sense ... Because Paul's a consultant. ... He goes around and helps signature drives, helps you get money for your signature drive, does that everywhere, everywhere, for lots of groups.

*(Discussing whether EA knows the amount of the invoices Tim submitted at the close of the 1185 campaign.)*

**EA:** I might have known at one time. But now I do not.

**TP:** Do you believe that Paul Jacob used money received from Tim Eyman, Citizen Solutions, or any other source to sponsor 517 signatures?

**EA:** I know they didn't receive any money from Citizen Solutions. At all. But where they got their money—Paul gets his money, he may have gotten some of his money from Tim, as a startup. Who knows? But he has a lot of contacts. He does this around the country.

...I told Paul, since he was on the East Coast, I would get his signatures in, and then I would call him up and tell him, "You've got these signatures in from Joe, and these from whoever, and so you can pay them for their signatures. They're here. So that he wasn't paying for signatures he didn't know—make-believe signatures.

**TP:** Does Tim Eyman receive a commission for the business he sends to Citizen Solutions?

**EA:** In my time with Citizen Solutions, he never received a commission.

**TP:** Does he receive any kind of fee or payment?

**EA:** He gets a consultant fee.

**TP:** And is part of his services that he renders generating business for Citizen Solutions?

**EA:** Part of it, yeah.

**TP:** And does get that consulting fee when it's his own initiative that Citizen Solutions is working on?

**EA:** I don't know.

**TP:** You don't know. Has that ever happened?

**EA:** Because I don't know if it's, when you say "his own initiative."

**TP:** Like 1185, for example. He was submitting invoices at the close of the 1185 campaign.

**EA:** William doesn't pay anybody for anything.

**TP** (quoting William Agazarm, in Exhibit E): "While you are trying to avoid telling Roy exactly what the funds are for, you could always tell him you are working on 'something' with Paul Jacobs and hoping to grow some national recognition from it." You said that you think that they might referring to the Initiative 517 campaign there, and it sounds like William is talking about securing funds from Roy that Roy doesn't know what the payment's for...Did William and Roy ever make payments to Tim Eyman that Tim used to sponsor Initiative 517 signatures?

**EA:** They made payments to Tim Eyman. What Tim did with the money, you'd have to ask Tim.

**TP:** And you don't have any knowledge of what Tim did with the money.

**EA:** I have no actual firsthand knowledge. I wouldn't be surprised if he paid Paul Jacobs to go get the money for 517.

**TP:** And what makes you say that?

**EA:** It's normal business, right?

**TP:** Explain what you mean.

**EA:** If you want to hire somebody like Paul to fund your drive, to take it over like he said he would, you might want to pay him. To retain his services. RE: **Amended** Executive Summary and Staff Recommendations Regarding Complaint and Citizen Action Letter Against Permanent Offense (a political committee), Permanent Offense, Inc., Traffic Improvement Initiative Committee, Tim Eyman, Karen Eyman, Suzanne Karr, Monte Benham, Jack Fagan and Mike Fagan

On February 6, 2002, Staff filed a formal complaint against Permanent Offense (Permanent Offense PAC), Permanent Offense, Inc., (a for profit entity), Traffic Improvement Initiative Committee and Tim Eyman to determine whether they:

1. Properly reported campaign expenditures, including the purpose of those expenditures, in accordance with RCW 42.17.080 and 42.17.090;
2. Concealed the fact that campaign funds were expended to compensate Mr. Eyman for services he performed on behalf of Permanent Offense PAC. in violation of RCW 42.17.120;
3. Used campaign funds for Mr. Eyman's personal expenses in violation of RCW 42.17.125; and
4. Established a second political committee, Permanent Offense, Inc., that failed to comply with the provisions of chapter 42.17 RCW or created Permanent Offense, Inc. as part of a political committee, Permanent Offense PAC, that failed to comply with the provisions of chapter 42.17 RCW.

Subsequent to Staff's complaint, on February 13, 2002, a citizen action letter from Richard Smith and Knoll Lowney, representing Permanently Offended, was sent to the Office of the Attorney General, who then forwarded the letter to PDC Staff for investigation. That letter alleged violations against Permanent Offense PAC, Permanent Offense, Inc, Traffic Improvement Initiative Committee, Tim Eyman, Karen Eyman and Suzanne Karr for:

1. Failing to file timely and accurate reports with the PDC for the activities of Permanent Offense PAC and Traffic Improvement Initiative Committee in violation of RCW 42.17.080 and 42.17.090;
2. Making expenditures in such a manner so as to effect concealment in violation of RCW 42.17.120; and
3. Using campaign contributions for personal expenses in violation of RCW 42.17.125.

Mssrs. Smith and Lowney sent a second letter, also received February 13, 2002, to the Office of the Attorney General alleging that Monte Benham, Jack Fagan and Mike Fagan also violated RCW 42.17.

Staff has concluded a preliminary investigation into all of the allegations.

## **Summary of Findings and Alleged Apparent Violations**

Permanent Offense PAC was formed in 2000 to support Initiatives 710, 711 and 722. Of these, only Initiative 722 qualified for the ballot. Permanent Offense PAC later supported Initiative 747 (2001), which also qualified for the ballot. In 2002, Permanent Offense PAC is supporting Initiative 776, and is currently attempting to obtain sufficient voter signatures to place the measure on the ballot this fall.

### **Concealment of Campaign Expenditures – RCW 42.17.120**

The investigation revealed that Tim Eyman and Suzanne Karr created Permanent Offense, Inc. as a Sub Chapter S Corporation on February 18, 2000. At that time, Tim Eyman was 51% owner and Suzanne Karr 49% owner. All profits of a Sub Chapter S Corporation must be claimed as income by the owners at the end of each calendar or fiscal year.

Staff maintains, based on documents received during the investigation, that Mr. Eyman and Ms. Karr violated RCW 42.17.120 when they used Permanent Offense, Inc. to conceal compensation paid to Tim Eyman for services provided to the political committee.

- a) An e-mail sent from Ms. Karr to Mr. Eyman on December 16, 1999, indicates that she had spoken with Alan Gottlieb. Ms. Karr said that Mr. Gottlieb told her that running money through a private organization would violate the spirit of the law and is “suicide,” and the media would eventually find out and “it will be uglier than ever.” She continued by saying that Mr. Gottlieb suggested they run all the money through PDC and pay Permanent Offense to manage the campaign like other political consulting firms do. Ms. Karr informed Mr. Eyman that if they create a corporation, that it be a for-profit entity, because if it were a non-profit entity, the salaries and expenses paid to principals would have to be disclosed. (See Report of Investigation, page 11)
- b) An e-mail sent from Ms. Karr to Mr. Eyman on January 2, 2000, discussed assets of Permanent Offense PAC. She continued with discussions about the creation of a separate corporation. She stated: “As you said, the company will exist as an accounting entity to transfer funds to you.” (See Report of Investigation, page 12)
- c) Mr. Eyman sent Ms. Karr an e-mail on January 30, 2000, in which he said that he wanted to begin the official payment to Permanent Offense Inc. by both initiatives (Permanent Offense PAC and Traffic Improvement Initiative Committee). He stated that: “My goal is from January 1, 2000 to December 31, 2000, that Permanent Offense will distribute to Tim a total of \$100,000 over and above expense reimbursement... We can keep the disbursements steady throughout or start out smaller and spike it after the signatures are submitted, whatever keeps our reserves adequate to accomplish our goals.” (See Report of Investigation, page 13)
- d) After the corporation was created, Ms. Karr sent Mr. Eyman an e-mail, dated March 10, 2000, in which she stated: “This is our first C4 with the Permanent Offense payments, so we will see if we get any flack about it... If you get questioned you can continue to refer them to me. I plan to say that we just got too big to be able to operate on a volunteer basis. We have to create some kind of professional organization if we plan to continue to operate the way we have & that requires money.” (See Report of Investigation, page 13)
- e) In a February 3, 2002 Associated Press article, Tim Eyman was quoted as saying: “Permanent Offense Inc. organization was set up to have a way to cover the fact that I was making money sponsoring initiatives, and none of my co-sponsors knew that was the case.” (See Report of Investigation, page 29)
- f) On February 4, 2002, Mr. Eyman held a press conference. During the press conference, he admitted that he had lied about receiving payment or compensation for working on initiatives. Mr. Eyman had maintained over the years that he was acting as an unpaid volunteer for the initiatives. He stated to the press that “This entire charade was set up so I could maintain a moral superiority over opposition, so I could say our opponents make money from politics and I don’t.” (See Report of Investigation, page 30)

Concealment of campaign expenditures was accomplished by billing Permanent Offense PAC and Traffic Improvement Initiative Committee for “Management/Consulting Services” and other “Professional Services” and using that money to compensate Tim Eyman. Staff maintains that

falsifying reports is one way to accomplish concealment. Manipulating the system to frustrate full disclosure, to hide the truth, is another. That's what occurred in this case.

- g) In 2000, as treasurer, Suzanne Karr moved \$60,616.40 from Permanent Offense PAC and Traffic Improvement Initiative Committee to Permanent Offense, Inc. for "Management/Consulting Services" and other "Professional Services" by creating Permanent Offense, Inc. invoices and then paying them with Permanent Offense PAC funds.
- h) In 2000, Mr. Eyman was compensated as an employee \$54,141.85. As 51% shareholder, Mr. Eyman earned profits of approximately \$400. As 49% shareholder, Ms. Karr also earned profits of approximately \$400. She disputes that she was notified of this by the corporation, and did not claim this as income for tax purposes.
- i) In 2001, Tim Eyman moved \$165,491.78 from Permanent Offense PAC to Permanent Offense, Inc. for "Management/Consulting Services" and other "Professional Services" by creating Permanent Offense, Inc. invoices and then paying them with Permanent Offense PAC funds.
- j) In 2001, Mr. Eyman was compensated as an employee \$5,000.00. Although the exact amount of the profits are unknown at this time, as 100% shareholder in 2001 (Ms. Karr having severed her ownership relationship with the corporation in 2000), it is estimated the profits approximate \$150,000 based on revenue of \$165,492 and known corporate expenses of \$14,112.

**Failure to properly report campaign expenditures, including the purpose of those expenditures – RCW 42.17.080 and 42.17.090.**

During 2000, Suzanne Karr was treasurer of Permanent Offense PAC and Traffic Improvement Initiative Committee. Staff maintains that Ms. Karr violated RCW 42.17.080 and .090 when she:

- k) Failed to report in-kind contributions for management, accounting and database services received by Permanent Offense PAC and Traffic Improvement Initiative Committee from Permanent Offense, Inc. between August and November, 2000. The actual amounts are unknown; however, based on the formula Ms. Karr used when she reported the transfers of funds previously, 25% of contributions received and 8% of expenditures made, it appears that \$39,769.11 for Permanent Offense PAC and \$33,348.42 for Traffic Improvement Initiative Committee, for a total of \$73,117.53, was not reported as in-kind contributions.
- l) Failed to report "orders placed, debts and obligations" for Permanent Offense PAC and Traffic Improvement Committee. Ms. Karr stated during her interview that she never reported any orders placed, debts or obligations as they were incurred because the committees always had funds and she knew the bills would be paid eventually. She stated "I was negligent in accruing any kind of liability for any vendor, not just Permanent Offense...I was not nitpicky about accruals like I would have been in a

normal accounting system.” The amount is not currently known. This information did not come to light until Ms. Karr’s interview of March 28, 2000, and because of the time limitations placed on staff due to the citizen action letter, invoices were not reviewed.

Staff maintains that Permanent Offense PAC violated RCW 42.17.080 and .090 when it:

- m) Failed to report in-kind contributions estimated at \$39,769 for management, accounting and database services from Permanent Offense, Inc. between August and November, 2000.
- n) Failed to report “orders placed, debts and obligations.” Ms. Karr stated during her interview that she never reported any orders placed for either committee. This information did not come to light until Ms. Karr’s interview of March 28, 2000, and because of the time limitations placed on staff due to the citizen action letter, invoices were not reviewed.

Staff also maintains that in 2001, Tim Eyman and Permanent Offense PAC failed to report in-kind contributions from Permanent Offense, Inc, when it paid \$4,145 to Hawthorne & Co. between May 10, 2001 and August 13, 2001 for work performed for Permanent Offense PAC, thus violating RCW 42.17.080 and .090.

### **Use of campaign funds for personal use – RCW 42.17.125**

Staff maintains that Tim Eyman violated RCW 42.17.125 when he sought and received reimbursement from Permanent Offense PAC for expenditures not related to PAC activities. Prior to 2001, Mr. Eyman submitted reimbursement requests to Suzanne Karr, who reviewed them and paid only those that she determined were legitimate PAC expenses.

In 2001, Mr. Eyman submitted reimbursement requests to himself, and paid himself with PAC funds. In addition, Mr. Eyman paid personal expenses and those related to another business he owns (Insignia Corp.) directly out of PAC funds.

- o) During 2001, Mr. Eyman reimbursed himself with Permanent Offense PAC funds for multiple questionable expenditures, including \$11,567.32 in postage expenses with no postal service invoices. He was unable to account for postal reimbursements of \$2,800 and \$5,600, but acknowledged that these could have been for Insignia Corp. business or his personal use. In 2001, Permanent Offense PAC paid \$213.93 to Winstar, an e-mail and website service provider for Insignia Corp.
- p) In numerous instances, reimbursements had no documentation (such as invoices or receipts) other than Mr. Eyman’s notations on a typed list. For example, one receipt listed \$60 for cab fare and Mr. Eyman doubled the reimbursement amount with a handwritten notation indicating a return trip and was reimbursed \$120.

- q) Although Mr. Eyman submitted receipts for numerous other expenses, there was frequently insufficient information to determine if the expenses were for Permanent Offense PAC or for his personal business. An example is a \$1,326.46 reimbursement for printing in 2001. In one instance, Mr. Eyman submitted two separate parking receipts for the same date and time when he was attending a convention for his watch business in California.
- r) Mr. Eyman ran Permanent Offense PAC, Insignia Corp. and Permanent Offense, Inc. out of the same location. Mr. Eyman stated that he used supplies purchased by Permanent Offense PAC and Traffic Improvement Initiative for all three entities, as well as for his personal use. He also stated that he used equipment (computers, copiers, fax machines, and cell phones) purchased by Permanent Offense PAC for Insignia business and personal business.
- s) Mr. Eyman received reimbursement for automobile maintenance on a vehicle he considered the primary family vehicle. A portion of those costs should have been paid by him personally.

### **Failure to keep campaign records - RCW 42.17.065**

Staff maintains that in 2001 Tim Eyman and Permanent Offense PAC violated RCW 42.17.065 when they failed to keep adequate campaign records, including documentation for reimbursements for phone bills, postage, and mileage expenses. Receipts for reimbursements paid to Tim Eyman were not detailed enough to determine the purpose of the expenditure. For example, the front page of a phone bill was included in the records, but the attachments showing each number called was not included. A credit card receipt was included for postage reimbursement, but no receipt from the post office was included.

### **Failure to designate and report Tim Eyman as Treasurer of Permanent Offense PAC– RCW 42.17.040 and .050**

During 2001, Karen Eyman was designated as treasurer of record and signed reports. However, the evidence suggests that Ms. Eyman did not initiate, authorize or approve campaign expenditures for Permanent Offense PAC, nor did she review reports filed by Permanent Offense PAC for accuracy or completeness. Evidence obtained during the investigation indicated that Tim Eyman had sole control of all financial aspects of the campaign, including the checkbook, and that he initiated, authorized or approved all campaign expenditures.

Staff maintains that Permanent Offense PAC violated RCW 42.17.050 when it failed to designate Tim Eyman as campaign treasurer.

Staff maintains that Permanent Offense PAC violated RCW 42.17.040 when it failed to amend its Committee Registration Statement showing Tim Eyman as treasurer.

### **Reimbursement for a contribution – RCW 42.17.780**

Staff maintains that Tim Eyman and Permanent Offense PAC violated RCW 42.17.780 when they reimbursed Tim Eyman for the following contributions:

- t) \$500 to the Republican National Committee on August 24, 2000 and
- u) \$60 to the No on I-747 Committee on October 26, 2001.

### **Monte Benham, Mike Fagan and Jack Fagan –**

The investigation revealed no evidence that these individuals acted in a way to effect concealment, or that they personally violated the provisions of chapter 42.17 RCW.

### **Karen Eyman -**

The investigation revealed no evidence that Karen Eyman acted in a way to effect concealment, or that she personally violated the provisions of chapter 42.17 RCW. However, she did sign reports as treasurer that contained information related to the transfer of funds from Permanent Offense PAC to Permanent Offense, Inc.

### **Summary**

Staff recommends the Commission find **Tim Eyman** in apparent violations of the following provisions:

- RCW 42.17.120 by concealing compensation paid to himself from Permanent Offense PAC through Permanent Offense, Inc. for services he provided to Permanent Offense PAC;
- RCW 42.17.125 by using Permanent Offense PAC campaign funds to pay expenses for Insignia Corp., as well as his own personal expenses;
- RCW 42.17.065 by failing to keep adequate campaign records to substantiate reimbursements to himself;
- RCW 42.17.080 and .090 by failing to report in-kind contributions Permanent Offense Inc. provided to Permanent Offense PAC;
- RCW 42.17.780 by reimbursing himself with Permanent Offense PAC funds for campaign contributions.

Staff recommends the Commission find **Suzanne Karr** in apparent violations of the following provisions:

- RCW 42.17.120 by concealing compensation paid to Tim Eyman from Permanent Offense PAC through Permanent Offense, Inc. for services he provided to Permanent Offense PAC;



- RCW 42.17.080 and .090 by failing to report in-kind contributions Permanent Offense Inc. provided to Permanent Offense PAC, and by failing to report orders placed, debts and obligations for Permanent Offense PAC and Traffic Improvement Initiative Committee; and

Staff recommends the Commission find **Permanent Offense PAC** in apparent violations of the following provisions:

- RCW 42.17.080 and .090 by failing to report in-kind contributions Permanent Offense Inc. provided to Permanent Offense PAC, and by failing to report orders placed, debts and obligations;
- RCW 42.17.065 by failing to keep adequate campaign records to substantiate reimbursements to Tim Eyman;
- RCW 42.17.040 and .050 by failing to designate and report Tim Eyman as its treasurer; and
- RCW 42.17.780 by reimbursing Tim Eyman for campaign contributions.

If apparent violations are found, staff recommends that the Commission refer the matters to the Office of the Attorney General for further action.

Regarding Monte Benham, Jack Fagan, Mike Fagan and Karen Eyman (individuals listed in the citizen action letter), staff requests that the Commission recommend that the Office of the Attorney General take no further action.

Regarding Traffic Improvement Initiative Committee, staff is withdrawing its allegations and recommends the Commission advise the Office of the Attorney General to take no further action regarding this committee (since the committee filed its final report on December 11, 2000.)

Staff is withdrawing its allegation (#4) regarding Permanent Offense Inc. failing to register and report as a political committee.

EXAMINATION

BY MR. PERKINS:

Q So to begin with, Mr. Eyman, I'm going to give you copies of three documents, and I have copies for Mark as well. And I will describe them. These are a letter from PDC Director of Compliance, Phil Stutzman, dated November 8, 2013; a subpoena duces tecum dated December 16, 2013; and a subpoena PDC staff provided to you on June 30, 2014, for this interview.

Have you recently reviewed these documents? If not, feel free to take a moment to look through them. They outline what we're about here today.

Our first questions in the interview are going --

MR. LAMB: I'm not sure he's done.

Q Please take your time. I'm sorry.

MR. LAMB: I only said that because I wasn't done.

Q These are all, of course, documents that have been sent to you previously.

MR. LAMB: And, Tony, I am just going to reiterate what I said that Mr. Eyman has the same request as Mr. Ruffino, that any requests just be sent directly to my office and not to his home.

MR. PERKINS: Okay. I accept that.

A And this is the most recent one, the one at the bottom?

1 Q Mm-hmm, June 30th.

2 A Okay.

3 Q So my first questions are going to be background sort  
4 of questions. The answers may seem obvious, but just  
5 give me a concise and full response and we'll move onto  
6 the more substantive questions. These just have to do  
7 with how initiatives get qualified for the ballot in  
8 Washington and who the players are.

9 Do you know Roy Ruffino, Edward Agazarm and  
10 William Agazarm, and, if so, please explain how you  
11 know them.

12 A Yes, I know them and I have worked with them.

13 Q Okay. In what capacity?

14 A On initiatives.

15 Q Okay. With what company are they associated?

16 A At various times each of them have participated with  
17 Citizen Solutions, various versions of it.

18 Q Okay. Of those three individuals, who do you know the  
19 best and with whom have you worked the longest?

20 A Equal amount of time between Eddie and Roy.

21 Q Okay. And the answer may seem obvious, but what does  
22 Citizen Solutions do for your initiative committees?

23 A Our PACs contract with them to contract with other  
24 people to collect signatures for initiative petitions.

25 Q And when did you first begin that business relationship



1 with Citizen Solutions?

2 MR. LAMB: I am going to ask you to clarify,  
3 Tony, when you say "you," you're talking about the  
4 initiative committees?

5 MR. PERKINS: Yeah, any committee that he's  
6 associated with or has founded.

7 A Awhile. I think it was 2003.

8 Q Okay. Does Citizen Solutions charge you for its  
9 services?

10 A Citizen Solutions sends invoices to our PAC.

11 Q Okay. And how are payments made to Citizen Solutions?

12 A From Spokane and where our PAC is based.

13 Q You testified a moment ago that Citizen Solutions does  
14 or has provided invoices to your committees; is that  
15 correct?

16 A Yes, sometimes in writing and sometimes just verbally.

17 Q Okay. Do you enter into a contract with Citizen  
18 Solutions for each campaign?

19 A We've normally just approached them about a project  
20 once it's filed and discuss the details of it verbally.

21 Q Okay. You have provided documents to PDC staff  
22 including emails that did have proposed contracts  
23 attached to them between your committees and Citizen  
24 Solutions and I will give you an example. In the  
25 context of the 1185 campaign, a proposed contract was

1 sent to you by Eddie Agazarm with instructions to  
2 finalize it and either sign, scan, and email or mail  
3 through postal delivery to William Agazarm, who at that  
4 time was living in Utah. Can you tell me whether in  
5 the case of Initiative 1185 there was a contract  
6 completed and, if so, who signed it for your committee  
7 and who signed it for Mr. Agazarm's company?

8 A I don't remember ever finalizing a contract. I may  
9 have, but I don't remember doing it.

10 Q Okay. Who would have a copy of that contract if one  
11 had been finalized?

12 A I don't know at this stage.

13 Q Okay. Who keeps the business records for Voters Want  
14 More Choices?

15 A That would be Jack and Mike Fagan in Spokane. I live  
16 in Mukilteo.

17 Q Okay. Is it fair to say that you don't have a copy of  
18 any contract?

19 A That is correct.

20 Q Okay.

21 MR. LAMB: Just to clarify, this may seem  
22 really redundant, I think he provided you a copy of the  
23 draft contract. You were talking about an executed  
24 contract.

25 THE WITNESS: Oh, yes. Thank you. I

1 apologize.

2 MR. LAMB: I just wanted to clarify for the  
3 record.

4 Q That's fine.

5 A And to clarify, you said those were drafts, right?

6 Q Correct.

7 A Okay, yeah.

8 Q Tim, have you ever provided an invoice to Citizen  
9 Solutions seeking payment?

10 A Yes.

11 Q Did that invoice come from you personally or from a  
12 business or political committee or any entity with  
13 which you're associated?

14 A It was an invoice from my LLC.

15 Q And what's the name of that LLC?

16 A Tim Eyman, Watchdog for Taxpayers, LLC.

17 Q Okay. Have you ever provided any other invoice or  
18 request for payment personally to Citizen Solutions?  
19 Have any of your political committees, maybe your  
20 business Insignia Corporation, has any other person or  
21 entity sought payment from Citizen Solutions on your  
22 behalf?

23 MR. LAMB: So to be clear, and Tony, it will  
24 be something like the last time in that I will say this  
25 once and just kind of clarify it, but my belief as

1 Mr. Eyman's counsel is that the questions he can be  
2 asked are from 2009 forward about his relationship with  
3 Citizen Solutions. It's very important, Tim, for you  
4 to understand when he is asking you a question, there  
5 was Citizen Solutions, Inc., and there is Citizen  
6 Solutions, LLC. As your counsel, I direct you not to  
7 answer any questions prior to 2009 about Citizen  
8 Solutions, Inc., because Citizen Solutions, LLC, did  
9 not exist. So I understand Tony can state that he  
10 disagrees with that. That's my direction to you as  
11 your counsel, so when you're answering that question,  
12 answer for Citizen Solutions, Inc., for that time  
13 period and then answer for Citizen Solutions, LLC.

14 MR. PERKINS: And I'm sorry, if I could  
15 interrupt before you provide your answer. What Mark  
16 wasn't explicit about, but that I would like to get on  
17 the record, is his sense the questions that pertain to  
18 activities outside the PDC's statute of limitations are  
19 out of bounds in this interview. Do I understand you  
20 correctly? Is that the reason why you identified the  
21 year 2009?

22 MR. LAMB: You did.

23 MR. PERKINS: As I said previously, the PDC,  
24 of course, can only act on violations within the  
25 statute of limitations, but in an investigative

1 proceeding, we seek information that helps us to  
2 dispose of allegations one way or the other. A good  
3 example is to ask questions that document patterns and  
4 practices in business affairs. Those facts hold true  
5 outside of any statutory limitation on actions. That's  
6 why we ask those questions, to develop a set of facts  
7 for the record, and that's why we're asking all of  
8 these questions here today. We understand what our  
9 scope of authority is and what we can take action on  
10 and what we can't.

11 So I'm going to continue to ask some questions  
12 that speak to facts older than five years, but I want  
13 to underline my understanding that, of course, we do  
14 operate under a statute of limitations.

15 Q So my question again, Tim, was did any entity in  
16 addition to Tim Eyman, Watchdog for Taxpayers, LLC,  
17 ever provide an invoice or request for payment to  
18 Citizen Solutions, LLC, or prior to 2012, Citizen  
19 Solutions, Incorporated?

20 MR. LAMB: And I would reiterate that for my  
21 purposes, I'm directing you to answer that question  
22 from 2009 going forward.

23 A As per Mark's point, the answer is no.

24 Q Okay. And are you aware of information that would  
25 speak to our question prior to 2009, but are choosing

1 not to share it?

2 MR. LAMB: I'm going to direct him not to  
3 answer because it's a different -- I admire your  
4 cleverness, but that's a different way of asking the  
5 same question.

6 MR. PERKINS: Well, he could respond in the  
7 affirmative or negative. I mean, he either is aware or  
8 not. He is not telling me the contents.

9 MR. LAMB: I'm directing him not to answer.  
10 I respect you asking the question and I'm going to ask  
11 you to respect me asking him not to answer it.

12 And just to be clear, the last question you were  
13 asked was, you were saying -- you have described there  
14 was one payment from Citizen Solutions to your LLC and  
15 we were talking about payments other than that was --

16 MR. PERKINS: And in fact, I don't think that  
17 Tim has established whether there was only one. That  
18 was my next question.

19 MR. LAMB: Yes.

20 Q Has Citizen Solutions, Incorporated, or Citizen  
21 Solutions, LLC, ever made a payment to you or to any  
22 business or political committee with which you're  
23 associated?

24 A As per Mark's clarification of the situation, no.

25 Q So that includes from 2009 to the present?

1                   MR. LAMB: You mean other than the one.

2 A Other than, yeah. No.

3 Q Okay.

4 A Right.

5 Q Did Citizen Solutions -- well, I guess I should ask  
6 this in a broader sense. Has Citizen Solutions made a  
7 payment to Tim Eyman, Watchdog for Taxpayers, LLC?

8 A Would you please repeat the question for me.

9 Q Has Citizen Solutions, Incorporated, or Citizen  
10 Solutions, LLC, made any payments to Tim Eyman,  
11 Watchdog for Taxpayers, LLC?

12 A Yes.

13 Q Describe those payments.

14 A Describe those payments.

15 Q Beginning with the amount.

16 A Well, I was paid --

17                   MR. LAMB: He asked beginning with the  
18 amount.

19 A I apologize. Okay. I don't remember the exact dollar  
20 amount, but it was a little over \$300,000.

21 Q Okay. Did that come in one payment or multiple  
22 payments?

23 A One payment.

24 Q And when was it made?

25 A I don't remember the exact date, but it was in July of

1 2012.

2 Q Okay. Next I'm going to show you an exhibit that we've  
3 marked as Exhibit A, and this is an email that we  
4 received from you, Tim. And if you would review it,  
5 it's an exchange on July 8th of 2012 between you,  
6 William Agazarm and Edward Agazarm. If you'd review it  
7 beginning with the originating email in the middle of  
8 page 2. I'll give you a couple minutes.

9 A Okay. Okay.

10 Q When in relation to this email exchange on July 8,  
11 2012, was the approximately \$300,000 payment to Tim  
12 Eyman, Watchdog for Taxpayers, LLC?

13 A After.

14 Q Is that payment the one that's being discussed in this  
15 email exchange?

16 A Which part of the email?

17 Q Well, your originating email apparently had an invoice  
18 attached and a letter dated June 9th. You discuss a  
19 payment and there's some general discussion around that  
20 payment, which we'll get to. I'm going to ask you the  
21 purpose of the payment in just a moment, but can you  
22 establish, looking at this email exchange, that it was  
23 at this time and in these conversations with, for  
24 example, William Agazarm and in drawing up the invoice  
25 that was attached to this email that you were seeking



1 that payment of approximately \$300,000, or are we  
2 talking about separate and distinct payments?

3 A I had met with William in late June when he was in town  
4 and discussed a future business arrangement and we were  
5 still working out details on how that would be done,  
6 and there were discussions after these emails as well.

7 Q And what was the nature of that business arrangement  
8 that you were discussing?

9 A My LLC, my business was paid to secure future clients  
10 and projects for Citizen Solutions, and I have secured  
11 clients and projects for them pursuant to the  
12 agreement.

13 Q Okay. How were you expected to go about that? Was the  
14 intent that you would nurture relationships, make  
15 contacts, pitch the services of Citizen Solutions to  
16 people in politics; what was supposed to happen?

17 A That I would advise and assist Citizen Solutions in  
18 securing future clients.

19 Q Okay. Was there a written agreement as to the services  
20 that you would provide to Citizen Solutions?

21 A I believe there were some drafts, but it ended up being  
22 an oral agreement.

23 Q Okay. Did you retain those drafts?

24 A No, I did not.

25 Q You did not. Who were those drafts being circulated

1 among? Were you going over them with William Agazarm,  
2 with Roy Ruffino, with Edward Agazarm?

3 A The only one I remember are the ones that are  
4 referenced in the first email on July 8th.

5 Q Based on what you've described as an oral agreement,  
6 what were its terms? Did it go forward to a particular  
7 time span, did it compensate you for past activity?

8 A It was oral, but it was basically understood I would  
9 get 100,000 a year for three years to secure future  
10 clients for them and moving forward and they would  
11 benefit from me helping them secure future clients  
12 based on my, how do you phrase this, experience doing  
13 initiatives.

14 Q Okay. So 100,000 a year, but I understand you received  
15 a single payment of 300,000. Explain how that  
16 occurred.

17 A It's what we negotiated. There were options there  
18 would be paid more over a longer period of time, but we  
19 settled on a smaller amount all at once.

20 Q Okay. Did the payment compensate you for any services  
21 rendered in the past?

22 A No. It was for securing future clients.

23 Q Okay. We'll return to that arrangement and the  
24 services there that you've just described in a moment,  
25 but I have some other questions.

1           Going backwards, how long have you been  
2           submitting invoices to Citizen Solutions or seeking  
3           payment from them for any reason?

4           MR. LAMB: And, again, I'm going to have the  
5           same qualifier of I am directing you to answer the  
6           question only from 2009 forward and to clarify whether  
7           it's Inc. or LLC.

8   A   Invoices for their services came from Spokane and --

9   Q   You may have misunderstood me.

10   A   I apologize.

11   Q   What I asked was how long you have been submitting  
12       invoices or requests for payments to Citizen  
13       Solutions

14   A   Only that time.

15   Q   Okay.

16   A   Of July of 2012.

17   Q   Okay. In this email exchange that we have identified  
18       as Exhibit A, there was apparently an invoice attached  
19       to the originating email and then in a response, Edward  
20       Agazarm indicates that you had recently submitted an  
21       invoice. Do you recall whether those were for  
22       different amounts, different services or a duplicate  
23       billing or what the distinction was between those two  
24       invoices?

25   A   I think I reference in the email that these are drafts,

1 so I don't remember what the difference was between  
2 this, whether or not the -- I mean, drafts have errors  
3 in them, so I don't know what the final one was.

4 Q Okay. So we have received testimony from Edward  
5 Agazarm that going backwards almost to the beginning of  
6 your business relationship with Citizen Solutions, that  
7 you have sought and received payments from Citizen  
8 Solutions and that those have ranged from \$5,000 up to  
9 \$100,000. Is that accurate? Do you dispute it?

10 MR. LAMB: I am directing my client not to  
11 answer that question to the extent it involves events  
12 prior to 2009.

13 Q Is there an answer to that question for the period 2009  
14 going forward that you haven't shared with us?

15 MR. LAMB: I'll allow you to answer that  
16 question.

17 A No.

18 Q I think I would like to get on the record, Tim, it's  
19 helpful if we get it in the respondent or in the  
20 subject's own voice and own words whether you would  
21 answer that question. So I am going to rephrase it  
22 again and not belabor this and we'll move on quickly,  
23 but we have received testimony from Edward Agazarm, who  
24 prior to 2012 was a partner in Citizen Solutions, that  
25 his company received requests for payment from you and

1 made payment to you ranging from 5 to \$100,000 dating  
2 almost all the way back to the beginnings of your  
3 business.

4 Will you answer whether that's accurate and  
5 provide more details of those payments?

6 MR. LAMB: On the advice of his counsel, he  
7 is not going to answer that question.

8 MR. PERKINS: I would like to hear it from  
9 Tim and then we can move on.

10 A Mark is my attorney.

11 MR. LAMB: And he is following his attorney's  
12 direction.

13 Q I would like a verbal answer from Tim, though. All the  
14 information and responses -- I understand your counsel  
15 and it's being noted and we will move on as soon as I  
16 can get a direct answer.

17 MR. LAMB: Well, I guess I'm, and I do want  
18 this on the record, but I'm not really sure what the  
19 distinction is that you're seeking. It's obvious that  
20 Tim is represented by counsel. It's obvious that his  
21 counsel has directed him not to answer that question.  
22 He's indicated I am his counsel. Is your position that  
23 he could claim at a later date that he wasn't acting on  
24 the advice of his attorney unless you elicit a direct  
25 response from him?

1 MR. PERKINS: We want everything in the words  
2 of respondents. If Tim wants to remain silent with  
3 that question, in the interest of moving on, I'll go  
4 forward.

5 MR. LAMB: Okay. Let's do that.

6 Q Has Citizen Solutions made a payment to you at anytime  
7 other than the \$300,000 payment we've discussed now?

8 MR. LAMB: And, again, I would qualify that  
9 as from 2009 going forward.

10 A No.

11 Q I'm going to show you another exhibit, Exhibit B, and  
12 we're going to focus on the second page of Exhibit B.  
13 It's a list of committees with which you are associated  
14 where you were an officer that have reported payments  
15 to Citizen Solutions for signature gathering. We are  
16 going to focus on the ballot number and the year so  
17 that you can understand that we are talking about  
18 periods of time, and I would like you to point out for  
19 me time periods on this list where Citizen Solutions  
20 has provided payments to you or to your LLC or any  
21 entity with which you're associated.

22 MR. LAMB: So just give us a moment to look  
23 through the entire list because I think there's  
24 relevant information on both pages.

25 A I have reviewed the document. What was the question?

1 Q Can you identify on page 2 of Exhibit B the election  
2 years or initiative campaigns during or after which you  
3 received payments from Citizen Solutions?

4 MR. LAMB: Why are you limiting it to page 2?

5 MR. PERKINS: That's where we're starting at  
6 least. On the first page of Exhibit B these are all  
7 the committees in our data base that have reported  
8 expenditures on Citizen Solutions. On page 2 it's only  
9 those committees that have Tim Eyman as an officer. So  
10 I am beginning my question with just that universe.

11 A But on page 1 it has --

12 Q Your committees and other committees that have worked  
13 with Citizen Solutions.

14 A I understand. All right.

15 MR. LAMB: So the question was again, I'm  
16 sorry.

17 Q The question is look at that list and specifically the  
18 election years and the ballot proposition campaigns and  
19 tell me during or after any of these campaigns on this  
20 list, did you receive payments from Citizen Solutions  
21 or did any entity with which you're associated receive  
22 payments from Citizen Solutions?

23 MR. LAMB: That's a multiple compound  
24 question.

25 Q Let's start it with Tim personally.

1 A So my LLC received a payment in July of 2012.

2 Q Okay. Did you, your LLC, any business or committee  
3 that you're associated with, receive payments during or  
4 after the 1033 campaign in 2009?

5 MR. LAMB: I think --

6 A Could you repeat the question?

7 Q Yeah. We have described a payment that Citizen  
8 Solutions made to Tim Eyman, Watchdog for Taxpayers,  
9 LLC, in July of 2012. Were there similar payments  
10 received by you, by your LLC or any other entity  
11 before, during or after, or let's just say during or  
12 after the Initiative 1033 campaign in 2009 and then  
13 moving down the list, the Initiative 1053 campaign in  
14 2010, the Initiative 1125 campaign in 2011, just  
15 covering each of those years.

16 MR. LAMB: So I think, Tim, what I would say  
17 is answer from the period 2009 going forward and I  
18 think that will answer --

19 MR. PERKINS: That was my specific question.

20 MR. LAMB: So from 2009 to 2014, any payments  
21 that either your LLC or you received.

22 A There was the payment of July 2012 where my LLC  
23 received that payment. There weren't any others.

24 Q Okay. Thank you.

25 A Amazing how a simple question can --



1 MR. LAMB: Mind if we take a bathroom break?

2 MR. PERKINS: I'm going to pause the recorder  
3 and then we're going to go off the record.

4 (Whereupon, a recess was taken.)

5 MR. PERKINS: We are again recording and back  
6 on the record.

7 So we had just been discussing Exhibit B and the  
8 list of Tim's committees and whether during these  
9 election periods Tim had received payments from Citizen  
10 Solutions. I want to just put something on the record  
11 just to make sure that it's understood. We understand  
12 there was a payment made within the statute of  
13 limitations, it was made in July of 2012. As I think I  
14 have communicated clearly enough, we're not attempting  
15 to develop facts that would lead to alleged violations  
16 or actions on such alleged violations outside the  
17 period of the statute of limitations. We understand we  
18 can't. However, we're trying to develop facts that are  
19 relevant to activity that did fall within the statute  
20 of limitations. Now, if you're directing Tim to not  
21 answer questions that are relevant to activity that  
22 does fall within the statute of limitations, we will  
23 note that, but I want to be clear that this could only  
24 ever lead, if it does, to enforcement for the activity  
25 within the statute of limitations. Other facts are

1 relevant, but they don't constitute actionable  
2 violations.

3 MR. LAMB: Understood, and just so we're  
4 clear on the record as well, it's been my position from  
5 the inception of this investigation, that this  
6 complaint was brought not because there was a  
7 legitimate violation of public disclosure law and it  
8 was not brought by your agency, it was brought by a  
9 disgruntled former business associate of Mr. Eyman and  
10 Citizen Solutions. As a result of that, I think the  
11 purpose of her complaint was to elicit information  
12 about the business practices of Mr. Ruffino, of the  
13 Agazarms, and Mr. Eyman in an attempt to embarrass  
14 them, in an attempt to violate their right to conduct  
15 their business practices in a manner that suits them.

16 To that end, as within civil litigation, there  
17 are time periods and there are constraints on time  
18 periods that you can ask about. I don't believe that  
19 the period of time that you're asking about is  
20 relevant. I respectfully understand, and I'm not  
21 wanting to litigate this today, that you disagree with  
22 that. I'm just saying that my position is the business  
23 activities of these entities prior to 2009 is not  
24 relevant to this investigation and specifically to the  
25 complaint that was filed by Ms. Bockwinkel.

1 MR. PERKINS: Except if not having that  
2 information prevents us from understanding patterns and  
3 practice of misconduct.

4 MR. LAMB: Obviously, unfairly or fairly, I  
5 am in a position to make an assessment on that that you  
6 are not, and my assessment is that it does not impede  
7 your investigation in any way. That's why I am  
8 directing him not to answer, because I think the  
9 purpose of this complaint filed by Ms. Bockwinkel was  
10 to try to embarrass Mr. Eyman and to try and elicit  
11 business information that frankly is none of her  
12 business and none of anybody else's business.

13 MR. PERKINS: Okay. Well, your objection is  
14 noted. We'll continue.

15 Q Tim, tell me, the \$300,000 payment -- first I should  
16 back up. We have received testimony that the payment  
17 was \$308,000. Can you confirm that or are you not  
18 aware?

19 A That sounds right.

20 Q Okay. Can you tell me how the amount was calculated?

21 A By mutual agreement.

22 Q Okay. Who derived the figure of \$308,000? Why not an  
23 even three, why not 325?

24 A That's the number that William and I agreed to.

25 Q Can you explain \$308,000? I understand you agreed on

1           it.

2                       MR. LAMB: Are you talking about the fact  
3           that it was like three per year for three years? I'm  
4           trying to understand what you're asking about.

5 Q   Was \$308,000 a figure that was derived based on some  
6           calculation? What made that the number chosen?

7 A   It's the number we mutually agreed to.

8 Q   Was it based on a percentage of revenue for Citizen  
9           Solutions or a percentage that they would receive or  
10          had received in any campaign year or from any source?

11 A   No, it's the number we agreed to.

12 Q   Can you provide any more information as to why you lit  
13          on 308,000? I mean, I do understand it was the number  
14          you agreed to.

15                       MR. LAMB: Can I ask a clarifying question  
16          because I think you may be asking him something he is  
17          not understanding. I think what you are asking, Tony,  
18          is you described earlier that you had a three-year  
19          agreement for \$100,000 a year and I think what Tony is  
20          fixated on or asking about is why it wasn't \$300,000 as  
21          opposed to -- it was that extra eight. Is that what  
22          you're trying to clarify?

23 Q   Explain the extra eight, explain why it was such an odd  
24          number.

25 A   It wasn't odd to us.

1 Q Okay. You did indicate 100,000 a year for three years  
2 which adds up to 300,000. Why the difference?

3 A It's the number we agreed to.

4 Q And, again, I apologize if I have already asked this  
5 question. I am not aware that I did.

6 MR. LAMB: I'll let you know if you have.

7 Q Was there any written agreement outlining the terms of  
8 this payment, the \$308,000 payment?

9 A No.

10 Q There was no written agreement. Okay. Who decided  
11 when the payment was due?

12 A Again, you know, mutual agreement.

13 Q Okay. How was the payment made? Did you receive a  
14 check or wire transfer, direct deposit?

15 A I don't remember for sure, but I would estimate it was  
16 a wire transfer.

17 Q Okay.

18 A That sounds right.

19 Q And do you know what steps Citizen Solutions had to go  
20 through to authorize and execute that payment?

21 A No.

22 Q Did you have any dealings with Roy Ruffino regarding  
23 that payment?

24 A No. Would you ask that question again.

25 Q Did you have any contact or dealings with Roy Ruffino

1           regarding the payment we've been discussing, the  
2           \$308,000 payment?

3                       MR. LAMB: I think your answer was no.

4 A       No. No.

5 Q       Okay. And are you aware whether the payment was drawn  
6       on a business account assigned to Citizen Solutions or  
7       came from some other source?

8 A       No, I don't know.

9 Q       Okay. What did you do with the \$308,000 when it was  
10       received?

11 A       What did I do with it? Well, it was deposited in my  
12       account and subsequent to that, I loaned a portion of  
13       it to Citizens in Charge.

14 Q       And how much of it did you loan? What was the amount  
15       of your loan to Citizens in Charge?

16 A       I believe the initial amount was \$75,000 and there were  
17       subsequent loans as well.

18 Q       And how much were those subsequent loans?

19 A       I'm not as clear on the amounts. I think -- I remember  
20       distinctly the \$75,000 initial amount. I think there  
21       was a 25,000 one done soon after that and after that,  
22       it was when Citizens in Charge said would you loan us  
23       more that there were additional loans.

24 Q       And what was the total of your loans made to Citizens  
25       in Charge?

1 A I don't know the exact dollar amount, but --

2 MR. LAMB: Don't guess, but if you --

3 A Oh, okay. Well, then, I don't remember the exact  
4 dollar amount.

5 Can I estimate?

6 MR. LAMB: Yeah, you can estimate.

7 A I would estimate the total dollar amount to be a little  
8 over 190,000.

9 Q Okay. Backing up a bit, you indicated that when you  
10 received the \$308,000, you deposited it in your  
11 account. So tell me if I understand the sequence of  
12 events. The money went to Tim Eyman, Watchdog for  
13 Taxpayers, LLC. When you say you deposited it into  
14 your account, which account are you referring to?

15 A As I said earlier, the money was wire transferred to my  
16 LLC and so I never made a deposit of the money.

17 MR. LAMB: When you say deposit, you were  
18 referring to them making a wire transfer into your  
19 account.

20 A That is correct. And so the money was there.

21 MR. LAMB: That's your answer?

22 A And that's my answer.

23 Q Did you transfer those funds to any other account, for  
24 example, a personal account or any other business  
25 account that you maintained?

1 A No. The 75 -- Oh, I'm sorry.

2 MR. LAMB: No.

3 Q So the account into which the \$308,000 was wire  
4 transferred was Tim Eyman, Watchdog for Taxpayers, LLC;  
5 is that correct?

6 A That is correct.

7 Q And it went from the account of that LLC to Citizens in  
8 Charge.

9 MR. LAMB: No.

10 A No.

11 MR. LAMB: \$308,000 was wired into an  
12 account.

13 Q Thank you. I didn't mean to make that leap. The loans  
14 that we've said add up to at least 100,000 but as much  
15 possibly as 190,000.

16 A I mailed a cashier's check, so I mailed a \$75,000  
17 cashier's check to Citizens in Charge.

18 Q Okay. Were those loans to Citizens in Charge ever  
19 repaid?

20 A I believe the loan was --

21 MR. LAMB: He is asking you if they ever paid  
22 back money that you loaned to them.

23 A Yes, much of it.

24 Q Okay. How much?

25 A I don't have an exact dollar figure, but I would



1 estimate about \$70,000 so far and they're making  
2 regular payments on it.

3 Q Okay. Who is receiving the repayments?

4 A Tim Eyman, Watchdog for Taxpayers, LLC.

5 Q Did you offer the loans to Citizens in Charge or did  
6 they solicit them?

7 A I believe the loan to Citizens in Charge would build a  
8 business relationship with and credibility with Paul  
9 and Citizens in Charge, which would in turn help me  
10 fulfill my work for Citizen Solutions. I felt  
11 confident that I would be paid back and they have in  
12 fact paid back much of it.

13 Q Okay. So correct me or tell me if I have this correct.  
14 There was an initial loan of \$75,000 to Citizens in  
15 Charge. Can you state the date that that loan was  
16 made?

17 A No.

18 Q Okay. You received \$308,000 from Citizen Solutions in  
19 July. How many weeks or months later did you loan  
20 \$75,000 to Citizens in Charge?

21 MR. LAMB: I think he just testified he  
22 doesn't know.

23 Q Was it still within 2012?

24 A Yes.

25 Q Was it the following month, two months hence, three

1 months hence?

2 MR. LAMB: I don't want you to guess.

3 A I mean, I think it was soon after receiving it.

4 Q The next \$25,000 installment, was that also during 2012  
5 or was that in 2013?

6 A 2012.

7 Q Okay. Did you make other loans during 2012 to Citizens  
8 in Charge?

9 A Yes.

10 Q Did you make any loans to Citizens in Charge during  
11 2013?

12 A No.

13 Q Again, Tim Eyman, Watchdog for Taxpayers, LLC, is the  
14 entity that would have banking records that would  
15 document these loans; correct?

16 MR. LAMB: And to be precise, Tim Eyman,  
17 Watchdog for Taxpayers, LLC, is the entity that made  
18 those loans. Tim Eyman personally did not make those  
19 loans.

20 Q Sure. I am just wondering who would have records that  
21 would document these transactions.

22 A The answer is the bank.

23 MR. LAMB: It would be the LLC.

24 A The LLC.

25 MR. LAMB: If the LLC made the loans.

1 Q Is that correct?

2 A Well, the LLC made the loans, but the statements are at  
3 the bank.

4 Q Okay.

5 A I apologize. I didn't try to --

6 Q We are going to request records from the LLC, including  
7 banking records that document these transactions, so I  
8 need to establish for the record who we need to direct  
9 that request to.

10 A Okay.

11 Q Thank you. So on July 25 of 2012, Citizens in Charge  
12 began to make a series of payments for signature  
13 gathering for the Initiative 517 campaign. The  
14 committee Protect Your Right to Vote on Initiatives  
15 reported a number, a couple of dozen I think, payments  
16 for signature gathering which total up to \$182,000.  
17 Did your loans to Citizens in Charge pay for the  
18 signatures that Citizens in Charge ended up  
19 contributing as in-kind contributions to the 517  
20 effort?

21 A I am aware that Citizens in Charge made in-kind  
22 contributions to the initiative. That was obviously --

23 MR. LAMB: Be clear on which initiative.

24 A Initiative 517. And that certainly helped the  
25 initiative, but it also helped deepen my business

1 relationship with Citizens in Charge. I loaned them --  
2 to be specific, my LLC loaned Citizens in Charge money  
3 and what they did with that money afterwards I didn't  
4 have any control over that.

5 Q Did you request or suggest that they use the funds to  
6 fund signature gathering for Initiative 517?

7 A No.

8 Q In dealings with Paul Jacob, did you have any  
9 conversation about him funding initiative signature  
10 gathering for 517?

11 A Paul and Citizens in Charge were excited about the  
12 possibility of going on offense when it came to  
13 protecting initiatives. They fight nationally against  
14 restrictions on the initiative process and they saw  
15 this initiative as having a chance to go on offense  
16 rather than being on the defensive in state  
17 legislatures. I also saw it as a good opportunity for  
18 me to kind of increase my profile with Paul and  
19 Citizens in Charge and to deepen my business  
20 relationship with them because they work on a national  
21 basis and I saw a lot of opportunity there for that.

22 Q I'm going to ask you to describe what that opportunity  
23 looks like just so that we can understand it, but I  
24 just want to be clear, did Paul Jacob say what he would  
25 do with the funds that you loaned to him? Was there

1 any discussion of this money being used to support  
2 Initiative 517, any discussion whatsoever from you or  
3 from him?

4 MR. LAMB: I think that's a compound  
5 question. So I think what you're asking is did Paul  
6 Jacob indicate that he was supporting 517.

7 MR. PERKINS: That's one question, yeah. We  
8 could start there.

9 A He was extremely excited about Initiative 517. He  
10 thought it was a great initiative and wanted to be able  
11 to help it.

12 Q Okay. At the time the funds were either requested or  
13 provided to Paul Jacob and Citizens in Charge, was  
14 there any discussion of using those funds to support  
15 Initiative 517?

16 MR. LAMB: I think, I mean --

17 Q It's a very clear question. It's a very clear  
18 question.

19 A It is. I'm simply trying to figure out how to answer a  
20 yes or no question with a -- absolutely both of us  
21 discussed how we both supported Initiative 517 and he  
22 said he had many projects going on nationally and that  
23 if additional funds came in, they would be in a  
24 position to be able to help Initiative 517, but once I  
25 made the loans, I didn't have any knowledge or

1 understanding of whether or not my loans went to his  
2 other projects or whether or not he used those funds  
3 specifically for 517. I don't know --

4 MR. LAMB: You mean because he had  
5 multiple -- because you were not the only -- your loan  
6 was not the only source of income to Citizens in  
7 Charge.

8 A That's correct. That's what I was trying to convey.  
9 So I know I made loans to Citizens in Charge and after  
10 that I didn't have any control over or knowledge of how  
11 their funds are allocated.

12 Q Did you have a loan agreement with Paul Jacob or  
13 Citizens in Charge?

14 A Well --

15 Q Was there anything to document that it was a loan?

16 A I mean, it was a verbal agreement. I gave him very  
17 favorable terms because I figured by giving him really  
18 favorable terms, that that would really deepen that  
19 business relationship and that there was the strong  
20 possibility that because they work on all these other  
21 projects, that there would be the opportunity for me to  
22 fulfill my work for Citizen Solutions, which was  
23 securing future projects for them and to be able to get  
24 future clients.

25 Q But was there a written loan agreement with payment

1 terms?

2 MR. LAMB: He testified no, he said there  
3 wasn't a written agreement, there was a verbal  
4 agreement.

5 Q What were the terms of the loan then?

6 A That they would pay back the loan and they've been  
7 making regular payments and there was no interest on  
8 the loan. And, again, I would reiterate I did it  
9 because I really wanted to really kind of build a  
10 business relationship with them and I felt that this  
11 would really be frankly a good investment.

12 MR. LAMB: And he testified that roughly half  
13 the loan has been paid back.

14 A Yes, that's correct.

15 Q Okay. And when was the first payment, the first  
16 installment on that loan paid back to you?

17 A I think it started in 2013 and has been continuing  
18 since then. I don't remember the specific month.

19 Q Okay. But, again, these would be transactions that  
20 would be documented in banking records of Tim Eyman,  
21 Watchdog for Taxpayers, LLC; is that correct?

22 A Yes.

23 Q Have repayments gone to anyone else?

24 A No.

25 Q Did you request or suggest to Paul Jacob that he use

1 the funds you were loaning to him to support Initiative  
2 517?

3 MR. LAMB: I think that question has been  
4 asked and answered.

5 A I mean, he was excited to be able to support 517.

6 Q If I could interject. I think the question I asked was  
7 too vague in that I asked whether there was any  
8 discussion of it. I need to ask very directly. Did  
9 you ask or suggest to Paul Jacob or anyone at Citizens  
10 in Charge that they use the money you were loaning to  
11 them to support Initiative 517?

12 A No.

13 Q Did Paul Jacob or anyone at Citizens in Charge say that  
14 they would use the money you were loaning to them to  
15 support Initiative 517?

16 A Well, I'm certainly aware that they ended up spending  
17 money for 517. I was talking with them regularly to  
18 make sure that we were reporting as in-kind  
19 contributions the moneys that they were spending for  
20 517.

21 Q Tim, I asked a pretty specific question. Did you  
22 receive any assurances or statement, did you hear any  
23 statement from Paul Jacob or anyone that they would or  
24 planned to use the money you were loaning them to  
25 support Initiative 517 before the in-kind contributions



1           were made? If Tim could just answer that question.

2                   MR. LAMB: I think he answered the question.  
3 I think he said it was because he knew they were making  
4 payments, that he could see the payments coming from  
5 Citizens in Charge to the campaign.

6                   MR. PERKINS: Well, I see it as a separate  
7 question.

8                   MR. LAMB: So are you asking if prior to  
9 those payments, did they say we are --

10 Q           Okay. I understand these loans were being made, they  
11 were completely, almost \$190,000 or approximately that  
12 much, before the close of 2012.

13 A           Mm-hmm (witness nods head affirmatively).

14 Q           I've asked you, did you ask, request or suggest to Paul  
15 Jacob or anyone with Citizens in Charge that they use  
16 the money you were loaning to them or your LLC was  
17 loaning to them to support Initiative 517, and your  
18 response was?

19 A           No.

20 Q           Now I am asking, did Paul Jacob or anyone within  
21 Citizens in Charge state that they would use the funds  
22 you were loaning to them to support Initiative 517? If  
23 we could just get a clear answer to that question.

24 A           In our discussions he made it clear that if additional  
25 funds came in, that they would be in a position to be

1           able to help Initiative 517.

2   Q    Did he state that he was going to use your loan for any  
3           other specific purpose?

4   A    Nothing that specific, no.

5   Q    Did he state what sort of additional fund raising they  
6           needed to conduct and for what purpose?

7                   MR. LAMB:  I don't understand the question.

8                   MR. PERKINS:  I can give background.  Tim has  
9           testified that Paul Jacob said if additional funds came  
10          in, they would be in a position to support Initiative  
11          517.  I'm wondering what additional fund raising did he  
12          need to conduct.  Did he describe what its purpose was?  
13          Did he describe what other projects he was working on?

14                   MR. LAMB:  I understand.

15                   MR. PERKINS:  What his other obligations and  
16          commitments were.

17   A    I was aware of some of his other projects based on  
18          previous conversations, much centering on pension  
19          reform in other states and other initiatives he was  
20          supporting.

21   Q    Okay.  And at the time is there anything in particular  
22          you were aware of at the time?

23   A    The pension reform initiatives that he was working on.

24   Q    And where were those going on?

25   A    I don't know specifically.

1 Q Did he share any information about his financial  
2 commitments or the campaigns that he was working on,  
3 you know, the kind of dollars that he was looking at  
4 and what he needed to spend in other areas?

5 A No.

6 Q Tim, when you loaned \$190,000, or your LLC did, to Paul  
7 Jacob and Citizens in Charge and then he concurrently  
8 was making payments back to signature gathers and  
9 petition coordinators to get Initiative 517 on the  
10 ballot, did you have the sense that it was your money?

11 A Again, I was aware that they were spending their money  
12 and was checking in with them regularly to find out the  
13 amounts that they had spent each month on in-kind  
14 contributions. They asked me for additional loans  
15 during that time and I felt confident that by being  
16 responsive to those, that that would deepen my business  
17 relationship with them and that it would in turn help  
18 me moving forward as far as fulfilling my work for  
19 Citizen Solutions in getting them clients and future  
20 projects.

21 Q The specific question, though, was, is there any sense  
22 in which the money that you loaned to Citizen Solutions  
23 which then went to pay for Initiative 517 signatures  
24 was a pass-through?

25 MR. LAMB: No, I think his answer was no.

1 MR. PERKINS: I don't think I got a direct  
2 answer.

3 MR. LAMB: You did.

4 Q I understand you were seeking to build your business  
5 relationship with Citizens in Charge which would help  
6 you with your business relationship with Citizen  
7 Solutions. I'm talking about something much narrower.

8 MR. LAMB: He specifically said -- I mean, if  
9 you read back his answer, he specifically said it was  
10 their money. I mean, I think he gave you the answer to  
11 that question. He can answer it again, but if you read  
12 back the transcript, he gave you an answer to the  
13 question. He said how they used their money.

14 MR. PERKINS: Oh, their money meaning it was  
15 Citizen in Charge's money.

16 MR. LAMB: Yes. He testified that he lent  
17 the money and he had no control with what they did with  
18 the money once he lent it to them.

19 Q Okay. And so did you feel entirely confident when your  
20 committee disclosed in-kind contributions from Citizens  
21 in Charge that the disclosures were completely open and  
22 transparent even though they did not include the fact  
23 that you had ongoing loans to Citizens in Charge for  
24 the very amount that they ended up contributing to your  
25 committee?

1 MR. LAMB: I don't think he's testified to  
2 that.

3 A I believe to this day that everything was done  
4 correctly, that the in-kind contributions on a monthly  
5 basis were reported, that we were diligent making sure  
6 that those in-kind contributions were reported on time  
7 and we succeeded at that, and that my loan was exactly  
8 that, a loan, and I had every expectation that I would  
9 be paid back, but the loan was, I believe, an  
10 investment in the future in order to fulfill my  
11 obligation that I had to Citizen Solutions to secure  
12 them clients and future projects.

13 MR. LAMB: Can we take another rest room  
14 break before we go back on the record?

15 MR. PERKINS: I'm going to pause the  
16 recorder.

17 (Whereupon, a recess was taken.)

18 MR. PERKINS: We're back on the record.

19 Q Tim, I am going to draw your attention back to Exhibit  
20 A, which is an email exchange from July 8, 2012. I'm  
21 going to focus in on the email that you sent to Edward  
22 Agazarm and William Agazarm in which you stated,  
23 "Promised Paul a payment early this week so eager to  
24 follow through on that and get the ball rolling (you  
25 said some petitioners want to do it on speculation but

1 better to get them locked in early). Talked to Brian  
2 today and he'll have petitions printed tomorrow  
3 (Monday). Strike while the iron's hot."

4 Explain all of that to me.

5 A Well, as I said in the email, I had already discussed  
6 with Paul the possibility of doing a loan and I was  
7 clearly eager to get paid from Citizen Solutions and  
8 Paul was very excited about doing and supporting  
9 Initiative 517. It was an idea that he felt that they  
10 would be able to do in other states and that if we were  
11 successful with 517 in Washington, that he would be  
12 able to do it in other states, which would mean  
13 potentially using me as a consultant or using Citizen  
14 Solutions for their signature gathering. So it was  
15 clearly an effort to spur them to pay me.

16 Q Okay. So when you say, "Promised Paul a payment early  
17 this week, so eager to follow through on that and get  
18 the ball rolling (you said some petitioners want to do  
19 it on speculation but better to get them locked in  
20 early)" can you be clear which petitioners and which  
21 signature drive you're referring to?

22 A Seems pretty clear in there that that, and as the email  
23 below or the next paragraph makes clear, we are talking  
24 about 517.

25 Q Okay. Thank you. Going back down that exchange, there

1 is the email from William Agazarm where he states, "You  
2 are trying to avoid telling Roy exactly what the funds  
3 are for." Is that correct and why would that be the  
4 case?

5 A My agreement with Citizen Solutions was with William.  
6 Roy was solely focused on Initiative 1185 and wasn't  
7 privy to the conversations that I'd had with William.  
8 Again, this is all making it clear that I was sending  
9 them a draft of something and that would be presented  
10 to Roy later.

11 Q Why would it make a difference to Roy what you planned  
12 to use your money for?

13 MR. LAMB: Are you asking him to speculate on  
14 what Roy --

15 MR. PERKINS: Well, if it's accurate as  
16 William says, that Tim was trying to avoid telling Roy  
17 exactly what the funds were for, what was the  
18 impediment to telling Roy?

19 MR. LAMB: That's something William said, not  
20 something Tim said.

21 A That's exactly it. I wouldn't speculate on what  
22 William was thinking when he wrote that.

23 Q Were you in fact attempting to withhold this  
24 information from Roy Ruffino?

25 A No, not particularly. It didn't really have anything

1 to do with him. They're totally separate transactions.

2 Q So I understand that in this exchange, you're  
3 forwarding a draft invoice and letter to Eddie and  
4 William Agazarm. This isn't being circulated among  
5 Roy. Is there a reason why he wasn't involved in these  
6 consultations?

7 A The email says that I was asking them for their  
8 suggestions on it.

9 Q Okay. Why was Roy not involved from the outset?

10 A Because Roy handles the day-to-day of Citizen  
11 Solutions, and the agreement with William and I had  
12 more to do with the business side of things of taking  
13 more of Citizen Solutions national.

14 Q Okay. What was it about, or I'm sorry, can you explain  
15 to me the timing of your request for payment to Citizen  
16 Solutions. Why at this time, why in late June and  
17 early July of 2012?

18 A William was in town in late June and we were discussing  
19 business opportunities that would be mutually  
20 beneficial.

21 Q Okay. What did you do with the remainder of the  
22 \$308,000?

23 MR. LAMB: I am going to interject. If this  
24 is -- if it has to do with other business relationship  
25 that you think might reveal trade secrets or something



1           that you don't want to have public, you can ask to  
2           confer about that.

3   A    Provided for my family.

4   Q    It provided for your family?

5   A    You asked me what did I do with the money.  I said  
6           provided for my family.

7   Q    Okay.  So can you help me understand the difference  
8           between the services that you have rendered to Citizen  
9           Solutions and the services that you perform for your  
10          political committees and for which you receive officer  
11          compensation, what's the difference between those two  
12          services?

13  A    Could you repeat the question.

14  Q    Yeah.  For some years you have been reporting -- your  
15          committees have been reporting payments to you for  
16          officer compensation.  I am wondering what sort of  
17          services do you perform to receive that compensation  
18          for your committees and how is that separate from what  
19          you have been paid by Citizen Solutions to do?

20  A    Well, as I said, I was paid by Citizen Solutions to  
21          advise and assist them in securing future clients and I  
22          secured clients for them as pursuant to the agreement.  
23          The officer compensation for the PAC is letters sent to  
24          our supporters saying if you like the initiatives that  
25          we do and you appreciate our effort, please donate to

1           our compensation fund.

2   Q    Okay.  The PDC data base includes to-date one committee  
3           that has retained the services of Citizen Solutions  
4           since the 1185 campaign, and that is the Protect Our  
5           Gun Rights Committee.  Are there other clients that you  
6           have driven their way?  Are we talking about people in  
7           other jurisdictions?

8   A    Pursuant to the agreement, I'm not going to disclose  
9           those groups.

10   Q    Okay.

11                   MR. LAMB:  Tony, we're at 2:23 and I  
12           indicated that we would be available for 90 minutes.  I  
13           don't want to hold hard to that, but do you have a  
14           sense --

15                   MR. PERKINS:  Sure.  We'll wrap it up as soon  
16           as we can.

17                   MR. LAMB:  We live in the north end.

18                   MR. PERKINS:  Sure.  I will be focused and we  
19           will try to get through these as efficiently as we can.

20   Q    Tim, are Jack Fagan and Mike Fagan or Stan Long aware  
21           that you received a \$308,000 payment from Citizen  
22           Solutions?

23   A    You'd have to ask them.

24   Q    Did you inform them?

25   A    Oh, did I inform them?  No.

1 Q You did not. Why not?

2 A It was a business arrangement between me and -- well,  
3 between my LLC and Citizen Solutions and they're not  
4 members of that group.

5 Q Okay. I need to double back. I realized I didn't  
6 complete a question I asked earlier. The \$308,000, the  
7 remainder of it, besides what you had loaned or  
8 transferred to Citizens in Charge, did any of the rest  
9 of that money go to support Initiative 517?

10 A No.

11 Q Okay.

12 MR. LAMB: And to be clear, you're not saying  
13 that the money that you loaned, that necessarily did go  
14 to help 517, you're just saying that the balance of the  
15 loaned money to Citizens in Charge, the remainder of  
16 the money went all to support your family.

17 THE WITNESS: That's correct.

18 Q So personal family living expenses?

19 A Mm-hmm (witness nods head affirmatively).

20 Q Okay. So do I understand correctly then that other  
21 than helping to support yourself and your family, what  
22 you have done with the payment you have received for  
23 three years for work on behalf of Citizen Solutions is  
24 to make a loan to Paul Jacob and Citizens in Charge; is  
25 that correct? Is there any other use that was made of

1 the funds?

2 MR. LAMB: I think that's -- he testified he  
3 made loans, the loans have been in large part repaid  
4 and that he used the rest to support his family.

5 Q Okay. And have those funds been reinvested in other  
6 activities that would benefit Citizen Solutions in the  
7 long run?

8 A No.

9 Q Okay.

10 MR. LAMB: Just so I am clear, you're saying  
11 the money that was repaid, that money went to support  
12 your family?

13 A That's correct. Oh, I'm sorry. Is that what you mean?  
14 I apologize. Did I turn around and -- okay.

15 Q Send it back out it in the political universe.

16 A No, no.

17 Q Did anything like that happen?

18 A It did not.

19 Q Okay. So did you in fact send a letter to Roy Ruffino  
20 during the summer or fall of 2012 discussing a  
21 partnership as was described in Exhibit A?

22 A We had talked about it, but we ended up settling  
23 instead on this contracted arrangement where I would  
24 provide them with professional services.

25 Q Okay. Did any of your discussions with Paul Jacob

1           involve raising funds for the Initiative 517 campaign?

2   A    No.

3   Q    I'm going to show you an exhibit, it's marked as  
4       Exhibit C, and it's an email exchange on November 8,  
5       2012, between yourself and Paul Jacob, and in the  
6       originating email, you say, "Paul, please do your best  
7       to fund raise for Initiative 517."

8                   Did he raise any contributions for 517?

9   A    We reported all transactions related to 517. Let me  
10       read this. I apologize. And, again, the question now  
11       that I have reviewed the email, what was your question  
12       again?

13   Q    Are you aware that Paul Jacob did raise funds for 517,  
14       accepted contributions from any source that finally  
15       went to help fund Initiative 517?

16   A    Not that I know of, no.

17   Q    You don't have any information indicating that that  
18       ever happened?

19   A    I mean, he came to town and met with donors. Whether  
20       or not donors ended up giving to him, I don't have any  
21       information on that.

22   Q    Did you ever ask him?

23   A    No, other than requests of is there anything else I  
24       need to report this month as far as in-kind  
25       contributions for 517.

1 Q Did you give him instructions on what should happen to  
2 financial contributions, where they should be directed,  
3 who checks could be made out to or mailed to, did you  
4 give him any such information?

5 A As I said before, I just checked with him when PDC  
6 reports were due and said is there anything more that  
7 we have to add for the previous month.

8 Q Sure. And that's a great approach when we are talking  
9 about in-kind contributions, but I'm talking about  
10 specifically monetary contributions. You've asked him  
11 to raise funds. Did you also have conversations about  
12 what should happen if someone expressed interest in  
13 giving a monetary contribution?

14 A I assumed he would know to report that to us. He was  
15 very diligent when it came to reporting anything  
16 related to 517, so there was no reason for me to doubt  
17 that he would tell me if he did raise some.

18 Q And if he were to get a check made out to the Protect  
19 Your Right to Vote on Initiatives Committee, that he  
20 would mail it somewhere, was this part of the  
21 discussion? Did you share that with him or have those  
22 conversations?

23 MR. LAMB: I don't understand the question.

24 MR. PERKINS: Because if Mr. Jacob were to  
25 receive a monetary contribution, he could not simply

1 deposit it in his account and then cut a check for a  
2 like amount or spend it to support the initiative.

3 MR. LAMB: Correct.

4 MR. PERKINS: So I'm wondering whether Tim,  
5 it was his committee, whether he shared information to  
6 him about how monetary contributions to support  
7 Washington State ballot measures have to be processed;  
8 that they have to be directed to the proponent of the  
9 initiative, put in that campaign account.

10 A Well, I mean, Paul Jacob's group has a long history of  
11 donating to our initiatives and we would always report  
12 those and -- I'm sorry. Go ahead.

13 MR. LAMB: I guess that's a fair answer.

14 A Yeah, and so, the man knows the system.

15 MR. LAMB: To be clear, that's not the only  
16 way somebody can support an initiative. There can be  
17 multiple committees established to support an  
18 initiative. Somebody can make an in-kind contribution  
19 to an initiative.

20 MR. PERKINS: Okay. I'm just talking about  
21 fund raising from other sources.

22 Q I'm going to move on to another exhibit. This is  
23 marked as Exhibit D. It's an email exchange that you  
24 had with Paul Jacob and others including Bob Herbold,  
25 Mike Dunmire, and perhaps others, Peter Zieve, if that's

1           how you say the name, and spanning from October 5th of  
2           2012, to November 12th, 2012, trying to set up  
3           meetings for people to talk about political fund  
4           raising.

5           So I want to zero in on the email at the bottom of  
6           page 2, which is from you to Bob Haerbold with Mike  
7           Dunmire copied. "Bob, trying to set up a meeting with  
8           you and Mike Dunmire the week after Thanksgiving. Mike  
9           is working with Paul Jacob, a conservative activist, to  
10          raise money nationally for helping with statewide  
11          initiatives throughout the nation to help pass  
12          conservative policies." Skipping down. "And he can  
13          guarantee that donations are anonymous to ensure that  
14          there is no negative blow back." I'm curious about the  
15          statement and whether Mike Dunmire, Paul Jacob, Bob  
16          Herbold, made contributions that haven't been disclosed  
17          to support Initiative 517 or any other initiative that  
18          you are aware of.

19   A    Would you please ask the question again.

20   Q    What fund raising are you describing here? Does it  
21          include any Washington State ballot proposition or  
22          candidate or political committee?

23   A    Well, as the email says, he's working with Paul Jacob,  
24          a conservative activist, to raise money nationally for  
25          helping with statewide initiatives throughout the



1 nation to help pass conservative policies like pension  
2 reform, tax limits, paycheck protection and other  
3 limitations on unions, et cetera, and elect more  
4 physically conservative republicans, especially in the  
5 U.S. Senate.

6 I think it says it right there, that that's what  
7 the fund raising that we were doing was going to do.

8 Q But was this inclusive of Washington State races? I'm  
9 curious about the promise of anonymity and what that  
10 meant to you.

11 A What it meant to me.

12 Q Yeah. What is your understanding about the  
13 permissibility of anonymous contributions in Washington  
14 State or in any other jurisdiction?

15 MR. LAMB: I don't think he is talking about  
16 Washington State.

17 MR. PERKINS: Okay. That's not at all clear  
18 from the exchange. So that's why I'm asking.

19 MR. LAMB: I think it is, but --

20 A To raise money nationally, that sounds like that's a  
21 reference to nationally.

22 Q But also for statewide initiatives.

23 A Throughout the nation.

24 Q Right. And I'm just curious what's your understanding  
25 about the allowability of anonymous political

1 contributions in Washington?

2 A What's my understanding of it.

3 Q Do you believe that they're permissible under  
4 Washington law?

5 MR. LAMB: You're addressing a legal  
6 question.

7 A I understand that donations are disclosed both in-kind  
8 and direct donations and we comply with those  
9 requirements.

10 Q Okay. Is it accurate to say that this promise of  
11 anonymity was intended to also cover Washington State  
12 races or should I read between the lines that it was  
13 not intended to apply to Washington races?

14 MR. LAMB: I don't think you need to read  
15 between the lines to infer that, that it's not talking  
16 about Washington State.

17 A It says at the bottom, "You and Pat were extremely  
18 supportive of our initiatives. This is a tremendous  
19 opportunity for you to help with measures throughout  
20 the nation." Well, I mean, it seems like it's pretty  
21 clear that Paul Jacob's group works nationally to  
22 protect the initiative process from legislative  
23 restrictions, that they support initiatives which  
24 they've done for us in the past, and that he was in  
25 town meeting with people to help him support the stuff

1           that he does on lots of areas, topics that are listed  
2           in the email itself.

3   Q    But I take for granted when you speak of a promise of  
4           anonymous contributions, that you meant something in  
5           particular. Can you tell me where you got the idea  
6           about anonymous contributions and why you would provide  
7           an assurance like that?

8                   MR. LAMB: I think that's calling for him to  
9           speculate. I think he's answered that he thinks it's  
10          talking about matters outside of the state of  
11          Washington. This is an investigation that is limited  
12          to the state of Washington, unless I understand that  
13          you have jurisdiction that goes beyond our borders.

14                   MR. PERKINS: But of course this email was  
15          provided in response, by Tim, in response to a request  
16          for records relevant to this investigation, so I have  
17          to at least ask the question, what's the relevance to  
18          these statements to Washington State races, is there  
19          any.

20                   MR. LAMB: He said no, he said there is none.

21   A    You asked me for emails that I had sent out related to  
22          politics. I was being responsive to your request.

23   Q    Okay.

24   A    The email says, "but this is a tremendous opportunity  
25          for you to help with measures throughout the nation."

1 I can't be more clear than that.

2 Q Okay.

3 MR. LAMB: We're going to conclude this  
4 interview at three o'clock or our participation will  
5 conclude at three o'clock.

6 MR. PERKINS: That should be fine. Thank  
7 you.

8 Q Tim, I am going to move on to a different topic. So  
9 when Citizen Solutions negotiates payment terms or  
10 informal or formal contract amounts for your  
11 initiatives with your committees, does anybody other  
12 than you work with Citizen Solutions' principals on  
13 those topics? Does Mike Fagan talk to them, does Jack  
14 Fagan talk to them, Stan Long?

15 A No, no. I usually handle that.

16 Q Okay. Do Roy Ruffino, William Agazarm or formerly  
17 Edward Agazarm have contact with Stan Long, Jack Fagan  
18 or Mike Fagan on other topics related to your  
19 committee, not contracts, not gross payment amounts,  
20 nothing like that, but any other topic related to your  
21 committee work?

22 A It's basically outside my knowledge of what they  
23 discuss with other people.

24 Q Okay. I guess a more concise way to put the question  
25 is are you the point of contact for your committees

1 with Citizen Solutions and its principals?

2 MR. LAMB: And just to clarify, I think what  
3 you're answering is that they may have points of  
4 contacts on signatures, on invoices, on other matters  
5 that aren't in your purview on those campaigns, but in  
6 terms of matters that you are responsible for, you're  
7 the point of contact?

8 A That is correct.

9 Q Okay. And what matters are you responsible for that  
10 are the basis for your contact with Citizen Solutions?

11 A We communicate on a regular basis during the year on  
12 potential projects.

13 MR. LAMB: To be clear, the question I think  
14 is what context did Citizen Solutions have with Jack  
15 Fagan, Mike Fagan or Stan Long. Would there have been  
16 a point of contact that --

17 Q I've actually moved on. My question was if Stan Long,  
18 Jack Fagan and Mike Fagan do talk to Roy Ruffino and  
19 William Agazarm about some matters, you know,  
20 invoicing, et cetera, what topics are reserved for you?  
21 What do you deal with with Citizen Solutions? You  
22 testified a moment ago that general agreements between  
23 your committee, your formal or informal contracts, you  
24 handle that, is that correct, and is there anything  
25 else?

1 A I communicate with the principals at Citizen Solutions  
2 on a regular basis throughout the year on potential  
3 projects. We interact regularly on quantities of  
4 signatures that have come in, whether or not there's  
5 blockers interfering with the signature collection  
6 process. I ask them on a regular basis to come to  
7 Olympia and testify on anti-initiative bills that are  
8 regularly introduced in Washington and many times they  
9 will provide petitioners to testify on those bills.  
10 And I spend a lot of time trying to obtain from all the  
11 players how much money we're raising compared to the  
12 number of signatures that Citizen Solutions has  
13 collected, trying to make sure that we have the money  
14 to be able to pay the bills, and it is a day-by-day,  
15 hour-by-hour --

16 MR. LAMB: I think that's an adequate  
17 description.

18 A Well, I want to be clear here and I want to --

19 Q If I can give you --

20 MR. LAMB: -- instead of --

21 A No, it's important. He asked me what my  
22 responsibilities are. I think it's important to answer  
23 in full. And what I'm trying to -- I'm sorry. Go  
24 ahead.

25 MR. LAMB: I think what specifically he is

1 asking about is what matters with respect to Citizen  
2 Solutions you would do, not strategically what you  
3 would do, and I think you've answered adequately.

4 Q I can give you one example, though, and then we can  
5 move on. When they need to increase the price that  
6 they pay petitions or petition coordinators, do they  
7 talk only to you or do they talk to Stan Long, Jack  
8 Fagan or Mike Fagan?

9 A They communicate directly with me.

10 Q Anybody else? Any other officers of the committee?

11 A Not that I know of.

12 Q When there has to be a price increase, for example,  
13 this is something I saw discussed in a lot of emails  
14 you provided, do you authorize that price increase?

15 A After checking with others, I usually make the decision  
16 on whether or not that's necessary.

17 Q Okay. And who do you check with?

18 A There are a lot of principals that are involved in any  
19 signature drive. I talk with donors, I talk with  
20 vendors, I talk with -- there's a lot of balls up in  
21 the air, and before you make a decision like that, you  
22 have to make sure that you're going to actually have  
23 the money to be able to do it, but at the same time you  
24 only want to do it as a last resort because the goal is  
25 to be able to make sure that there's never the

1           cataclysmic situation where you need more signatures  
2           and you don't have the money to be able to have them.

3   Q    So taking an example of an increase in signature  
4           payments or the price per signature, do you consult  
5           with Jack Fagan, Mike Fagan or Stan Long before  
6           approving such an increase?

7   A    I usually notify them of it verbally, and certainly not  
8           Stan Long, but with Jack and Mike, but with donors,  
9           with other people that are supporting the effort, I  
10          have to make sure that everyone's on the same page that  
11          it's going to be necessary to do so.

12   Q    Okay. In the context of the Initiative 1185 campaign,  
13          did you consult with Jack Fagan, Mike Fagan or Stan  
14          Long on price increases for signatures?

15   A    I'm sure I did. I don't have a specific instance of  
16          it.

17   Q    Okay. My next question is going to necessitate us  
18          looking at an exhibit. You provided some bank  
19          statements to us and I have looked through them and  
20          highlighted a few entries in the bank statements, and  
21          basically what I'm seeing when I look at these bank  
22          statements is that it looks like your committee may  
23          have had multiple checkbooks. I was wondering if you  
24          could first confirm or say that that wasn't the case.

25                   MR. LAMB: Let's start at the top. So we are



1 talking about Voters Want More Choices.

2 MR. PERKINS: Yes. It's a bank statement  
3 that Tim has provided.

4 Q And I have highlighted on all of these copies a few  
5 transactions that I'm interested in. There's a couple  
6 of checks that were written out of sequence. Most the  
7 checks were written in the 3000 sequence, but there is  
8 a couple that were written in the 5000 sequence, and to  
9 me, it indicates that there might be multiple  
10 checkbooks for the committee. Is that correct?

11 A I'm in Mukilteo, all of our treasurer duties, petition,  
12 accounting and all this stuff is handled by them, and  
13 as you're probably aware, I'm not allowed to  
14 participate in this side of the equation, so this is  
15 Sanskrit to me.

16 Q Okay, but are there multiple checkbooks for the  
17 account? If you know, say yes or no, whatever the case  
18 is; if you don't know, just say you don't know.

19 A I don't know.

20 Q You don't know. Okay. Just drilling down, do you  
21 possess a checkbook for your committees, including  
22 Voters Want More Choices?

23 A I don't.

24 Q Okay. Did you at any point in 2012?

25 A I don't, no.

1 Q I am sorry, what was the answer?

2 A No, I don't.

3 Q Okay. Thank you. Have you ever written checks from  
4 committee funds?

5 A No.

6 Q So the payments that I have highlighted correspond to  
7 payments that Citizen Solutions has received. The date  
8 and amount are the same that Citizen Solutions has  
9 disclosed as payment for signature gathering. So I  
10 just wanted to make sure that I had a clear answer that  
11 you didn't write checks for these payments to Citizen  
12 Solutions; is that accurate?

13 A That is accurate.

14 Q Who files PDC reports for your committees, including  
15 Voters Want More Choices and Protect Your Right to Vote  
16 on Initiatives?

17 A That's all handled out of Spokane.

18 Q Okay. And who precisely does it? Is it one of the  
19 Fagans, Stan Long, or one of their staff members?

20 A I have to smile when I hear about staff members. We do  
21 not have staff members. It's all handled in Spokane by  
22 them. I don't know specifically.

23 Q Okay. Do you know who possesses the computer that your  
24 data is held on, your electronic filing data for PDC  
25 reports?

1 A No.

2 Q You don't know whether it's in Stan Long's accounting  
3 office or in the home office of the Fagans, you're just  
4 not aware?

5 A No.

6 Q How is information communicated to the other officers  
7 of the committee for filing purposes, information about  
8 in-kind contributions, for example?

9 A We --

10 MR. LAMB: To be clear, you're talking about  
11 for filing purposes; right?

12 MR. PERKINS: Correct, yes.

13 A For filing purposes. So -- can you pick a committee  
14 for me?

15 Q Sure.

16 A Because there's no general rule and so it would be  
17 helpful to be specific.

18 Q Okay. Protect your Right to Vote on Initiatives, they  
19 ended up disclosing between one and two dozen in-kind  
20 contributions over a variety of dates from Citizens in  
21 Charge. How were the dates and amounts of those  
22 in-kind contributions communicated to your committee  
23 officers for filing and who communicated the  
24 information and who received it?

25 A I would normally call Paul and say, "Is there anything

1 that needs to be reported this month," and then I would  
2 call either Jack or Mike Fagan and tell them the  
3 amounts and the dates that I was given.

4 Q Okay. Does any of this communication ever happen in  
5 writing?

6 A Possibly, but mostly it was just verbal communication.

7 Q Okay. So I think although we only have ten minutes  
8 left, I'm going to take a very quick break and probably  
9 end up having, you know, five minutes at the close of  
10 the interview.

11 (Whereupon, a recess was taken.)

12 MR. PERKINS: Back on the record.

13 Q Just one or two more questions and then we'll conclude.  
14 So we've talked about what you described as a loan from  
15 your LLC to Citizens in Charge and that loan repayments  
16 commenced in 2013 and about \$70,000, if I recall  
17 correctly, has been repaid. Did the LLC create records  
18 to help account for this loan and its repayment,  
19 anything at all, a spread sheet, a ledger, some kind of  
20 tally of the money that went out, the dates that it  
21 went out and the dates that it's been repaid, so that  
22 the LLC can know when the loan has been paid in full?

23 A No, there's nothing like that.

24 Q Okay. And are there any written communications between  
25 you and Paul Jacob about this loan at the time that it

1           was made or the loans were made and written  
2           communications back about repayment?

3    A    No.

4    Q    Have there ever existed any such communications?

5    A    No.

6                           MR. LAMB:  Written communications.

7    Q    Written communications.

8    A    No.

9    Q    Okay.

10   A    Not that I remember.

11   Q    Okay.  When you have received repayment or the partial  
12        repayment, how does that happen, are you getting checks  
13        through the mail?

14   A    Mm-hmm (witness nods head affirmatively), yes, I am  
15        getting checks through the mail from them.

16   Q    Okay.  And are those checks made out to the LLC?

17   A    They are.

18   Q    Okay.  Great.

19   A    With usually a memo at the bottom "Loan Repayment."

20   Q    Okay.  So are there any records that document the  
21        making of this loan or the repayment of this loan  
22        outside of what we would get from the LLC's bank?

23   A    Nothing beyond what's in the bank.

24   Q    Okay.  Is there any other information that you think  
25        would assist us in disposing of those allegations?

1 A No.
