The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on July 10, 2018. Your complaint alleged that Elisabeth Veneman may have violated RCW 42.17A.235 for failure to report campaign expenditures.

PDC staff reviewed your allegations and, as a result of staff's initial review, we found the following:

- Respondent's reports of expenditures were received in a timely manner and the public was therefore not deprived of critical information

Based on these initial findings, staff has determined that, in this instance, there is no evidence supporting a finding of material violation warranting further investigation.

The PDC has closed the matter and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
