Dear Michael J Killian:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on June 14, 2018. Your complaint alleged that Jackie Lopez Giddens may have violated RCW RCW 42.17A.240 for failure to disclose the filing fee and campaign signs on the expenditure report.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

The filing fee was reflected on the amended C-4 Report Schedule B that was filed on June 20, 2018.

Jackie Lopez-Giddens provided documentation which verified that the filing fee and sign purchase were reported on an L Report dated in May, 2018.

Ms. Lopez also stated that the campaign treasurer worked with PDC staff to amend the C-4 report because it was not displaying on the PDC website.

PDC Staff were informed by Michael Killian that the complaint had been subsequently withdrawn due to the information referenced in the response.

Based on these initial findings, staff has determined that in this instance, the failure to disclose the filing fee and campaign signs does not amount to a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
