Subject: Complaint regarding Ronald Krebs, PDC Case 36967

Dear John Geniuch:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on June 14, 2018. Your complaint alleged that Ronald Krebs may have violated RCW 42.17A.240 for failure to properly itemize expenditures.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- On June 6, 2014, Ron J. Krebs filed a Candidate Registration (C-1 report) declaring his candidacy for election to San Juan County Sheriff, selecting the Full Reporting Option, and listing Angelia Procassini as Campaign Treasurer.
- For the 2014, Mr. Krebs acknowledged that his Campaign failed to properly itemize expenditures as required in accordance with PDC laws and rules. He stated that his former Treasurer did not recall or have the specific number of items printed for the expenditures identified in the complaint.
- On April 17, 2018, Mr. Krebs filed a Candidate Registration (C-1 report) declaring his candidacy for reelection to San Juan County Sheriff, selecting the Mini Reporting Option, and listing himself as Campaign Treasurer.
- While Mr. Krebs filed under the Mini Reporting Option for the 2018 election, he will be reminded about the
 importance of filing timely and accurate all PDC reports, including providing a detailed description of the
 goods and/or services, including the number of items printed.

PDC staff is reminding Ronald Krebs about the importance of the accurate disclosure of all contribution and expenditure activities, including the quantified itemization of printed materials and related advertisements.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
