Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on April 11, 2018 Your complaint alleged that Raise Up Washington PAC may have violated RCW 42.17A.235, .265, .205, .220, 320, & .255 for failure to timely and accurately disclose contributions, expenditures, books of account, committee registration, and sponsor ID.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- No evidence was provided to substantiate any allegations outside of late filing of C-3 and C-4 reports in violation of RCW 42.17A.235.
- The majority of the alleged violations were for timely filed, and later amended, C-3 and C-4 reports.
- The remaining allegations in the complaint alleged that Raise Up WA failed to timely file C-3 and C-4 reports on an accelerated pre-primary schedule.
- Raise Up WA supported a ballot proposition, and did not participate in the 2016 Primary Election.

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of an actual material violation warranting further investigation.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1), and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
