I would refer you to <u>RCW 42.17A.555</u>, which prohibits use public facilities for political events. <u>PDC guidelines include this discription:</u>

Public facilities may not be used to support or oppose a candidate or ballot proposition. RCW 42.17.555. Facilities include school district equipment, buildings, supplies, employee work time, and district publications. The statute includes an exception to the prohibition for "activities which are part of the normal and regular conduct of the office or agency."

Not only did Principal Heather Hiatt and Vice Principal John Green, Counselor Vollie Berry violate RCW 42.17A.555 by organizing the event on campus, they used minor children for a political purpose as props without parental consent, Assistant Superintendent Brian Schultz abetted this violation by informing Shore Police Department that the children left campus "voluntarily", this is untrue as explained above.

My minor sons who attended Kellogg Middle School, where taken off campus by Principal Heather Hiatt, Vice Principal John Green, Counselor Vollie Berry on March 14th, 2018, with out parental consent and against multiple district policies and in violation of RCWs.

The handbook for Kellogg Middle school states:

Kellogg Middle School operates under a closed campus policy. From the time you arrive in the morning until the end of the school day, students are not to leave school grounds without written permission. Because of the disruption to the school environment, student visitors are not allowed at Kellogg.

I was told by both Vice Principal Casey Campbell and Assistant Superintendent Brian Schultz that the children were leaving "voluntarily".

One of minor sons informed that Vice Principal Green told him, "you are off campus you can do whatever you want", he did not instruct my minor son to return to campus or that it was against the rules to be off campus. I was also informed by my minor sons that Sean Hudson told them they, "could go if they wanted, or not to go" with regards to the event, in direct violation of school policy. The staff made no effort to inform the minor children they are not allowed to leave campus. At no time did anyone on the staff attempt to stop the minor children from leaving the campus. At no time was I as a parent notified they would be leaving campus, the only reason I found out about this was an automated call informing me my minor children were absent from a class.

When I called the school to find out about this, I was informed that one minor child was in class and the other was "out on the march with Principal Hiatt".

I was lied to by the staff of Kellogg Middle school when they informed me that the march was going to City Hall. Instead the march went to the Shoreline Courthouse and District Headquarters.

While at District Office I attempted to contact my minor son, Assistant Superintendent Brian Schultz asked me to be quiet and not to call his name in an effort to locate my minor son.

Since the minor children were escorted by and under the supervision per the office of Kellogg Office staff, of at least Principal Heather Hiatt and Vice Principal John Green, Counselor Vollie Berry, and against the rules of the school, they were still under the authority of those staff members.

Field trips are defined as travel away from school premises, under the supervision of a teacher with an approved course of study, for the purpose of affording students a direct learning experience not available in the classroom

Furthermore:

Each student participating in a field trip must first return a permission slip signed by his/her parent. The permission slip must include parent and physician contact information. Parents shall be informed if private vehicles are to be used for the field trip.

Neither I or my wife signed a permission slip for this event.

During the march the many minor children including mine were leaving the event unsupervised and wandering about the area of the 2.6 mile march route. I observed many minor children between Kellogg and the Courthouse and District Office. I found my minor son at N.E. 175th St. and 10th Ave. NE without any adults present. My other minor son informed he left the march to return to Kellogg from N.E.175th St. and 15th Ave. N.E., without any supervision, which why he was in class when I first contacted Kellogg about the absence notification.

Our minor children were removed from campus by Principal Heather Hiatt and Vice Principal John Green, Counselor Vollie Berry against school and district policy.

Assistant Superintendent Brian Schultz's informing the Police that students were off campus "voluntarily", was untrue statement, as minor children are not allowed to leave campus and they were

taken off campus by staff members, this false statement impeded my request for an investigation with the Police Department.

Specific complaints.

- Removal of minor children from campus without parental consent.
- Violation of Kellogg policy in allowing minor children to leave campus.
- Violation of District Policy for Field Trips.
- Violation of District Policy for Parental consent for Field Trips.
- Endangering Allowing minor children to be unsupervised off campus, walking for 2.6 miles along busy arterial streets.
- Impeding the reporting of an incident to law enforcement.
- Violations of RCW 42.17A.555 and PDC guidelines.
- Use of minor children as political props while in violation of RCW 42.17.555.
- False statements to parents and law enforcement about the location and supervision of a minor child.

Remedy or Resolution: What specific action do you want taken on your complaint.

- Suspension or Termination, formal reprimands at a minimum.
- Formal written apologies from all staff involved.
- Documented Retraining of all staff involved.
- Written assurances from all staff involved of future compliance with District and School policies will be followed regarding field trips and permissions.
- Written assurances from all they will not use minor children for political activity.
- Future compliance by Shoreline School District #412with RCW 42.17A.555 and PDC guidelines.
- Equal time to present the historical context of the Second Amendment, historical consequences of gun control, and FBI and CDC data about deaths and injuries involving firearms.
- Written memorandum of understanding for the safety of the children during the course of the complaint investigation they will not leave campus without written consent or in the company of a parent, I cannot as parent return them to school when their safety and security is not assured.
