

File a Formal Complaint - Ozzie Knezovich

See you next year, in 2018 - my name, next your name, and on the election ballot. And, if, you consider this a threat, your finally right.



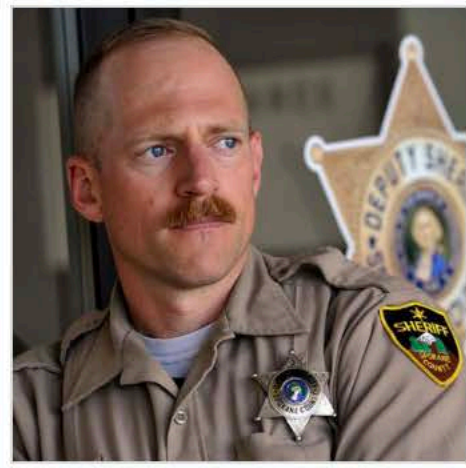
