## Micaiah,

I received your request for a formal response, on the 19th of March, to a complaint submitted to

you from the Spokane County Sheriff, Ozzie Knezovich. I have forwarded the complaint on to my

attorney for his review accordingly, however, who is currently out of the area and unable to

immediately respond on my behalf by the 26th of March - within the 5 day window as provided.

In reading the complaint, I note that Knezovich didn't submit ANY supporting evidence – which makes a detailed response, on my part, reasonably impossible. Is your request within the guidelines of your Department's policies and procedures?

For the record, I deny all the undocumented allegations – I have made NO formal announcement

for placing my name on any ballot, for any elected position, and especially; to the Sheriff's good

friend Mike Fitzsimmons on the KXLY radio program in 2015, or participated in seeking the

business support of any one, "single," individual in my allege announcement, or in economically

supporting any individual in the production of any Documentary against Knezovich – NONE – but

not that I am unworthy of one in my continued efforts and focus on my efforts to hold Knezovich

accountable in the death of a Pastor and a Child resulting in a very real costly and unexplained

outcomes to the taxpayers of Spokane County.

As, a part of Knezovich's conspiracies and cover-ups, in just the past 6 months, he has made false

statements to Spokane County Deputies alleging that I made "death threats" against him, his wife,

and his family resulting in my false arrest, during a very public event at a public high school,

resulting in my false incarceration – and only to have all his charges completely "dismissed" by the

Spokane County Prosecutor, Larry Haskell.

And, even in the face of the Prosecutor's decision, Knezovich has continued to state that I am under

investigation by the Spokane County Sheriff's Office, the Spokane Police Department, the WSP, and

even the FBI and the Joint Terrorism Task Force without ANY result and as verified by Public Records

During this period, Knezovich also demanded that the Spokane County Prosecutor send his dismissed

charges to the Pend Oreille County Prosecutor's Office for a Formal Review - again, resulting in NO

support for his false arrest and his subsequent charges and continuing false allegations.

Knezovich is currently violating the Sheriff's Department's Policies and Procedures in electioneering,

endorsing candidates, supporting candidates and in interfering into the political affairs and outcomes

of local municipalities within Spokane County resulting in a multitude of Community Problems involving

the illegal activities of those above, including; Bob West and his daughter Brandi Peetz – names that you

should be familiar with and while continuing is his placement of billboards for Crime Check containing his

image in violation of your standing order against doing so along with your suspended fine.

For the record, as Sheriff Knezovich is now facing a formal request to the Prosecutor's Office in being

placed on the Spokane County Prosecutor's Brady Cop List, De-Certification as a Law Enforcement

Officer in Washington State for lying against me in my matter, and even a Civil Right's Lawsuit, I must

ask you, if it is possible that Knezovich is also lying to the PDC, in providing NO evidence in this matter

while providing undocumented and while desperately misleading you in these baseless allegations?

Please provide me with the evidence to his allegations accordingly along with a reasonable time-frame

in an opportunity to properly respond accordingly, and my attorney will be pleased to do so. As Sheriff,

and should I choose to formally announce, I will abide by the Sheriff's Departments Policy and Procedures and the PDC's Policies and Procedures – for which the record in your office should reflect that I have a perfect record in following.
