### Public Disclosure Commission Statement of Understanding

#### William Peach: PDC Case 40612 and 40731

I William Peach, hereby acknowledge that:

I failed to timely file a Monetary Contribution report (C-3 report) and three Summary Full Campaign Expenditure reports (C-4 reports) for my 2018 Campaign for Clallam County Commissioner, in violation of RCW 42.17A.235, as follows:

- **Failure to timely file a C-3 report:** On August 3, 2018, the Committee to Elect Bill Peach (Campaign) filed a C-3 report disclosing that I loaned the Campaign \$20,000 on May 16, 2018. The disclosure of the \$20,000 loan was required to be reported by June 11, 2018, and therefore the C-3 report was filed 53 days late, and four days prior to the August 7, 2018 primary election. The \$20,000 represented 84.5 percent of all contributions received by the Campaign as of November 14, 2018.
- **Failure to timely file three C-4 reports:** On September 19, 2018, the Campaign filed three late primary election C-4 reports. (1) The 21-Day Pre-Primary Election C-4 report, due to be filed on July 17, 2018, disclosed \$825 in expenditures made; (2) The 7-Day Primary Election C-4 report, due to be filed on July 31, 2018, disclosed \$2,688 in expenditures made; and (3) The Post-Primary Election C-4 report, due to be filed on September 10, 2018, disclosed \$7,457 in expenditures made.

I would like to avoid the time and expense resulting from a Brief Adjudicative Proceeding (Brief Enforcement Hearing) being scheduled by Public Disclosure Commission (PDC) staff.


Therefore, in lieu of PDC staff scheduling a Brief Enforcement Hearing, I am completing this Statement of Understanding, and enclosing a check or money order in the amount of \$600 as a penalty payment in this matter.



The \$600 penalty being assessed, includes a \$150 penalty in accordance with the Penalty Schedule adopted by the Commission for Brief Enforcement Hearings set forth in WAC 390-37-143, for each of the following acknowledged violations:

1. One violation of RCW 42.17A.235 for failing to timely file a C-3 report disclosing a \$20,000 candidate loan to my Campaign.
2. Three violations of RCW 42.17A.235 for failing to timely file the 21-Day and 7-Day Pre-Primary Election C-4 reports, and the Post-Primary Election C-4 report.

I understand that by completing this Statement of Understanding, I am acknowledging the violations of Chapter 42.17A RCW and Title 390 WAC set forth above, and I am waiving my right to a hearing in this matter. I further understand that this will resolve the issue of my failing to timely file C-3 and C-4 reports for the 2018 election cycle.
