Subject: Complaint regarding Luanne Van Werven, PDC Case 30906

Dear Washington State Democrats:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on January 31, 2018. Your complaint alleged that Luanne Van Werven may have violated RCW 42.17A.235 and RCW 42.17A.240 for failure to timely file a C-4 report of contributions and expenditures.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- RCW 42.17A.235(2)(b) requires candidates and political committees to file a C-4 report of contributions and expenditures on "*the tenth day of the first month following the election.*"
- As the tenth day of the first month following the 2016 general election fell on a weekend, the post-election C-4 report was due on December 12, 2016.
- Luanne Van Werven filed a post-election C-4 report on December 13, 2016, in substantial compliance with the timeliness requirements of RCW 42.17A.235(2)(b)

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
