

## File a Formal Complaint - Chestine Edgar

Burien For All PAC was formed to support four candidates (Krystal Marx, Nancy Tosta, Jimmy Matta, Pedro Olguin) and Burien Initiative 1. Burien Initiative 1 did not make it onto the ballot and no campaign expenditures were made for this. The two mailers, design and postage and the robocall costs were devoted to electioneering for these four candidates. It appear from the PDC data base of reports that-

1. This Committee failed to file accurate, timely C3 and C4 reports. RCW 42.17A.235
2. A failure to properly break down, describe expenses. RCW 42.17A235, WAC 390-16205, WAC390-16-037
3. A failure to submit C6 reports showing the independent expenditures made to Krystal Marx, Nancy Tosta, Jimmy Matta, Pedro Olguin. Or if Burien For All submitted them to the PDC then these candidates failed to report these independent expenditures to in their individual campaign reports. The expenditures made to these candidates appear to be in excess of \$1000 per each of the candidates during their 2017 campaigns.

In searching the PDC data base of Burien For All, I was unable to find C6 report filings for this committee and I was unable to find any of the four candidates( Marx, Matta, Tosta, Olguin) who reported having gotten these independent expenditures from Burien For All.

I have attached one of the flyers Burien For All sent out, they failed to note the number of items they printed and mailed. They reported doing a second mailer and again failed to report the number of items printed and mailed. They made a robocall and failed to report the number of calls completed and paid for- paid for long after the calls were made.

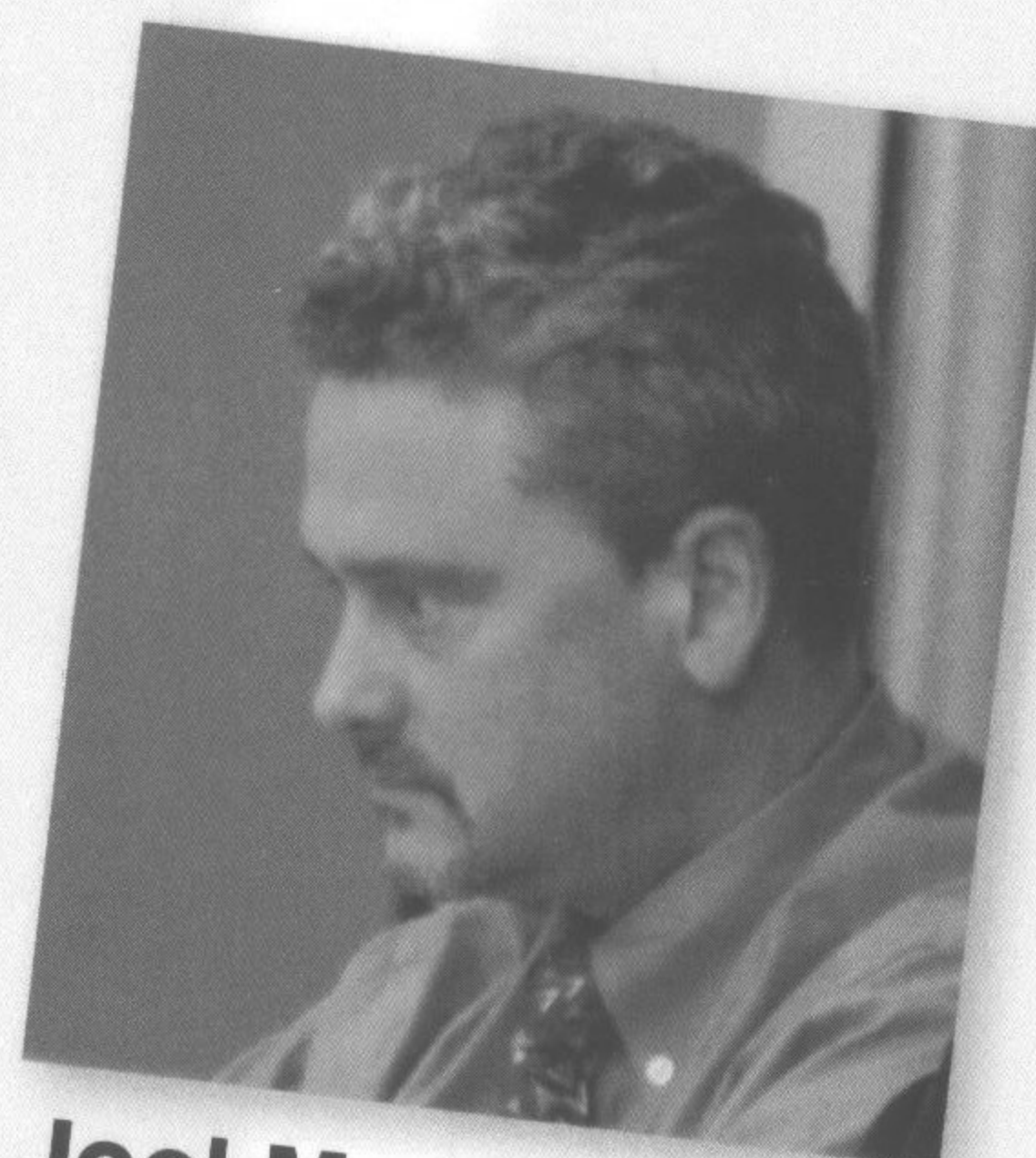
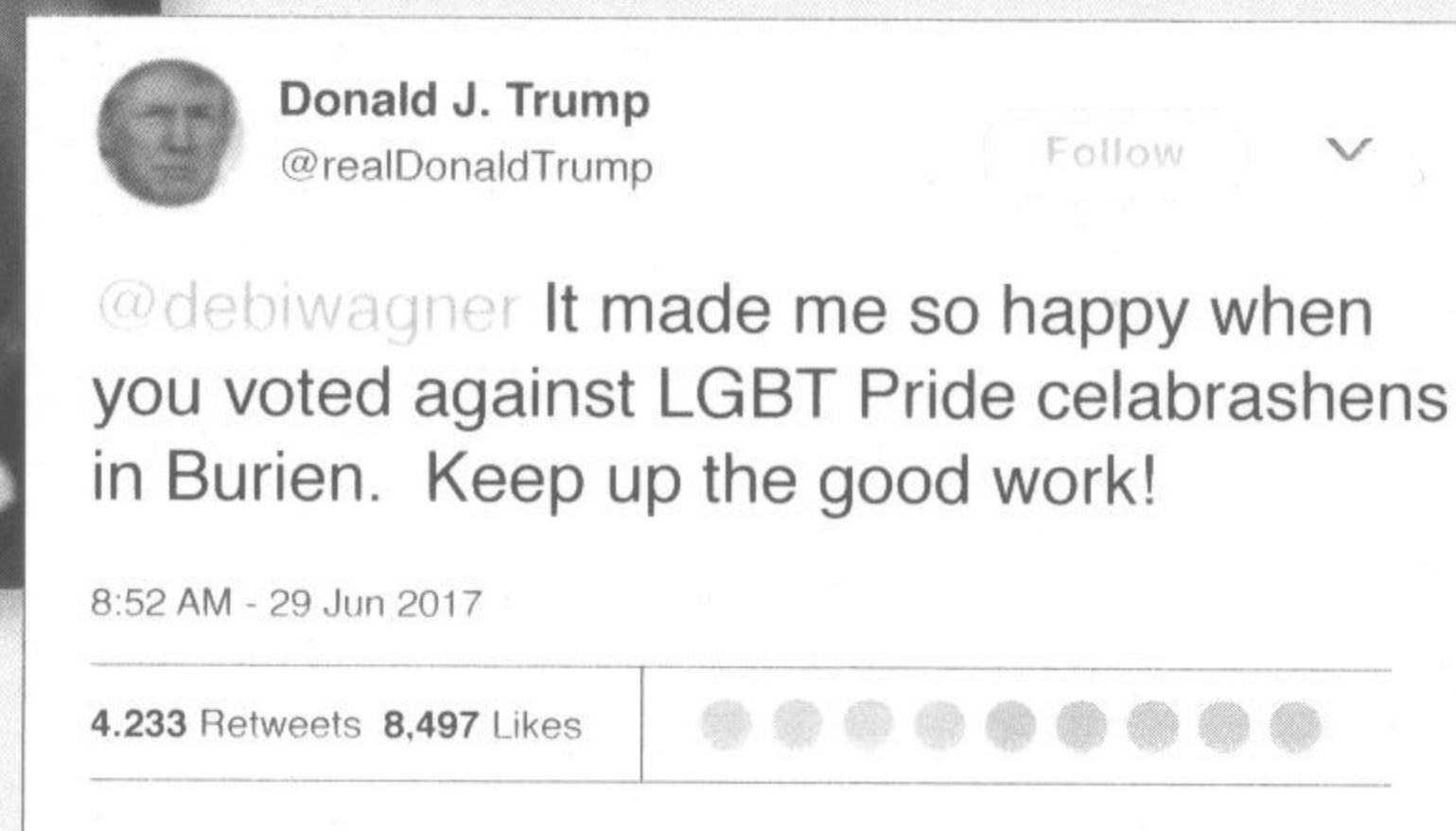
- Burien For All - Trump Flyer 1 - Front

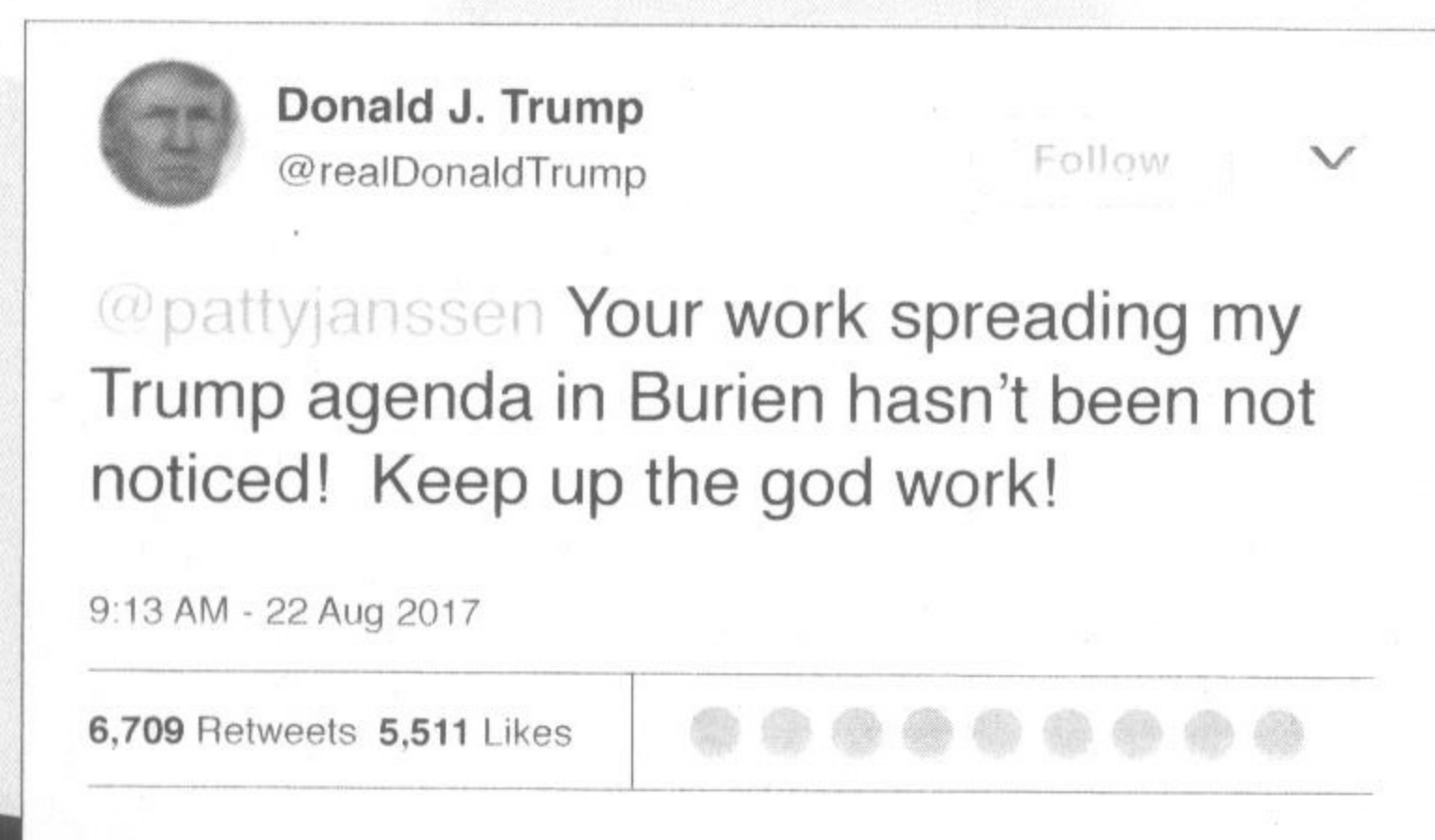
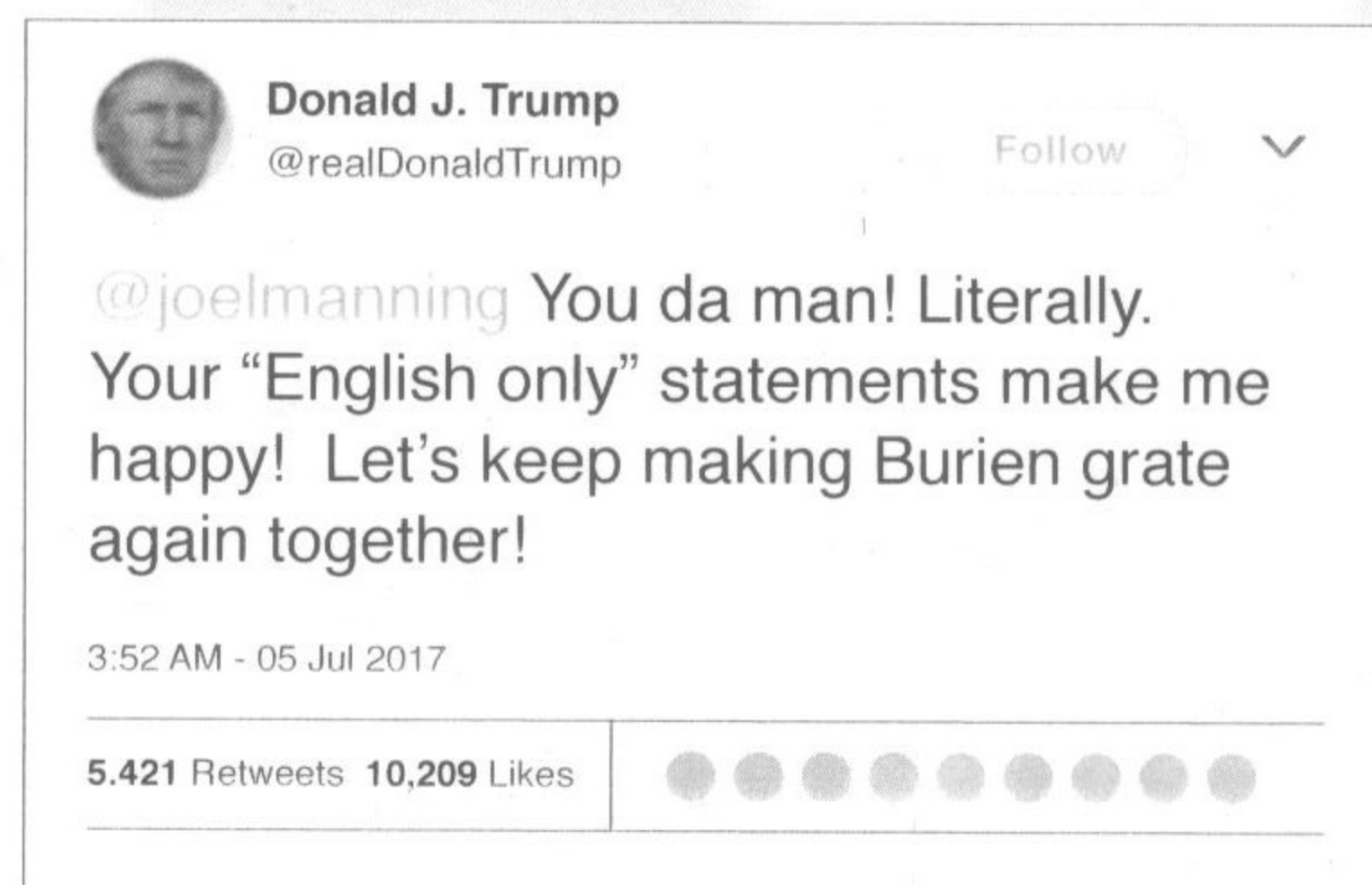

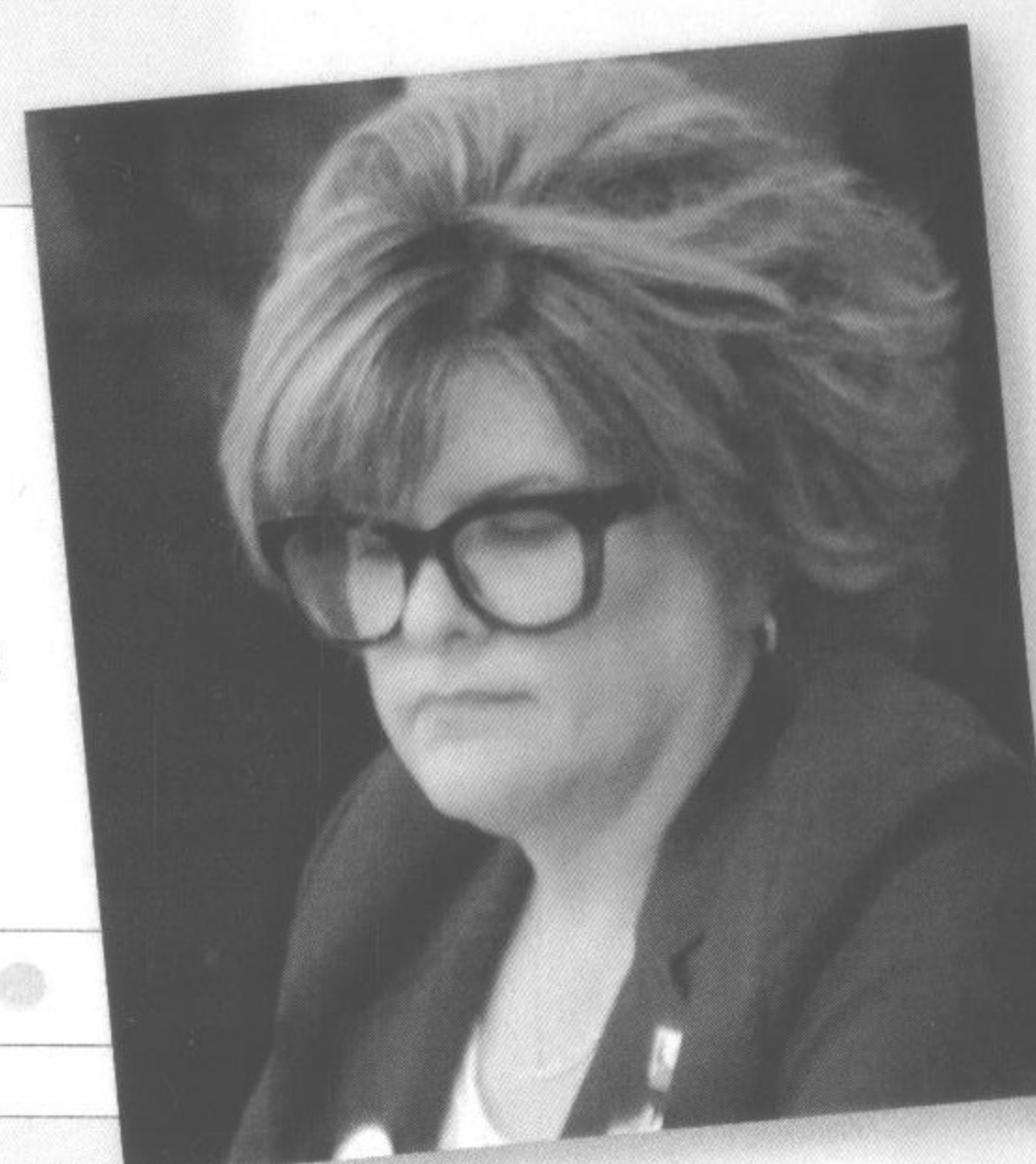
