The formal written warning will include staff's expectation that Feminist Progress PAC continues to work with PDC staff to ensure that all required disclosures of contributions and expenditures are made to the public. The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Subject: Complaint regarding Feminist Progress PAC, PDC Case 29799

Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on December 21, 2017. Your complaint alleged that Feminist Progress PAC may have violated RCW 42.17A.235 for failure to timely report contributions and expenditures, and RCW 42.17A.240 and WAC 390-16-037 for failure to provide detailed breakdowns of expenditures.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Feminist Progress PAC filed their initial C-1pc on July 20, 2016, choosing the Full Reporting Option which required them to file C-3 and C-4 reports of contributions and expenditures, no later than the deadlines provided in RCW 42.17A.235.
- Feminist Progress PAC failed to timely file their C-3 and C-4 reports from July 20, 2016, through April 10, 2017, when they acquired the services of a professional treasurer.
- Feminist Progress PAC has admitted to failures to timely file and accurately and completely breakdown expenditure details.
- On November 13, 2018, Feminist Progress PAC filed their missing C-3 and C-4 reports from election year 2016, late disclosing \$4,027 in contributions and \$2,062 in expenditures.
- Feminist Progress PAC has no prior found violations of PDC laws or rules.

Based on these initial findings, staff has determined that in this instance, failure to timely and completely report contributions and expenditures, does not amount to an actual material violation warranting further investigation.

Pursuant to WAC 390-37-060(1)(b), Feminist Progress PAC will receive a formal written warning concerning failure to timely and completely disclose personal financial affairs The formal written warning will include staff's expectation that Feminist Progress PAC continues to work with PDC staff to ensure that all required disclosures of contributions and expenditures are made to the public. The Commission will consider the formal written warning in deciding on further Commission action if there are future violations of PDC laws or rules.

Based on this information, the PDC has dismissed this matter in accordance with RCW 42.17A.755(1), and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
