The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on November 20, 2017. Your complaint alleged that King County Democratic Central Committee Non-Exempt Account may have violated RCW 42.17A.235 for failure to timely report in-kind contributions made to Burien candidates

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- The in-kind contributions made to Burien candidates were timely reported.

Based on these initial findings, staff has determined that in this instance, no evidence supports a finding of a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
