Through a public records request I have discovered the following, and want to file a complaint about what I believe to be illegal and unethical campaign activity by Port of Olympia Commissioner Zita.

- 1) Contained on Commissioner Zita's Port issued computer is campaign related material, such as a campaign flier, donor lists and list of endorsements for her Port of Olympia campaign.
- 2) Commissioner Zita announced a May 30, 2017 meeting to be held at Port of Olympia offices that was (Sponsored by Zita for Port). An improper use of public property.
- 3) Commissioner Zita held a meeting at the Port of Olympia offices on July 21, 2017. Invitation to the meeting was not announced publicly, it was only known to a few of Commissioner Zita's campaign supporters. Another, improper use of public property.
- 4) Commissioner Zita's Port issued computer also contains student information along with other items related to her job as an Evergreen State College Professor.

Commissioner Zita has had training in ethics and use of public resources, and should know that Port of Olympia property cannot be used for political campaigning or any other personal use.

This is the second complaint filed concerning Commissioner Zita's campaign activities this year.

The PDC should investigate the above violations, as there appears to be a willful disregard for campaign rules and regulations. If the PDC finds that to be the case, the PDC should refer the matter to the Attorney General's office for prosecution.
