To The PDC,

A mailer was received by Burien Residents from a PAC calling itself Burien For All. The mailer was libelous in content in that provided false and defaming information about four candidates (Debi Wagner, Joel Manning, Patty Janssen and Darla Green). Its intent was to mislead the voters that received it and to expose the candidates to ridicule and contempt in the community. None of the named candidates has ever identified with Donald Trump and his alleged tweets nor have the individuals named ever referred to themselves as the Trump slate. This mailer specifically identifies the four candidates as the Trump slate.

Furthermore, the top contributors identified on the mailer (Puget Sound Leadership Council PAC and SEIU 775 NW) are not listed on the PDC site as contributors to the Burien For All PAC and the payment for the mailer and the postage for it are not shown as Expenditures.

What remains even more troubling about this mailer is that the committee board that put it together has elected public officials on their committee board: Lauren Berkowitz - Burien City Council member/PAC campaign manager and Joe Fitzgibbon - Washington State House of Representatives/PAC Board member. According to announced Media Public Record, Jeff Upthegrove is the political consultant for this PAC but yet he is not listed on the C1 filled by this committee by Lauren Berkowitz.

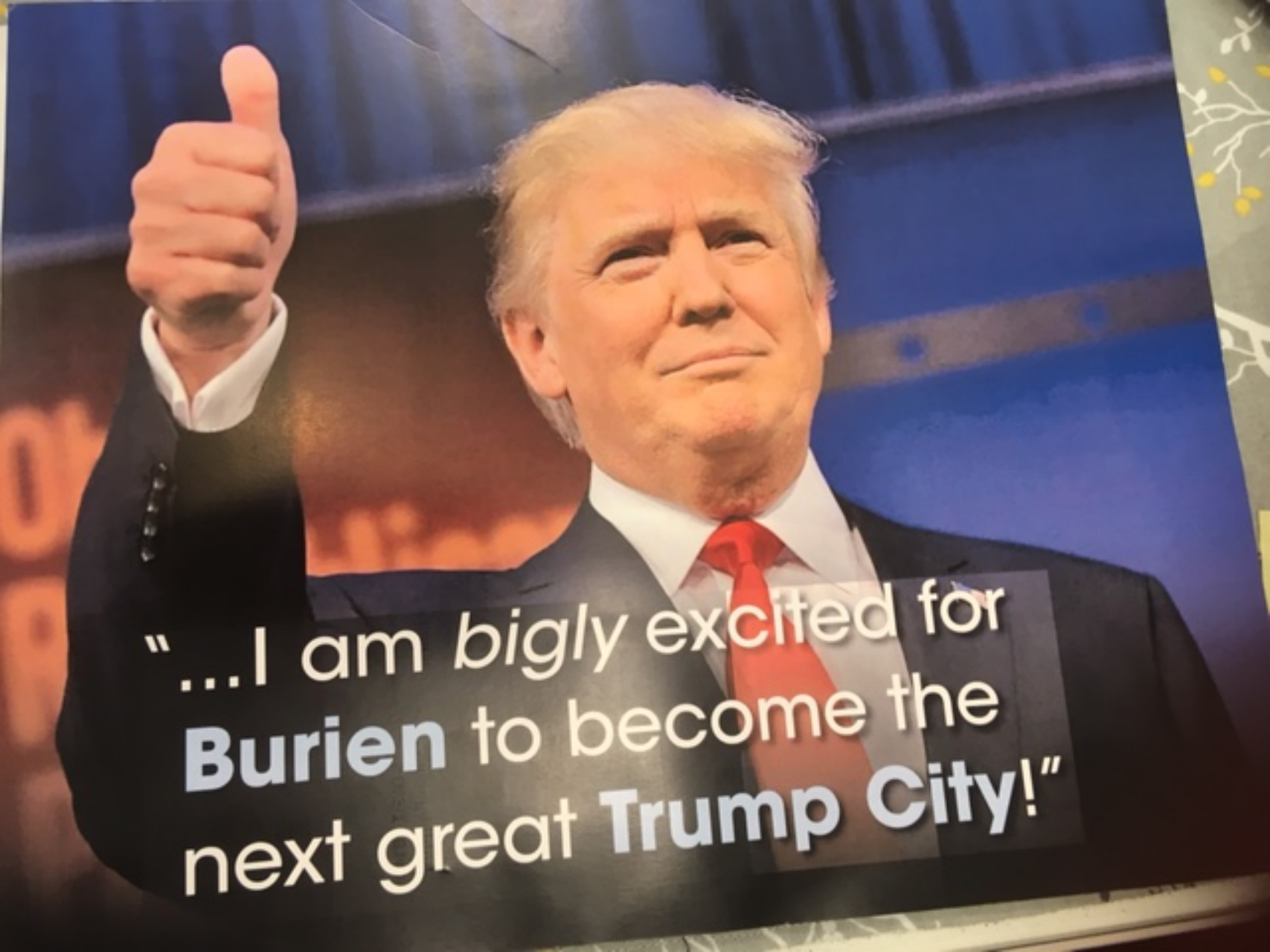
