## File a Formal Complaint - Kurt Fritts

State law strictly prohibits contributions of more than \$5,000 to political committees during the 21 days that precede a general election. Wash. Rev. Code § 42.17A.420(1). According to the PDC website, with respect to the general election on November 7, 2017, this period began on October 17, 2017. <a href="https://www.pdc.wa.gov/last-minute-contribution-restriction-begins-0">https://www.pdc.wa.gov/last-minute-contribution-restriction-begins-0</a>.

The contribution in question [Enterprise Washington's Jobs PAC contributing \$235,000 to Citizens for Progress Enterprise WA on 10/20/2017] clearly violates this prohibition. The contribution does not qualify for the exception in the Act for contributions made by, or accepted from, a bona fide political party. Wash. Rev. Code § 42.17A.420. Nor does the Ninth Circuit decision in *Family PAC v. McKenna* regarding the statute's application to ballot measure committees have any bearing on the conduct at issue here.

As a result, Cit for Progress Enterprise WA violated the law and must immediately return the amount

above \$5,000 to Enterprise Washington's Jobs PAC. <a href="https://www.pdc.wa.gov/learn/publications/publications/publications/prohibitions-and-restrictions/contributions-last">https://www.pdc.wa.gov/learn/publications-and-restrictions/contributions-last</a>. Given the rapidly approaching date of the election and the clear violation at issue, it is vital that the PDC act quickly to enforce the 21-day contribution limit.
