

I am writing to you today pursuant to RCW 42.17A.765 (4). This e-mail serves as notification to the Attorney General's Office and the Wahkiakum County Prosecuting Attorney's Office that there is reason to believe multiple provisions of RCW 42.17A have been violated significantly and repeatedly by the Wahkiakum County Democratic Central Committee.

By request, I am also copying the Thurston County Prosecutor's office and the Public Disclosure Commission on this email.

Please see a copy of the formal complaint I submitted to the PDC which I have attached as an attachment to this email. I submitted the complaint on October 13, 2017.

Also, please note that I included the same exhibit attached in this email which I also provided to the PDC in the original complaint.

(The following was submitted to the PDC October 13, 2017):

To Whom it May Concern --

It has come to my attention that the Wahkiakum County Democratic Central Committee has habitually and willfully committed frequent and multiple violations of RCW 42.17A.

**1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)**

On their most recent C1-pc form, the Committee failed to check either the full or mini-reporting box, which requires them to file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. *See attached C1-pc documents.*

Unfortunately, the Wahkiakum County Democratic Central Committee has failed to do this.

The PDC should investigate the possibility that the Wahkiakum County Democratic Central Committee committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately. Please don't hesitate to contact me if you need any additional information.
