

File a Formal Complaint - Glen Morgan

To Whom it May Concern --

It has come to my attention that Jim Cooper -- a 2016 failed candidate for the Thurston County Commission -- has committed further violations of **RCW 42.17A**, once again.

1) State law requires that campaigns accurately identify the name of a contributor, and prohibits the concealment of the identity of a contributor. RCW 42.17A.435. WAC 390-16-308 (3). State law further requires that accurate reports of contributions be submitted in a timely manner. RCW 42.17A.235. State law also requires that the address of contributors be accurately reported. RCW 42.17A.240. State law also establishes that candidates must return contributions that exceed the contribution limits contained in RCW 42.17A.405 within 10 days of receipt. RCW 42.17A.405, RCW 42.17A.110, WAC 390-16-312.

WAC 390-16-308 (3) establishes that contributions received from a sole proprietor or drawn upon the account of a business which is a sole proprietorship is attributed to the owner of the business entity and reported as such to the PDC.

JZK Inc. is a sole proprietorship owned wholly by JZ Knight (see attached), and as such, this contribution must have been attributed to JZ Knight. JZ Knight is a cult leader who lives in her walled compound in Yelm, WA and claims to channel a 35,000 year old homicidal Lemurian warrior spirit named "Ramtha." Apparently, "Ramtha" has travelled 35,000 years through space and time to help JZ Knight contribute to Jim Cooper among other political candidates. "Ramtha" also endorsed Donald Trump for President, but JZ Knight claims she only supports Democrats. The State Democratic Party divested itself of JZ Knight funds in 2012 after videos exposing her racist rants against Mexicans, Jews, Catholics and others went public. Some local Thurston County candidates and committees last year were less concerned about the racism than they were about collecting cult cash.

In October 2016, JZ Knight made two \$1000 contributions - both attributed to the general election cycle - to Jim Cooper's campaign. One of these was properly attributed to JZ Knight, the other was illegally attributed to JZK Inc.

As such, JZ Knight contributed \$2000 to Cooper for the general election cycle, while the limit for a contribution from an individual for this cycle was only \$1000. This is a clear violation of state law.

Another related donation to the Cooper campaign at the time was from Blue Room, Inc, which is another JZ Knight business, but i listed a separate officer, specifically a Dr. Matthew Martinez, who claims to have discovered multiple strands of DNA in JZ Knight's mouth while she is channeling the 35,000 year old homicidal warrior spirit named "Ramtha." Dr. Martinez was disciplined by the Washington State Department of Health and had his chiropractic license revoked for unprofessional conduct (see <http://kbkw.com/5022/>). He is now a partner with JZ Knight in the Blue Room, Inc which claims to use a type of blue light to heal people. Despite this colorful history, the \$1,000 donation from this organization is perfectly legal, even if a little odd.

Cooper must immediately refund the over-limit contribution from JZ Knight, Inc (really JZ Knight or "Ramtha").

2) State law requires that candidates file regular, accurate, timely C3 and C4 reports. RCW 42.17A.235.

a) Jim Cooper illegally claims to have paid the Thurston County Auditor on 6/16/16 for his filing fee of \$1,116.00. Filing week was in May, so this is impossible. Cooper must immediately amend his reports to contain the accurate date. This may have been illegally not reported as debt carried on a credit card.

b) Jim Cooper has failed to report the majority of his legal fees related to the lawsuit filed by the AG against his committee. This lawsuit is ongoing. The last he reported fees was in January. This is a violation of state law. Cooper must immediately disclose this cost, as either debt, an in-kind contribution, or an expenditure.

c) Unfortunately, Cooper failed to file a significant amount of reports before the deadlines specified under state law. See below:

The PDC should investigate the possibility that Jim Cooper committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)** . If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately. It should be noted, these continuing violations are being committed while Cooper is in active litigation with the Attorney General's office, which makes the continued violations all the more noteworthy.
