Please find additional information related to the above captioned PDC Ticket. Ms. Watts is a candidate for the Kennewick City Council.

Ms. Watts received cash contributions well in advance of her only filing on August 31, 2017. Said contributions date back to June 23, 2017. Ms. Watts claims she did not need to file as she was spending only her own money. As the record shows, she in fact received significant contributions. See Exhibit 1, cash contributions.

Second, Ms. Watts has failed to report any expenditures. Ms. Watts has extensive media, signage and other advertisements in the community. Ms. Watts claims to have spent \$4,072.20. Exhibit 2 shows no contributions by her committee.

This information further supports the allegations contained in PDC Ticket 25215.
