JUDGMENT SUMMARY (RCW 4.64.030)

- A. JUDGMENT CREDITOR: STATE OF WASHINGTON
- B. JUDGMENT DEBTORS: BETH DOGLIO and FRIENDS OF BETH DOGLIO a Washington candidate/registered political committee
- C. PRINCIPAL JUDGMENT: \$2,500 with \$2,000 suspended for a period of two (2) years contingent on no findings of violations of RCW 42.17A committed during the period of suspension.
- D. INTEREST: No prejudgment interest is owed. Principal judgment amount(s) due and owing shall not bear interest unless the principal judgment is unpaid by the due date specified herein.
- E. COSTS AND FEES: \$3,250 in attorney fees and costs.
- F. ATTORNEYS FOR JUDGMENT CREDITOR: Angus Lee, Angus Lee Law Office PLLC

1 for conduct occurring during the suspension period, then the suspended portion of the penalty
2 will be set aside.

3 d. In the event Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO fail
4 to pay any portion of the unsuspended civil penalty, fees, or costs, the suspended penalty of
5 \$2,000 will immediately become due and payable within 30 days of such finding without further
6 intervention of the Court.

8 e. Defendant BETH DOGLIO, agrees to watch completely the video "PDC |
9 Campaign finance rules for candidates and political committees" (available at
10 <https://www.youtube.com/watch?v=Wf16NZ76vdY>), and "PDC | How to use ORCA for
11 campaign finance reporting" (available at <https://www.youtube.com/watch?v=nLsOIMT9CDc>),
12 and also to provide plaintiff, through counsel, with a signed certification attesting to the fact that
13 she has watched both videos completely. Said certification must be provided within 60 days
14 from the date of entry of this Judgment.

16 3. Defendant BETH DOGLIO agrees to pay the State the unsuspended portion of the civil
17 penalty (\$500) within 30 days from the date of entry of the Judgment, by check made out to the
18 State of Washington and delivered to Linda Dalton at the Attorney General's Office, with proof
19 of payment and delivery provided to Plaintiff's counsel by the same deadline.

22 4. Defendant BETH DOGLIO agrees to pay by separate transmittal \$3,250 in attorney fees
23 and costs in this action to Plaintiff's counsel, the ANGUS LEE LAW FIRM, within 30 days of

JUDGMENT

THIS MATTER came on regularly before the undersigned judge of the above-entitled Court. Plaintiff, STATE OF WASHINGTON EX REL. GLEN MORGAN (STATE), appearing through its attorney of record, D. ANGUS LEE, and Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO, a candidate/political committee, appearing through their attorney DMITRI IGLITZIN, apprised the Court of their agreement to the entry of judgment for the purpose of settling and compromising this action brought under RCW 42.17A. The Court, having reviewed the records and files herein, and having found the settlement to be a just and proper resolution of this matter, and being otherwise fully advised in the premises, hereby ORDERS as follows:

1. Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO, are hereby assessed a civil penalty, under the provisions of RCW 42.17A, in the amount of \$2,500 payable to the State of Washington for violations of RCW 42.17A for violations of RCW 42.17A during calendar year 2016.

2. The amount of \$2,000 of the assessed penalty is hereby suspended upon Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO's compliance with the following court-ordered conditions:

a. The suspension will be in effect for two years from the date of entry of this Judgment. During the period of suspension, Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO agree that they will not violate any provision of RCW 42.17A.

b. In the event Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO are found by the Public Disclosure Commission or a court to have committed more than a de minimis violation of RCW 42.17A during the suspension period, the suspended penalty of

4. Defendants BETH DOGLIO and FRIENDS OF BETH DOGLIO shall pay Plaintiff's counsel, the ANGUS LEE LAW FIRM, \$3,250 in fees and costs within 30 days from the date of entry of this Judgment.

5. All further hearings and deadlines in this action are hereby stricken.
