

## File a Formal Complaint - Glen Morgan

**To Whom it May Concern --**

It has come to my attention that during her 2016 campaign for the 19th Legislative District, Theresa Purcell committed numerous serious violations of **RCW 42.17A** and **WAC 390**.

Purcell has repeatedly bragged about her knowledge of PDC requirements, however she has flagrantly failed to abide by Washington State's campaign finance law.

Attorney General Bob Ferguson has already filed one lawsuit against Purcell for serious violations of state campaign finance law. This complaint includes new, even more serious allegations against Teresa Purcell, which I failed to allege at the time because I was just beginning to learn about our State's campaign finance laws. I am surprised the AG's office (or the PDC) didn't catch them during their investigations, but since everyone is busy, hopefully this complaint will save some investigative effort.

### **1) Failure to file report of all expenditures/contributions received on the same day C1 was filed (Violation of RCW 42.17A.235(1)).**

Purcell filed the C1 form for her 2016 campaign on 4/29/2016.

On that same day, Purcell was statutorily required to submit all the contributions and expenditures she had received up until that point.

Unfortunately, she failed to report having received the following contributions until 5/10/16, well past the statutory deadline:

**2) Failure to report expenditure/in-kind contribution/debt for legal expenditures (Violation of RCW 42.17A.235).**

Per state law, candidates are required to report all campaign expenditures, in-kind contributions and debt on regularly filed C4 forms.

Unfortunately, Teresa Purcell has failed to report ANY legal expenses associated with her committee's court case.

Even a single billable hour from a Perkins Coie attorney (who she retained to represent her in the AG's case against her committee for campaign finance violations) constitutes a legally reportable expense that Purcell is required to report: either as an expenditure, an in-kind contribution to her campaign, or a debt to be paid at a later date.

**3) Failure to timely file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235, WAC 390-16-205)**

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, Zach Hudgins failed on numerous occasions to do this.

**4) Violation of RCW 42.17A.235, WAC 390-05-295 -- Failure to report debt.**

State law requires that the name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days. Per **WAC 390-05-295**, this includes any oral or written order placed, debt or obligation to purchase goods or services or anything of value, or any offer to purchase advertising space, broadcast time or other advertising related product or service.

**5) Failure to properly describe, break down expenses (Violation of RCW 42.17A.235, WAC 390-16-205).**

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate or committee's efforts shall be deemed expenditures by the candidate or committee. In accordance with WAC 390-16-037, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly.

The PDC also requires that: "Expenditures for media buys must be broken down by date, amount paid, run dates of the ad, and each media outlet (newspaper, radio or TV station, billboard company, etc.)", which Purcell also failed to do.

The Purcell campaign failed to break down/accurately describe the following 26 expenses:

**6) Illegal personal use of campaign funds (Violation of RCW 42.17A.445, WAC 390-16-238).**

State law prohibits the use of campaign funds for personal purposes. Per PDC regulations, any expenditure of a candidate's campaign funds that is not directly related to the candidate's election campaign is a personal use of campaign funds prohibited under RCW 42.17A.445.

The Purcell campaign illegally used campaign funds in the following instances:

Purcell must be forced to personally reimburse her campaign for these illegal expenses.

### **7) Failure to report occupation and employer information for donors over \$100 (Violation of RCW 42.17A.240, WAC 390-16-037).**

Washington's campaign finance law requires a campaign to timely report contributions received. The information required to be disclosed includes the name and address of the source of contributions that exceed \$25 in the aggregate, and the employer and occupation of any individual contributor giving more than \$100 in the aggregate.

Purcell has already been sued by the Attorney General's office for failing to include this required information, yet she continually fails to do so.

In her response to complaint #8913, Purcell says that "...we have either identified the employer and occupation or requested the information from the donor... ..we will work more diligently to gather that information in the future..." however she failed to file amended paperwork that included the required information.

This equates to a separate violation of the same statute. Please see the below chart for more information.

Please note that an asterisk next to a contributor's name indicates that the contribution was reported after Purcell had received the complaint from Mr. Morgan alleging she had systematically failed to report required information for contributors. **There are 7 instances of Purcell not reporting employer or occupation information after having received the complaint.**

**8) Failure to identify the accurate year a contribution was received (Violation of RCW 42.17A.235, .240).**

State law requires that the candidates must record the date that contributions were received by their campaign committee.

Unfortunately, Purcell has illegally identified the following contributions as having been received in 2011. They were -- in fact -- received in 2016.

ROESCH NANCY 9/21/2011 \$400.00 G LONGVIEW WA  
ROGERS STEVE 9/21/2011 \$100.00 G SOUTH BEND WA  
GLENN GUY 9/26/2011 \$300.00 G LONG BEACH WA

Purcell must amend these reports immediately.

**9) Failure to file accurate date of in-kind contribution received -- Late reporting (Violation of RCW 42.17A.235).**

Purcell reported having received a \$900 in-kind contribution for "Professional Photography" from "Mr. C's Photography" on 12/12/2016.

Purcell received this in-kind contribution much earlier than she reported it. The professional photography provided by "Mr. C's Photography" was used throughout most of her campaign.

This is a serious violation, as this in-kind contribution was likely reported 100+ days late.

**10) Failure to report in-kind contribution of mailing list (Violation of RCW 42.17A.235).**

In her campaign, Purcell sent out multiple mailers to registered voters within her district.

She used mailing lists to target specific voters in an effort to win the maximum number of voters per dollar spent. Unfortunately, because Purcell failed to report the expenditure for said mailing lists, or the in-kind contribution of mailing lists from some outside entity, she is in violation of **RCW 42.17A.235**. She should amend her reports immediately to include the source of her mailing lists, either as an in-kind contribution to his campaign or as an expenditure.

**11) Failure to include sponsor ID on political advertisements ( Violation of RCW 42.17A.320).**

The following Teresa Purcell campaign videos fail to include Sponsor ID "Paid for by People for Teresa Purcell (D), as required by state law:

This is illegal.

**12) Failure to list committee officer (Violation of RCW 42.17A.205 (2)(c), WAC 390-05-245).**

**WAC 390-05-245** defines committee officer as: "...any person designated by the committee as an officer on the C-1 or C-1pc registration statement and any person who alone or in conjunction with other persons makes, directs, or authorizes contribution, expenditure, strategic or policy decisions on behalf of the committee."

Unfortunately, the committee failed to list Melissa Vincett (her campaign manager) as an officer on their C1 form, which is required by **RCW 42.17A.205(2)(c)**.

Vincett should have been listed as committee officer, because she likely, in conjunction with others, made, directed, or authorized expenditures, strategic or policy decisions on behalf of the committee.

**13) Illegal unauthorized expenditure of funds by an individual not listed as an officer on C1 form (Violation of RCW 42.17A.425).**

State law requires that: "No expenditures may be made or incurred by any candidate or political committee unless authorized by the candidate or the person or persons named on the candidate's or committee's registration form..."

Because Melissa Vincett was an officer for the committee – despite not being listed on the form – this is a separate violation. In her role as campaign manager, Vincett doubtlessly made illegal expenditures for the Committee.

**14) Failure to disclose offices held (Violation of RCW 42.17A.700, WAC 390-24-010, 150).**

State law requires that elected officials disclose the offices that they hold on corporations. By her own admission, Teresa Purcell is a board member of the Cowlitz-Wahkiakum Legal Aid Program, a corporation registered with the Secretary of State's office.

Unfortunately, Purcell failed to report this on her F1 personal financial affairs statement, which is a violation of state law.

The PDC should investigate the possibility that Purcell committed the above violations maliciously, which would be a class C felony per RCW 42.17A.750 (2)(c). If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
