Subject: Complaint regarding 21st Legislative District Democrats, PDC Case 25009

Dear Charles Eakins:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on September 7, 2017. Your complaint alleged that the 21st Legislative District Democrats may have violated RCW 42.17A.235 for failure to report a \$100 contribution from you in August, 2016.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- The 21st Legislative District Democrats registered with the PDC under the mini reporting option, which may be selected if no more than \$5,000 is raised or spent and no more than \$500 is accepted from any one contributor. Reports are not required under mini reporting.
- It appears that the 21st Legislative District Democrats qualified to use the mini reporting option in 2016.

Based on these initial findings, staff has determined that in this instance, a C-3 report disclosing your \$100 contribution was not required. Therefore, there is no evidence of a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
