Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on August 12, 2017. Your complaint alleged that Walla Walla Fire PAC International Association of Firefighters Local 404 may have violated by RCW 42.17A.235, RCW 42.17A.240, RCW 42.17A.205, and RCW 42.17A.425 for failure to accurately and timely disclose contributions, expenditures, and committee officers.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

.

- The allegations contained in the complaint underlying PDC Case 24628 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On July 18, 2018, the PDC became aware that a lawsuit and settlement containing substantially similar allegations as the complaint underlying PDC Case 24628 was filed in Superior Court in the name of Washington State.
- The Superior Court now has primary jurisdiction over the substance of this complaint; the PDC will defer to their judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
