Dear Lori Shavlik:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on August 18, 2017. Your complaint alleged that Mark Roe may have violated RCW 42.17A.710(1)(g) for failure to disclose board memberships for Dawson's Place and King County Nurses Association on supplement to personal statement of financial affairs.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- Janice Ellis resigned from the board of Dawson's Place prior to taking office. On her F-1 supplement filed December 18, 2011, she properly reported her board membership as required by RCW 42.17A.710(1)(g)
- Janice Ellis does not, and has not, served on the board of the King County Nurses Association.

Based on these initial findings, staff has determined that in this instance, no evidence supports a material violation warranting further investigation.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
