Subject: Complaint regarding Pam Haley, PDC Case 23285

Dear Alex Brooks:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on July 27, 2017. Your complaint alleged that Pam Haley may have violated RCW 42.17A.235 for failure to report an expenditure for mailers.

PDC staff reviewed your allegations, and as a result of staff's initial review, we found the following:

- On July 12, 2017, Pam Haley placed an order for mailers with a cost of \$646.18, which was paid with an expenditure on August 9, 2017.
- On September 1, 2017, Pam Haley early-filed a post-primary C-4 covering August 9, which reported the \$646.18 expenditure for the mailers, however no initial debt was reported as required by RCW 42.17A.240(8).
- On December 14, 2017, Pam Haley amended previous reports to accurately report the order placed as a debt on July 12, which was discharged on August 9, 2017.

Based on these initial findings, staff has determined that in this instance, failure to accurately report debts and obligations in accordance with RCW 42.17A.240(8) does not amount to a material violation warranting further investigation.

PDC staff is reminding Pam Haley about the importance of the timely disclosure of all contribution and expenditure activities, including debts and pledges, and the timely filings of all future PDC reports.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
