Dear Glen Morgan:

The Public Disclosure Commission (PDC) has completed its initial review of the complaint you filed on July 17, 2017. Your complaint alleged that Karen Fraser may have violated Chapter 42.17A RCW for failure to accurately and timely report contributions, expenditures, committee officers, and for making unauthorized contribution.

PDC staff reviewed your allegations, and as a result of staff’s initial review, we found the following:

- The allegations contained in the complaint underlying PDC Case 23122 are substantially similar to a citizen action complaint, filed with the Attorney General's Office pursuant to RCW 42.17A.765.
- On January 16, 2018, the PDC became aware that a lawsuit containing substantially similar allegations as the complaint underlying PDC Case 23122 was filed in Superior Court in the name of Washington State.
- The Superior Court now has primary jurisdiction over the substance of this complaint, and the PDC will defer to its judgment in bringing the issues to resolution.

The PDC has closed the matter, and will not be conducting a more formal investigation into your complaint or pursuing further enforcement action in this case.
